### LETTER ESSAY - THE ROTHSCHILD STYLE

Back in March, 1972, I had occasion to go to Europe. My son was in trouble over there, and as a form of insurance for him I travelled to Basel, Switzerland and deposited \$3,000 in a bank known as Bank Robinson. Some five years later, this Swiss bank became the second in the last 100 years to become insolvent. At that time here in the United States, I was advised to use this bank because it was controlled and operated by a direct descendant to the famous Rothschild dynasty.

#### “Bank of Israel” and “A Gold Tooth” and our Federal Reserve System

The story we were later told about it going under, was that Mr. Rothschild had transferred all the funds of the bank to Israel, later going there himself. When criminal investigators were about to close in on Mr. Rothschild, he jumped, so they claimed, out of a 7th floor window in Tel Aviv. Rothschild was identified by a gold tooth.

The reason I write this is because before I made the deposit in the Bank Robinson, I had insisted on meeting the illustrious member of the Rothschild clan, which I was allowed to do. Mr. Rothschild was about six feet tall and very nice appearing - about 55 years old. He spoke very excellent English. We passed a few pleasantries, but then I got to the point. I asked him how the banks of Europe have utilized the debt money system - how all the money comes into circulation as a debit, with never any money created to pay the interest on the debt created thereby; that this system had been in existence for 200 years or more and it hasn't collapsed.

Now the United States has had such a system (the Federal Reserve) for about sixty years (at the time), accruing enormous yearly additions to the National Debt, yet Europe has had this Babylonian

banking system for over 200 years. Whereas in the United States bank defaults seem inevitable, the European system of usury just goes on.

#### “How the European System Keeps Going”

I then asked Mr. Rothschild a direct question as to how the European system keeps going. Where does the money come from with which to pay the enormous interest on the debt? He looked at me totally silent for several minutes and then said that he thought everybody fully understood how phony money is created, and how the interest on the debt is paid to the bankers. I responded that I certainly didn't know how the system worked. Mr. Rothschild was silent again for a while, and then he gave me an example. “You have been a fairly successful private businessman. But suppose you want to expand, and to do so you require a loan of, say, \$10,000 from your local bank. Things go along fine for several years, and then you have paid back \$5,000, or half the loan. But then unexpected severe reverses occur, and you simply tell the bank that you can no longer keep up the payments on the balance of the outstanding loan principle and interest.

“Now, I will use your own expression: honest free money in circulation - debt free money - versus Babylonian usury - don't you see that now the \$5,000 you cannot, will not, or have not repaid, remains in circulation as debt-interest free, honest money, for the other debtors to use to pay interest and principle on their loans.

“You see, it is this money from defaulted loans that enables the Babylonian system to keep going.

“Of course, you hear the banks making statements that they don’t want this to happen, but in truth, the banks can now foreclose on true asset collateral, for something they gave only bookkeeping credit on.

“Here in Europe, whenever the debts increase beyond a certain point, orders go out to the bankers to refuse further credit, and then foreclose from one-fourth to one-third of all outstanding loans. This way there will be money, principle and interest, for those still in debt to pay.”

What Mr. Rothschild continued to say I will never forget. Keep in mind that this was March 27, 1972.

### **“Foreclosures Needed to Keep Banking System Going”**

“You people in America will soon be given massive new credits for some five or six years, but by the early 1980’s orders will have to be issued to begin foreclosures. This is absolutely essential, because as I told you, without foreclosures the money would not be left in circulation to keep the banking system going;”

I then asked Mr. Rothschild against whom are these foreclosures going to be applied. Are the governments, Federal and State, or large corporations going to suffer foreclosure?

### **“Governments are Never Foreclosed”**

He responded that governments are never foreclosed, no matter what they owe the banks. If it is necessary to eliminate a government that becomes hostile to the Babylonian banking system, this is accomplished through war and revolution. Large corporate bodies will be left alone wherever possible, as the coming World Government will be handled through multinational corporations rather than through individual countries.

Against whom will the massive foreclosures in the United States be directed, I asked Mr. Rothschild? “The same parties as in Europe. We must go against those who are the smallest, the least organized to resist, such as the small businessman, the individual homeowner, and especially, the family farmers. These can be handled with the least trouble.”

As this began to sink in on me, I was so flabbergasted as to be struck dumb. Without much further conversation with Mr. Rothschild I handed my money over, filled out the papers of deposit, and left.

### **The Curse of Usury**

So there we have it - straight from the mouth of a Rothschild banker. In order to keep Israeli, the Communist nations, and international usury banking going, small American concerns must be foreclosed. This year, in 1986, we are told that Congress plans to give away over 20 billion in foreign aid - while here

in the USA some 3,000 farmers a month are cruelly foreclosed against.

So when we pay our taxes, or see and salute the flag of the United States - this is what it all stands for.

Mr. Rothschild made it unequivocally clear to me that the Babylonian system of international finance required that one-fourth to one-third of all outstanding loans to be foreclosed each year. Eventually, all money comes into circulation as debts, with none coming in for the interest on these debts. Yet when a person makes (or receives) a loan, it is almost always necessary that he spend this borrowed money into circulation immediately. While it is in circulation it is actually debt free. But if the borrower can pay off all of his loan, then that principle and interest is taken out of the debt free money in circulation. Naturally all borrowers can’t do this, because at no time would there be enough money in circulation. Thus, money and times get so hard that some borrowers must default.

And, as Mr. Rothschild said, the balance due on defaulted loans, which stays in circulation, keeps the system going.

So for those persons who now rule and control the world - they must foreclose heavily on the small homeowner, businessman, and especially the farmer - to keep the system going.

### **God’s Punishment For Debt**

Sure, the farmers have their faults. All my family were farmers. The farmer is usually highly individualistic. He is not much of a joiner, or survival researcher. The farmer wants to make his own decisions and take his own consequences. And true – he doesn’t usually research history and the economic situation, but feels that he is justified in borrowing what he needs from the banks.

But in times of fairly decent farm prosperity, IT IS THE BANKERS WHO ENCOURAGE THESE LOANS. Also, those people at the top, who run the banking system, know the farmer and the small businessman are the most independent persons in the entire nation. They must be encouraged to get into debt, then foreclosure will be enforced to kill their independence.

Read again the 4th paragraph of the Sixth Protocol of the Learned Elders of Zion: **“The Aristocracy of the Goyim as a political force is dead - BUT AS LANDED PROPRIETORS they can still be as harmful to us from the fact that they are self-sufficient in the resources upon which they live. It is essential therefore for us, at whatever cost, to deprive them of their land. This objective will best be attained by increasing the burdens upon landed property - IN WADING LAND WITH DEBT. These measures will check land holding and keep it in a state of humble and unconditional submission.”**

## THE METRIC SYSTEM, MEASURE STANDARD OF INFAMY

Many things such as our earth, sun, or minerals we use daily, we accept as matter-of-fact though, we know little about their history or position. Even our forefathers are a mystery to most people although we share some of their heritage through our system of measurement. Before we discuss some new form of measurement, such as the metric system, we should have a good basic knowledge of our present system if we plan to make a comparison, especially when our government, to appease the United Nations, has already agreed to adopt a decimal system based on the inaccurate standard of the meter.

Most of us are familiar with the inch, foot, yard, and mile. Some people are acquainted with the rod and acre. Fewer still know of the different cubic measures. There are a multitude of measures I have not mentioned; some common to the mariner, others to the housewife, and still others to the banker, which are common to us all. These were initially based on our first cubit measures providing a useful decimal system long before the meter was established and since used to make monetary divisions and change. You will see the correlation later as we continue.

As useful as it is, a decimal system is not always best. For the carpenter, for instance, multiples of ten are inferior. Our foot of 12 inches is equally divisible by 1, 2, 3, 4, and 6, where 10 is only equally divided by 1, 2, and 5. Architecture can be more balanced, design can be more functional, and much less waste is encountered during construction using a base of 12. For example, a sheet of panelling 4ft x 8ft, can be utilized by the carpenter with greater flexibility using the scale of 12 rather than the scale of 10. One might say, however, that with the metric system the panels would be metric also as would all other lumber and materials and no disharmony would occur. But if

your present home has panelled rooms and one panel has to be replaced, no metric panel would fit and a major expense and waste would ensue.

At the same time, our present linear scale for distance is in harmony with the time scale to which the meter is alien. A motorist can travel an even 60 miles in one hour and can compute his time to a mile in one minute. Our system of 12 is equally harmonious to 360 degrees in a circle, 12 months in a year, 12 signs of the Mazzaroth (Zodiac), and 12 hours light and 12 hours dark. Even the four seasons are a fraction of 12.

Yet the inch is divided by one millionth with the micrometer for great accuracy. The Cubit is 25 inches and that times four gives us 100 to establish the use of decimals where better utilized, whether it divides our monetary system or serves scientists or mathematicians.

Isaiah 19: 19-20 records location of the witness, or standard, for our multitude of measurements as mentioned in Job 38: 4-7. The former refers to the Great Pyramid in Egypt. From this standard recorded around 4,700 years ago, we find the mean distance to the sun of 91,840,000 miles to be exactly ten to the ninth power times the height of the pyramid. Science did not recognize this distance until just over a century ago, but now it is considered to be extremely accurate.

This accuracy is not surprising considering the divine origin of the measurement. Quoting

*A Miracle in Stone* by Joseph A. Seiss, D.D. (1877), this pyramid "...was designed and erected under special guidance and direction of God, and bears a very accurate relation to the physical universe which the Bible bears to the spiritual."

Even our planetariums could not align their foundations to true north in this modern day without the accuracy of that first and last remaining of the Seven Wonders of the World. We do have an error today of 0.001 on our scale of measurement owing to usage without the availability of checking against this standard over the millennia, although the measurement scale has been used to this date by God's chosen people, Israel, and has made possible our industrial revolution and national greatness through an accurate standard of measure.

Would the ark have been sound if the many timbers and planks used in its construction were measured by the Babylonian or heathen cubit approximating 18 inches? This cubit was determined roughly by the distance from the elbow to the fingertip. Noah's sons probably varied a little in stature, therefore such a measure would have resulted in a very leaky and unseaworthy ark. Then too, why would God resort to a heathen measure when His sacred cubit was such a viable standard? No. The same 25 inch cubit used to construct the ark during the time of Noah was the

same 25 inch cubit used roughly 1000 years later by Moses to build the Ark of The Covenant and used again another 400 years later to build Solomon's Temple.

As mentioned in Job 38: 4-7, the pyramid was a witness to the earth in its entirety, including its place in the solar system, its shape, mass, average temperature, volumes, distances, and all other measures as all complete measures were indicated by these verses. Even the pyramid standard of our mathematical Pi (3.1415926) is found to be accurate to 15 decimal places.

The shortest distance from the center of the earth to either pole, divided by 10 to the 7th power, gives us one inch linear measure. The grand standard for this is the earth's axis of rotation, 1/25th of the sacred cubit used by Noah, Moses, and Solomon and found in the Great Pyramid. The table would then run as follows; 25 inches = 1 cubit; 100 cubits = 1 acre side; 25 acre sides = 1 mile; and 4 miles = 1 league.

The grand standard for weight and capacity measure is the mean density, as noted by the pyramid, of the earth at 5.7 times the weight of water at 680 Fahrenheit (the constant temperature found in the King's Chamber of the pyramid, as well as the mean temperature of the whole earth.). Thus 68 degrees being 1/5th the distance mercury rises between the freezing and boiling point of water, we take  $5 \times 5.7 = 28.5$  cubic inches of this water, or an accurate standard which also equals 1 pound as well. This pint or pound divides by tens, grains, and drops, and multiplies by 10, 2.5 and 4, to make tons and chaldrons. Thus, 1 drop = 1 grain; 1 pint = 1 pound; 1 cwt = 1 bushel, etc. Even our heating and cooling systems are rated by BTU (British thermal unit) which is the capacity to alter one pint of water by 1 degree of temperature Fahrenheit.

Thus far I have not scratched the surface of measurements and standards, including measurements in time, past and future. Yet the importance of the accurate standards we presently enjoy, though we took much for granted, is now established for our purpose.

This new era of confusion we are presently living in (modern Babylon, if you will) is now foisted upon us with the metric system and its hordes of strange measures, spawned by what John Taylor, publisher of the *London Magazine* referred to in 1857 as the "unholy alliance of infidels and communists." Here we see the true political nature of the metric system was recognized over one hundred years ago as anti-Christian and at that time was openly publicised as such.

What was the origin of the metric system? Again refer to *Miracle in Stone* by Seiss. "Nearly one hundred years ago (or almost 200 years ago now) the French people, in their first revolution, made an attempt to abolish alike the Christian religion and the hereditary weights and measures of all nations seeking to supplant the former by a worship of philosophy and

liberty, and the latter by a new scheme of metres. For their unit of standard of length they took the quadrant of the earth's surface at the particular meridian of Paris, divided (it) into 10 million parts, and so obtained the metre of 39.3791 inches now so highly eulogized. To say nothing of the origin and motive of such a standard the science that is claimed for it is of no high character. It has the misfortune of taking a curved line drawn on the earth's surface and that at a particular meridian no more fitting than any other instead of some straight line invariable for all the earth. Besides, in estimating the earth's elliptic meridian at Paris, these atheistic savants, as now proven, miscalculated per metre 0.0053 too little and so, on their own basis, their lauded unit of length is not true."

Other scholars added their condemnation of the system. Sir John Herschel rightfully pronounced it "the newest and worst measure in the world," and Beckell Denison justly regarded it as "an inconvenient, inaccurate, and unstrideable measure."

Besides its inaccuracies, the metric system if completely adopted in the United States will cost the citizen dearly for centuries to come. Maps, surveys, land records prescriptions, recipes, and industrial formulas are only a few of the functions of modern life utilizing measurements, and these and countless others would have to be changed. It would mean expenditure, losses, and inconveniences beyond estimate for generations. The naive American public is being sold a new "rubber" standard (the meter) under the guise of a decimal system and feel such is necessary because a majority of countries have adopted the metric system. We should recognize the fact that when we embrace this ungainly standard of measure we no longer are a world leader, but we have become world follower. More than that, because of its definite atheistical origin with manmade measures being deliberately created to supplant those given His people by God Himself, the metric system is truly a measure standard of infamy!

## THINKING THE UNTHINKABLE – SPEAKING THE UNSPEAKABLE

The “farm problem” is made much of in the nightly TV news and in the newspapers. Thousands of farmers face foreclosure. Tens of thousands more are behind in their loan payments. Farmers in some areas are discussing the ambush of SWAT teams. Cavalry officers (tanks) in Indiana have been issued orders to round up “potential troublemakers” when told to do so.

Yet there is no farm problem as such. There never has been. What we have had ever since the Republic was founded in 1789 is a people problem. And this people problem is about to bring us this bloodshed, misery and despair that we - as a nation - so richly deserve.

There are two facets to this people problem - greed and selfishness; these two human character traits are what precipitated the present host of problems. We could, of course, blame the bankers, the usurers, the moneychangers - which is sort of like blaming maggots and vultures for infesting and eating dead carcasses.

The moneylenders are not the cause of the problem. They are merely the effect. The entire “farm problem” arose out of ignorance and disobedience to God’s laws.

Nor is this ignorance and disobedience blameable solely upon the farmers. Farmers are simply the first ones to feel the brunt of our national misbehaviour. Unless the rest of us straighten up we too will go to the proverbial chopping block directly.

So what are we doing wrong? In a word: everything. Remember the part in the Bible that goes, “...love your neighbor as yourself, for on that hangs all the law and the prophets?”

When was the last time you, personally, went out of your way to help someone else? I mean really help - not just threw the poor slob a fish so that the day after you fed him he was just as bad off as he was the day before? When is the last time that you or a group of you - actually accepted responsibility for another human being and did everything that you could to put that other human being back on his feet?

For myself, I’m ashamed to admit, it was 1972. A fellow named Kenneth Perkins was featured on the back page of the Louisville Courier-Journal. This man had lost his job in Indiana. While he was at a funeral, thieves broke in and stole every stick of furniture and every valuable that the Perkins family owned.

The Perkins family then moved to a relative’s place in Kentucky and rented a tar paper shack to live in for \$15.00 a month. Kenneth got a job as a gravedigger for \$600 a year.

When the Courier-Journal ran the story of his plight, three separate groups of churchgoers hauled a

grand total of six truckloads of broken toys to Kenneth Perkins and his family to “help out.”

I was flabbergasted that such well-meaning types could be so stupid. The Perkins family couldn’t eat toys. I drove down to his place armed with a yellow legal pad and a pen. I asked him what he needed to get on his feet. He needed tools. If he had tools, he could get a job as a mechanic. He needed garden implements. If he had garden tools he could grow food for his family. He needed food. And, of course, everybody can always use money.

I drove back home and threw my personal toolbox in the trunk of my car, bought a collection of garden tools at the local hardware store, and picked up a few boxes of canned goods at a local grocery store. I then collected a herd of bikers for a “charity run.”

The deal was, I would notify all the police departments in towns we would be rumbling through what the program was so that they could have a hassle free putt and they in turn would take up a collection for the Perkins family.

The herd of us descended on the Perkins family and dumped my tools, the garden implements, the canned food (they had no refrigerator), and took up a collection in cash. A week later Kenneth Perkins had a job at a local garage as a mechanic. Six months later the Perkins’ moved to a house in Lexington, Kentucky complete with refrigerator and indoor plumbing.

For years afterwards the Perkins family would write me once a year and let me know how well they were doing. Far as I know, they’re still OK. Larger groups of us should be able to do the same for farmers. The question is, do the farmers themselves understand the responsibility is also theirs? Do they understand that looking out for other human beings ultimately benefits themselves?

For example, how many farmers are in the anti-abortion movement? What, you may ask, is the connection? The United States abortion rate has been roughly 40 million a year since 1973. That equals the loss of over **40 million human beings** by the turn of the 21st century, which, by that time, should equal almost 20% of all the consumers of farm products in the United States. Farmers in the anti-abortion movement are simply attempting to protect their own markets, though they may not recognize it as such. .

For a classic example of “looking out for the next guy;” let’s consider what happened at the Battle of Culloden in 1746. In 1745 the Scots defeated the British at Prestonpans. In those days the final outcome of a battle was almost always decided by hand-to-hand combat. British soldiers - once they had come to grips with the Scots - armed with musket and bayonet were simply no match for Highland Clansmen armed with swords and shields. Moving a bayonet out of the way with a shield and then lopping an opponent’s head off with a sword was a fairly reliable, simple, uncomplicated, and almost foolproof procedure.



What defeated the Scots at Culloden was a maneuver that could easily be adapted to economics. A British General reasoned that while his soldiers were no match for the Scots on a man-to-man basis, there was a move they could make to even the odds.

Each British soldier was ordered to ignore his own safety and concentrate on protecting the man to his right. Since the Scots attacked with their shields on their left arm and their sword upraised, their right sides were exposed. Consequently, a bayonet pointed at a 45 degree angle to the right would be aimed at the exposed portion of a Highlander's torso. This particular movement worked so well that only 50 British soldiers died at Culloden, whereas 800 Highlanders went down.

If you believe that we face a common enemy - whether it be the bankers or the government - let's do the same thing. Let's cover the man to our right. Also, let's use another military tactic: let's pour all our troops (or resources) into one battle or affair - win that one - and then do it again. This is how wars are won.

Unfortunately, all these resources are currently being poured into the coffers of today's TV evangelists - to the tune of over \$100 million a year - so that these self-appointed prophets can build monuments (such as office buildings) to themselves.

Let me use as an example of the "way it should be done"; a story on page 3 of the Salt Lake Tribune for March 5, 1986. The story was about a farm family, Ken and Sue Massey and their children, who had lost a farm, which had been in their family for 80 years. Mrs. Massey had written a poignant letter that was read at the FarnAid concert which concert, though it raised over 7 million dollars, did absolutely nothing for families like the Masseys. The promoters of the concert said the money had to go to food pantries, crisis hotlines, college scholarships, and, of course, to lawyers so that the lawyers could "help" the farmers.

Pardon me while I upchuck. Willie Nelson has his heart in the right place, but his head is certainly somewhere else. The Massey's 310 acre farm was auctioned off for \$45,000. Why couldn't a thousand of us have donated \$50 and paid this farm off for these people? We could have. Anyone reading this could - and can - come up with fifty bucks.

The fact is that we didn't. Another "one of us" went down. Granted, a thousand practising Christians (notice I used the word "practising" as opposed to "professing") aren't going to change the world or reverse the present farm situation. But 2,000 of us could save two family farms. And a nation full of us - instead of putting our money in (usurious) savings and loans that are going to go under anyway, certificates of deposit, gold, silver, the stock market, and a host of other selfish, un-Christian uses money is more often than not put to - a nation full of us that followed God's Law on money and charity could do more than save a couple of family farms.

**We could save them all.**

They failed with the United Nations. Now they are running up the flag with the Trilateral Commission. Here is a list of their activities and involvements:

1. Founded after World War 1, the Council on Foreign Relations (CFR) has been for fifty years the undisputed creator of American foreign policy. Growing too large and too diverse to act as a "cutting edge" in policy creation, the political action today has moved from the CFR to the Trilateral Commission.

2. All key members of the CFR-Trilaterals are Scottish Rite Freemasons.

3. Media {Press, TV, Radio, magazines and books} are entirely under the control of CFR-Trilaterals through David Rockefeller's interfaced network of companies.

## **I AM VERY ANGRY**

So you thought the "Australia Card" was, designed just to catch welfare and dole cheats (after all, isn't that what the Government has been telling us?); you thought it might not even be a bad idea, and you've wondered just what all the fuss is about. Well, let's have a closer look at it!

- If you are employed in a job and you don't have a card, you may have to be dismissed or forced to resign as it is an offence for your employer to pay you (cl.49.2). Penalty - \$20,000.
- You cannot get a new job as it is an offence for an employer to hire a cardless person (cl.49.1). Penalty - \$20,000.
- A person without a card will be denied access to pre-existing bank accounts (cl.40.2), and cannot cash in investments (cl.41.2c), and cannot give or receive money to or from a solicitor (cl.41.7d), or cannot receive money invested in: unit, property, or cash management trusts (cl.42.2c). Penalty - \$20,000.
- Benefits will not be paid to the unemployed widows supporting parents, aged, invalid, sick without a card (cl.54.7). Penalty - Nil. (This area is administered by public servants).
- Farmers without a card will not be able to receive payments from marketing boards for their produce (cl.43.2). Penalty - \$20,000. (Nice little round figure, isn't it?).
- A cardless person cannot sell (cl.45.2), or rent (cl. 43.4) their own home or land. Penalty \$5,000.
- A Hospital may refuse entry to a cardless person (cl.53.1). A cardless person cannot claim Medicare benefits and is not eligible for bulk billing (cl.53.3).

That's not all! - The "Authority" is not bound by any time scale to renew a lost or damaged ID card, which you must apply for in writing, (remember the last time you had to deal with bureaucracy and applied for permission in writing to do something?)

And the clincher! - The "Authority" may cancel your card if "the person is no longer eligible for the issue of a card" (cl.19c).

But of course you would have been told all this by your Federal Labor member in your electorate (who, I understand, all voted yes for this proposed legislation) because he has been representing your rights in parliament for you hasn't he - well, hasn't he? Or you would have heard it at mass meetings called by your union for this proposed attack on workers basic rights as the unions and the Labor Government are for the working man aren't they - well, aren't they?

The proposed "Australia" (doesn't sound very Australian does it?) card has been delayed in parliament by the Liberal National party and the Democrats. The Democrats currently have the balance of power and as their policy is to "amend" legislation rather than obstruct it, and as they are not famous for their type of amendment, it will probably go through in one form or another, if the Labor party is re-elected.

## THE CHRISTIAN AND THE INCOME TAX - Part 3

Our Christian brethren of the Roman Empire had no such problem. They clearly understood that the simple act of being licensed by Caesar was a violation of Christ's Sovereignty. Christians in Rome did not die because they worshipped Christ. Caesar could care less which god they worshipped. They had hundreds of gods in the nation. Jesus was just another one of those gods to Caesar.

Christians died in Rome because they refused to violate the Sovereignty of God by lowering Him to an equal of other gods. How was this done in Rome? You had to apply for a state license; permission to worship your god, thereby admitting that Caesar was sovereign over Rome and their gods.

The Christian of that day refused to do this act which some Christians and pastors today would say was trivial. One of America's leading Fundamentalist pastors said, "I will not go to jail for any ministry in my church until they tell me I cannot preach Jesus from my pulpit." The enemies of Christ will never tell you not to preach Jesus. Hitler never did that. Russia does not do that today.

You can go to Moscow and preach Jesus from the pulpit of First Baptist Church. In fact, the Russian government has licensed that First Baptist Church just for that purpose. The government of Russia has even hired and trained a KGB agent to pastor this very church and preach Jesus every Sunday morning from that very pulpit.

The sad truth is that most pastors in America today are state approved; state trained pastors preaching in state licensed, state sanctioned, state supported churches. (For more information on this, get the author's work on church incorporation and 501 C-3 Tax Exemptions).

No pastor in America today can escape government unless he toes the public policy line. If you are not being bothered by government officials, it is because you are no threat to the sins of government's public policies.

The government today demands total allegiance, worship, obedience, and cooperation. There is no question that government enforced public policy today is humanistic, atheistic, socialistic, and yes, even communistic. If these policies violate your faith and obedience to Christ, the state expects you to forego your worship and obedience and honor of Christ's Sovereignty to obey the state. If you refuse to obey the state, you will be called radical, mentally ill and psychotic.

Mr and Mrs Cordie, of Fergus Falls, Minnesota, are good examples of this. They were teaching their children at home for religious reasons. Even though it was lawful and legal to do so in the State of Minnesota, Mr and Mrs Cordie were committed to a mental institution and their daughter removed from their

home and re-enrolled in a public state school. The psychologist's verdict after examination of the parents was "...excessive religiosity ...psychotic illness of paranoid type ...paranoid ideation ...speaks in 'tongues' ...chants ...has stockpiled huge quantities of food ...direct contact with God ...persecutory delusions..."

Of course, our own case here in Louisville - which resulted in the Faith Baptist Church being padlocked twice, seven men jailed for 93 days, and myself being jailed for 157 days -- was not over the education of the children, but the fact that an unlicensed church school violated public policy enforced by the National Education Association (NEA) and Nebraska Department of Education.

Calvary Temple Church in Atlanta was raided, church members harassed, and the church was harassed and assessed a tax by the IRS, not for any non-payment of taxes it owed or commission of a crime, but because the Pastor, Dr Robert McCurry, its members, and its paper, the *Temple Times*, is a strong voice against public policy on abortion, sodomy, IRS abuses, etc. Most pastors avoid this kind of trouble by being quiet on these issues or limiting their voice on the subject to the pulpit.

Dr. Greg Dixon, Dr. Gene Hood and their church members were arrested, strip searched. their women cavity searched, finger" printed and jailed for preaching in front of an abortion clinic. Did they break the law? No! Break a city ordinance? No! They violated public policy of abortion on demand. But what if they had violated a state or city ordinance? Unlawful state and city ordinances are not law. (More on this in chapter 3).

In summary, what I am saying is that there are thousands of people being harassed, made political prisoners, and having their property confiscated just as it was in the days of Rome and the Spanish Inquisition. It's being done in the name of law and order, but it is really being done under the power of unlawful government.

The reason it is being done is because the church community and leadership of that community refuse to stand up and voice a unified, loud opposition to this tyranny. I must sound a warning that God has already proclaimed His judgment against such leaders and against such religious institutions who fail to cry out for justice. The matter of the Christian and the income tax is only one of the very small aspects of this whole problem. In order to understand it we must look at the whole picture.

The bottom line of this picture is this: Who is Lord; who is Sovereign; who is God? God, Christ, the State, or the IRS. Does God expect a Christian to obey the State outside the limits of God's Law? Does a Christian sin when he allows the state to control a part of his life and property rightfully belonging to God?
