### THE CONSTITUTION TODAY AND TOMORROW

Every patriotic Christian respects and acknowledges the Constitution as the greatest man-made document for the structuring of civil government ever written. Few American Christians who have studied our history can neglect the fact that the Constitution has played an enormous role in the shaping of the Nation. (*While these words were written for America, they apply equally to Australia! Study this and take note! Ed.*)

However, these same historically astute Christians also plainly see that without the Bible, the constitution would never have been written. The Bible and its Law was the basic world-view or life standard upon which the vast majority of the Founding Fathers lived their lives. What was known as "Common (to all *Israel*, Ed.) Law" to the Founding Fathers consisted basically of the divine commandments, statutes and judgments found in the Bible. These became well entrenched in the cultural "traditions" of western law, as ably elaborated by Blackstone. Truly, the Bible had been the underlying bedrock of government for early Christian America.

We should, then, ask ourselves some pertinent, timely and important questions. Is our Constitution a perfect document? Indeed, was the Constitution the work by which Christian-Israel was to live and abide? Can a return to the Constitution save the Nation today?

First, is the Constitution a perfect document for the governance of Christian-Israel? David said in Psalm 19:7, "The Law of the Lord is perfect..." Is the Constitution the same as the Law of the Lord? Of course not! We must always remember to first look to the Law of Yahweh in the Bible as our covenant contract and standard for national conduct. Human documents, no matter how noble, must always occupy a rank in importance below scripture.

Second, was the Constitution the work by which Christian-Israel was to live and abide? Deuteronomy 10:12-13 says, "*And now, Israel, what doth the Lord thy God require of thee, but to fear the Lord (Yahweh) thy God, to walk in all His ways, and to love Him, and to serve the Lord thy God with all thy heart and with all thy soul. To keep the commandments of the Lord, and His statutes, which I command thee this day for thy good?" Deut. 11:32, "*And ye shall observe to do all the statutes and judgments, which I set**

*before you this day.*" Deut 12:1 commands us, "*These are the statutes and judgments, which ye shall observe to do in the land, which the Lord God of thy Fathers giveth thee to possess it, (whose 'land-rights'?Eds) all the days that ye live upon the earth.*"

Obviously, the Constitution does not contain all the commandments, statutes and judgments of the Bible. Therefore, the Constitution cannot be the guide for our country. The guide for Israel must be the Law-Word of God as Yahweh has so often commanded us in the Scriptures. (Old and New Testament)

Can a return to the Constitution save the Nation today? The Bible states in Deut. 11:26-28, "*Behold, I set before you this day a blessing and a curse, a blessing if ye obey the commandments of the Lord your God, which I command you this day: and a curse, if ye will not obey the commandments of the Lord your God.*" In Deut. 28:15 we read: "*But it shall come to pass, if thou wilt not hearken unto the voice of the Lord thy God, to observe to do all His commandments and His statutes which I command thee this day; that all these curses shall come upon thee, and overtake thee:*" The rest of Deut. 28, is devoted to describing those curses which are certainly very familiar to us today! Read all of chapter 28.

God tells us if we obey His specific commandments, statutes and judgments of His Law, He will bless us. His commandments and His Laws are superior to the constitution.

Thus, there are two major reasons why a return to the Constitution will never save our Nation. Number one, we as a nation, have completely forgotten and have, collectively, no knowledge of the historical context in which the document was framed. That is, we, as a nation and culture, no longer understand the thoughts, principles and aspirations of the Founding Fathers. It is widely acknowledged that, although wonderful, the Constitution was

a compromise with God's Law-Word. The Divine Laws of the Bible were never proscribed for our national laws and the name of Jesus the Christ was never even mentioned.

Number two, even if by some miracle of education the nation suddenly became literate in the literature of the Founding Fathers and decided to mechanically abide by the "letter" of the Constitution, would this, in effect, "save" America? No, it would not, for this simple reason: Israel-America(-Australia,Ed.) has sinned and must first repent before a divine healing can take place. Even a cursory review of the curses enumerated in Deut. 28 immediately tells us that these specific curses are now upon us for our national sins. Can anything short of war on our own soil bring us to a national repentance now? Review Israel history.

2 Chronicles 7:14 shows the only way in which our Israel-nation can be saved from herself and from her enemies. "*If My people (Israel,Ed.), which are called by My name (Christian,Ed.), shall humble themselves (not humble the enemies,Ed.), and pray and seek My face, and turn from their wicked ways; then will I hear from heaven, and will heal their land.*"

It must be realized today that we Israel people in America, as well as all over the White-Christian world, are living in sin (1 Jn. 3:4), disobedience to God's specific commandments, statutes and judgments.

Tyrants are placed over Israel when she disobeys! We are living in disobedience to the only Constitution that counts for the Covenant-Israel nations. That Divine Constitution has been and always will be the Law Word of God.

Therefore, let us humble ourselves and repent (*that means, stop being disobedient, and become obedient to God's commandments, Ed.*), turn from our sins, seek God and His ways outlined in the Law of the Covenant and cry out to our heavenly Father for deliverance from what is and what shall be upon us. Let us again by the grace of God, establish Bible Law, that Divine Covenant which Yahweh made with our forefathers, Abraham, Isaac and Jacob, as our individual and national Constitution.

### IS DEATH REALLY DEATH?

*"Behold, all souls are mine; as the  
 soul of the father, so also the soul of the  
 son is mine: the soul that sinneth, it shall  
 die."* (Ezekiel 18:4)

Is death REALLY death? Popular opinion  
 says, "No, not really." Incredibly, most people  
 think that death is only another form of  
 life! "Of course, the BODY dies," they say (as  
 if their physical human body is only a strange  
 impersonal growth they would be better off  
 without). "But," they continue, "man's SOUL  
 lives on after the body has died." In other  
 words, they claim that FOR THIS SUPPOSED  
 ENTITY THEY CALL THE "SOUL" (the real  
 "you"), THERE IS NO SUCH THING AS DEATH.

Variations on this doctrine of the so-  
 called "immortal soul" include:  
 PRE-EXISTENCE-which states that "You" (the  
 soul) consciously existed in some "spirit" form  
 before your body was born with "You" inside  
 it.

REINCARNATION-which states that "You" (the  
 soul) were transferred into another person  
 (or animal) after your former body died.

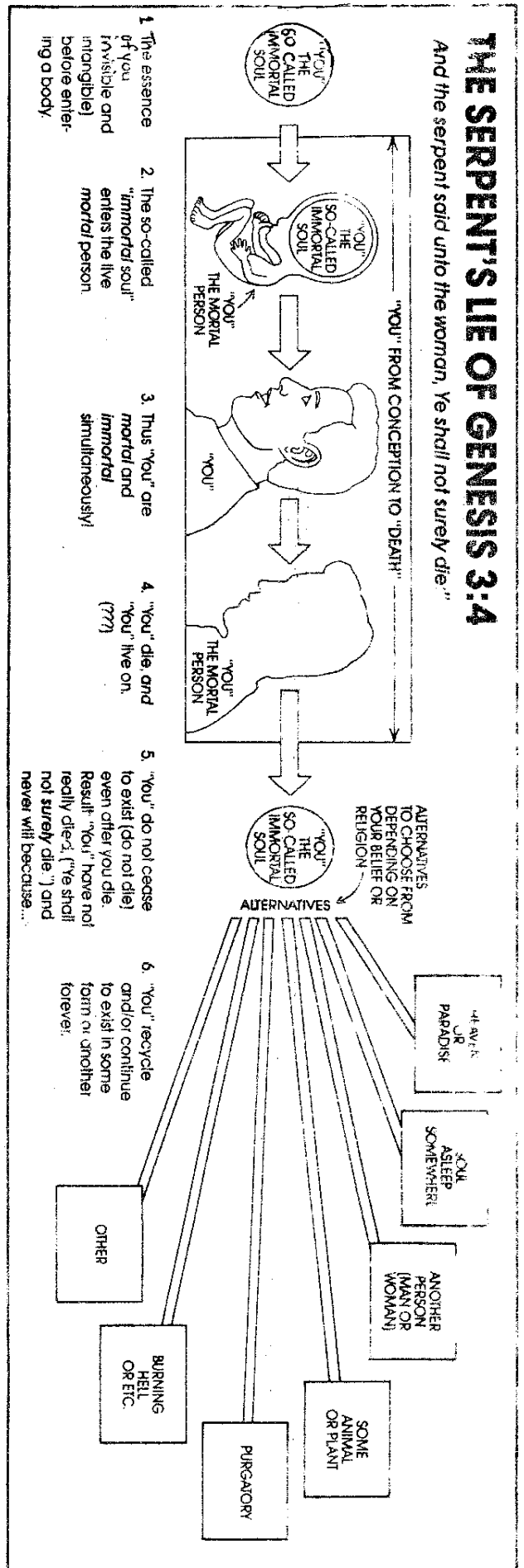
HEAVEN OR HELL doctrine- which states that  
 after you die, "You" will still be alive and  
 conscious without your body, and you will go  
 up to heaven or down to hell, depending  
 on how good you were in this life.

OTHER THEORIES are similar even though  
 they vary on the minute details. For example,  
 one theory holds that after your body dies,  
 the essence of "You" still exists somewhere  
 in storage and is simply "asleep or unconscious"  
 until the resurrection.

The theories may differ in the details,  
 but they all agree on the very important  
 point that the essence of "You", DOES NOT  
 SURELY DIE. (If someone does not die, then  
 he or she is immortal). In the Bible, "immor-  
 tality" actually means "deathlessness." So  
 all these theories-and any theory which says  
 that "You" shall not SURELY die-are simply a  
 restatement of the Serpent's lie in Genesis  
 3:4;

*"And the serpent said unto the woman,  
 Ye shall not surely die."*

The Big Lie, if told often enough, will  
 eventually be accepted as truth. Unfortunately  
 it has been told often, and as a result, "death"



no longer means "death" to most people - including Christians. It is an unseen paradox of popular thought: a glaring impossibility which people are taught to ignore.

### THE DEFINITION OF "DEATH"

Technically, "death" means "the opposite of life." Amazingly, religious tradition has re-defined "death" as merely "ANOTHER DIMENSION OF LIFE OR EXISTENCE."

### THE DEFINITION OF "LIFE"

"Life" is ANIMATE EXISTENCE. If you exist and move, you are alive. And if you do not move, then you are dead. What could be simpler? At some point "You" must lose all traces of mobility, metabolism, feeling, thought processes, etc., if the word "death" is actually to mean DEATH!

### "WILL THE REAL "YOU" PLEASE STAND UP?"

There is a great inconsistency with the way English-speaking people define the word "You" (expressed in the Bible as "ye" and "thou"). "You" can be one thing to one person, and something quite different to another.

People may talk about how "You" die. But as they continue to explain, it becomes that many believe that "You" really DO NOT die; only "your body" dies. "You" LIVE on. This results in an illogical dual-mindedness where two entities called "You" seem to emerge - "You" (the person), and "You" (the separate, invisible, intangible, conscious thing). Thus, in death, "You" (the person) perishes, while "You" (the intangible) goes off to heaven or continues to exist in some other way. So then, many a Christian has been trapped in a mental paradox, thinking that he is a person and yet (often without realizing it) that he is not just one person, but instead two separate beings at once - a pretty good trick! The word "death" takes on an aberrant meaning. Insanity ensues, and through a mere twist of semantics and logic, people think of themselves as being mortal and immortal at the same time.

To restate this position, this definition says that "You" DO NOT REALLY DIE, because after you die, "You", as this invisible thing, are still in existence.

### DOUBLETHINK INSANITY

With the idea that there are two "You's", people are tricked into accepting two mutually exclusive concepts! They are MORTAL, but yet IMMORTAL. They claim that the body is MORTAL, and yet, they also claim that the separate, invisible, intangible thing inside the so-called "soul"- is IMMORTAL. Thus "You" are MORTAL AND IMMORTAL at the same time! This is like saying something is solid and liquid at the same time, or red hot and ice cold at the same time. It could also be described as eating your cake and having it, too.

One preacher actually coined a new term in a desperate attempt to bridge this gaping chasm of faulty reasoning. He came up with, "*conditional continuity of being!*" This contribution no doubt helps the confused world of Judeo-Christianity maintain its insanity. Don't let rhetoric and fancy phraseology divert you from the sensibility of Scriptural Truth. Mortality and immortality cannot be blended. Neither can you be SLIGHTLY mortal or SLIGHTLY immortal any more than someone can be SLIGHTLY pregnant.

### DISEMBODIED SPIRITS?

The belief that "You" can be a disembodied conscious spirit is a lingering idea that originated in demonology. This misdirected pagan concept states that "demons" are countless, separate, supernatural, invisible entities of forces that have independent consciousness and thought but have no natural, tangible form. Supposedly, these entities or forces can magically fly anywhere and even pass into people, animals, or objects and "possess," or take control of them. This idea that there are millions of independent, supernatural demon entities in the world is a pagan concept.

*"I am the Lord, and THERE IS NONE ELSE, there is no God beside me: I girded thee, though thou hast not known me:" (Isa 45:5)*

*"Let them (the heathen) bring them (the demon idols) forth, and shew us what shall happen: . . . Shew the things that are to come hereafter, that we may know that ye are gods: yea, do good, do evil, that we may be dismayed, and behold it together. Behold, ye (the demons) are nothing, and your work of nought: an abomination is he that chooseth you." (Isaiah 41:22-24)*

*"They provoked him (God) to jealousy with strange gods, with abominations provoked they Him to anger. They sacrificed unto devils, not to God; to gods whom they knew not, to new gods that came newly up, whom your fathers feared not." (Deut. 32:16-17)*

So it is with the pagan notion of "disembodied spirits." It originated from the same source as the serpent's lie. This notion shapes the pagan definition of "You," thus incorporating a separate, invisible, conscious thing in you that cannot die. This thing is supposed to be able to think and act independently of any physical (natural) brain or body. This supernatural, intangible "You," in effect, possesses the tangible "You."

Seldom does anyone grasp the implications of this type of thinking. Yet the fruit of this delusion is apparent-it causes people to think their bodies are nothing but added baggage. The depressed teenager, driven by the hypnotic lure and destructive music of Witchcraft (which promotes, among other things, the idea that they have an "immortal soul"), commits suicide without hesitation. The sodomite may believe that he, or she, was accidentally



placed into a body of the wrong sex. And many people simply wander about aimlessly, without direction or purpose, just waiting to get off this earth and out of that old body, and fly away to heaven.

### THE DEFINITION OF "YOU"

But the human brain is NOT merely a spongy mass of "gray matter" that a separate intelligent entity possesses and controls. The physical brain, along with the rest of the body, comprise an awesomely designed, computer-like mechanism that God created for the express purpose of making consciousness, intelligence, and individual personality possible for man. "You" are you because of all those individual characteristics of your God-created body. When your brain is alive and functioning, "You" can generate thoughts. If God's power (the energy source) is separated from the brain and the rest of the body, then the brain ceases to function, resulting in loss of all thought, consciousness, and life. All that was known as "You" ceases. Then the word "death" truly means DEATH.

### IMMORTALITY AND ETERNAL LIFE

The Bible is clear and concise concerning the question of whether or not we are immortal. Concerning our Lord Jesus Christ, the Apostle Paul states:

*"WHO ONLY HATH IMMORTALITY, dwelling in the light which no man can approach unto;" (1 Tim 6:16a)*

In other words, Jesus Christ is the ONLY one who has yet received and can possess immortality. "Immortal" means "deathless." However, there are those who point out the following verses which use the term "eternal life:"

*"And this is the record, that God hath given to us eternal life, and this life is in his Son. He that hath the Son hath life; and he that hath not the Son of God hath not life." (1 John 5:11, 12)*

This scripture, and others, are used by some to teach that Christians become "immortal" at the time they are "saved." But is this scripture talking about "eternal life" or just "life"? Both terms are used interchangeably in this passage. Secondly, there is the question of whether "immortality" is inherent at birth, or only after "being saved"? For those who believe in a burning hell, consistency would require that "immortality" must exist irregardless of "salvation," otherwise an "unsaved" person would not have the immortality needed to "live forever" in a "burning hell."

But there is a great difference between the Greek terms which appear in the English Bible as "immortality" and "eternal life." Their actual meanings are:

1. IMMORTALITY - [Gk: athanasia]= no death (deathlessness).
2. ETERNAL LIFE - [Gk: dzoay ionion]= aeon life (life for an age).

One can easily see that these two terms are completely dissimilar. "Immortality" is fairly simple and straight forward, but "ETERNAL LIFE" (aeon life) is quite different. This term needs further consideration for its actual meaning is entirely different than we have been given to believe by the translators and the preachers.

The two Greek words DZOAY (life), and IONION (aeon), together indicate some kind of "life" that is connected to "an age" (aeon= a period of time). And since 1 John 5 states that God "HATH (past tense) GIVEN" us eternal life already, then this "aeon" ("life age") is THIS AGE IN WHICH WE LIVE RIGHT NOW - THE KINGDOM AGE! It is the present aeon of Christ's Reign (Matt 28:18 & 1 Cor 15:25). Jesus has given us "life" that we might understand and follow Him. So the King James Bible's rendering "eternal life" missed the mark by nine yards. "Aeon life" (Kingdom-age life) is a term which is meaningless outside the scope of Jesus Christ's Reign. Jesus gave the gift of "LIFE" to dead Israel. Israel was RESURRECTED from her death in sin, and made ALIVE again through the blood of Christ (see Ez 37 and Jn 1:4).

Returning to 1 John 5, we discover a concise Bible definition of "Kingdom Life," in verse 20:

*"And we know that the Son of God is come, and hath given us AN UNDERSTANDING (mental perception) that we may know him that is true, and we are in him that is true, even in his Son Jesus Christ. THIS IS THE TRUE GOD, AND ETERNAL (AEON) LIFE."*

The word "this" refers back to "an understanding." In other words, KINGDOM LIFE gives us an ability to UNDERSTAND Him that is true. "Aeon life" is obviously being used to mean heavenly guidance and "understanding:" in other words, REVIVAL.

These verses and others in the English translations use the misunderstood term "eternal life," but it is actually is the Kingdom principle of the Christian mind being "alive" as compared to the carnal mind which is "dead." Only the LIVING are capable of perceiving truth. The DEAD mind of a reprobate sinner is bound in chains of darkness.

*"These (carnally minded men) are .... without fruit, twice dead, plucked up by the roots; . . . . to whom is reserved the blackness of darkness for ever." (Jde 12-13)*

*"And be not conformed to this world (dead): but be ye transformed by the renewing of your mind (alive), that ye may prove what is good and acceptable, and perfect, will of God." (Romans 12:2)*

*"For to be carnally minded is death: but to be spiritually minded is life and peace. Because the carnal mind is enmity against God: for it is not subject to the law of God, neither indeed can be. So then they that are in the flesh (dead carnal mind)*



cannot please God. But ye are not in the flesh, but in the spirit (living Christian mind) if so be that the spirit of God dwell in you. Now if any man have not the spirit of Christ, he is not of Him. And if Christ be in you, the body is dead because of sin; but the spirit is life because of righteousness. But if the spirit of Him that raised up Christ from the dead shall also quicken (make alive) your mortal (dead in sin) bodies by his spirit that dwelleth in you." (Romans 8:6-11)

"Even when we were dead in sins, hath quickened us together with Christ, (by grace ye are saved;)" (Eph 2:5)

"But (His calling) is now made manifest by the presence of our Saviour Jesus the Christ, who has abolished death (the carnal mind), and hath brought life (in Christ) and immortality to light through the gospel." (2 Tim 1:10)

"But blessed are your eyes, for they see: and your ears, for they hear:" (Matt 13:16)

That which is translated "eternal life" in our English Bibles is misunderstood by most. It has been confused with "immortality" and the literal resurrection from physical death. However, the resurrection that brings "You" back from physical death is addressed by other scriptures which we have not addressed in this particular study.

### PHYSICAL RESURRECTION

With all of the preceding arguments under consideration, some of those who have "bought" the serpent's lie will stubbornly refuse to let it go, asking the following question: If "You," in death, do not exist at all, in any form, can God still resurrect "You?" In other words if there is nothing there to resurrect, how can God bring you back into existence?

A similar question could be posed as an answer: "If there was nothing there before man existed in the first place, then how did God bring him into existence?" The answer is obvious. God had the power to create man from nothing, and He can certainly resurrect (re-create) "You" from non-existence (nothing)! Anyone who says He can't, is limiting God.

Don't be confused by some variation of the original serpent's lie. Believe the God of Truth when He states, "Thou *SHALT* surely die!" (Gen 2:17)

"...for dust thou art, and unto dust shalt thou return." (Gen 3:19)

### BY THE WAY . . . .

It is also a popular notion that Adam and Eve were created immortal, but somehow lost their immortality when they sinned against God. If you believe words actually mean what they say, and God is logical and never changes, then you will recognize the impossibility of this popular notion.

Noah Webster's 1828 dictionary defines "immortality" as:

The quality of NEVER ceasing to live or exist; EXEMPTION from death and annihilation; life DESTINED to endure WITHOUT END,...

If you presuppose that an immortal being stands the chance of sinning and thereby becomes mortal, then you imply that the Word of God, and the words in Webster's definition, do not really mean what they say.

Since God knows the beginning from the end, He obviously had a certain DESTINY in mind for Adam and Eve when he created them. He created them to either die, or live forever.

Therefore, if God created Adam and Eve to be immortal from their first breath, that means they were DESTINED to live WITHOUT END. They would NEVER die; they were EXEMPT from death. Under these conditions it would be impossible for the state of immortality to change into the state of mortality, because if that change happened, it would mean that Adam and Eve had actually been destined all along to die and NOT live forever.

Or it would mean that "never" does not really mean never; "exempt" does not really mean exempt and so on. This would also imply that God changed His mind about Adam and Eve's destiny (to live without end). If God knows the beginning from the end, He would not need "Plan B."

Furthermore, it should be evident that the ability to sin is required in order for the condition of mortality to exist as is shown by the following verse:

"For the wages of sin is death..."  
(Romans 6:23a)

This verse says that sin results in death. Thus, if an immortal being is one who is exempt from death, he could not have the ability to sin. In other words, if Adam and Eve were created immortal, then they would not have been able to sin.

Furthermore, using the same logic, if supposed supernatural angels were created immortal, then there could not have been "Fallen" angels because as the story goes, the angels "fell" because they rebelled (sinned) against God. They would have had to be mortal to sin. But that is another subject.

Words HAVE to mean what they say or else we have only confusion and perpetual deception.

"He that loveth silver shall not be satisfied with silver; NOR HE THAT LOVETH ABUNDANCE WITH INCREASE: this is also vanity." (Ecc. 5:10).

In an age of booming technology, labor-saving "widgets" and "Babylonian Beefburger" franchise outlets lining America's streets, we must be enjoying the highest standard of living ever known. And superficially, we are. But looking beyond the cheap facade of glitter and tinsel on "franchise row," the realities of this great American carnival tell a more sobering story.

Never in history have we enjoyed (or endured, which ever you prefer) so many lawyers - and so much litigation. Never so many schools and colleges - or lack of common sense. Never so many fine hospitals and highly trained "medicine men" - or unhealthy people. Never so many restaurants - with so little worth eating. Select a field, the examples are endless - and economics is certainly no exception.

Never before have we been blessed with so many banks for depositing our loot - or so many indebted to them. Never have pay checks been larger - and mortgages so long. Never has government been so helpful - or taxes so high. And never have we so arrogantly asserted "freedom" to do our own thing - or pursued debt-bondage with such a passion.

There was a time when the objects we possessed were a measure of our wealth. Today they measure our debt. Abundance was simply not enough - we aspired to greed.

As King Solomon put it, we love abundance and are no longer satisfied with increase. Instant material and sensual gratification has become our way of life. To pave the way and show us how, was our noble and daring scout, the banker.

The "have it now" craving begins early. Infatuation with new automobiles, for instance, starts our young people on the treadmill, often before they finish school. Parents co-sign for their children's bank loans, encourage them to "establish good credit early in life," giving little thought to the habit pattern they create which may last a lifetime. Some future.

Without a doubt, many of your friends and acquaintances "enjoy" using bank credit to obtain things which are not theirs, such as the bank's new automobile, airplane, boat or house; but a violation of the loan contract can lead to repossession, quickly showing the folly of their ways.

"The rich ruleth over the poor, and the borrower is servant to the lender." (Pro. 22:7)

Bank credit is not, as some might think, a new phenomena engineered by do-gooders to help rid the world of poverty. To the contrary, commercial banking, the most profitable of all businesses, began in ancient Babylon. Loan contracts existed as far back as 2,000 B.C., many of them secured by mortgages.

Nor are we lacking alternatives to debt bondage, even in these pressing times. Young people would do well to profit from the frugality of an earlier time, when an old jalopy, say twenty or thirty years old, was purchased without debt and then restored to new condition as funds became available. This produced no suffering or hardship and, in fact, proved to be an enjoyable past time. The results were often remarkable!

But then, those were the days when youth were considered poor credit risks. They still are. Thus parents must co-sign as surety for what our forefathers would scarcely believe their own children's debt.

"My son (mom and dad in this case), if thou be surety for thy friend (son or daughter), if thou hast stricken thy hand with a stranger (banker), Thou art snared with the words of thy mouth, thou art taken with the words of thy mouth." (Prov. 6:1-2)

As young Christians who love and honor their parents, you should carefully weigh the implications of this relationship, for it means an absolute promise on the part of your parents to perform the service of a debtor, if for some unforeseen reason you cannot (or will not) keep your word. It means a "bond of law" is set upon you and your parents as indentured servants, from that day into the future - a future no man can possibly know.

"For he knoweth not that which shall be: for who can tell him when it shall be?" (Ecc1. 8:5-7)

In a world of economic uncertainties, why would anyone knowingly pledge to sacrifice his possession and future earnings on the altar of a bank? An economic downturn, caused by any of a number of reasons can result in a paycheck reduction, even a loss of one's job. This makes the payment schedule impossible to meet, leading to bankruptcy and foreclosure. Despite this, young people hurry down to their bank taskmaster and sign on the dotted line, caring little what tomorrow may bring.

"Seest thou a man that is hasty in his words? There is more hope of a fool than of him." (Prov. 29:20)

A subconscious fear of "loss" nevertheless permeates our society as "bank rentals" exert their pernicious influence on independent thought and action. An "unpopular belief" can cost you dearly and even get you fired. This could translate into an "overdue payment" in the bank book and few there be who can afford the luxury of resisting popular opinion. Fewer still can afford to challenge government policies, knowing the I.R.S. may attach their wages or bank accounts.



For people accustomed to compromising their beliefs in order to get along in the world, debt bondage creates little problem. Idealists, however, quickly sense the dilemma and loss of independence caused by exposure to a truth which, if acted upon, would irritate the "powers" that be.

*"No man can serve two masters: for either he will hate the one, and love the other, or else he will hold to the one, and despise the other. Ye cannot serve God and mammon. (Matt. 6:24)*

Notice how the second master was not identified as Satan or the Devil, but rather mammon - wealth personified. Like the gift which "blindeth the wise, and perverteth the words of the righteous" (Exod. 23:28), commercial credit induces us to ignore truth, especially as it concerns government and banking. Who will challenge those who hold the "keys" to our homes and our cars? American opinion has, you see, already been compromised.

An application for bank credit has overwhelming legal ramifications as well, not the least of which is the express *consent* of the debtor to abide by a new system of law, called Equity, governed by its own statutes and courts. Your so-called "constitutional rights" are correlatives of Law and do not exist in Equity. They are "voluntarily waived" by your signature on the contract for debt.

Bank credit serves as a springboard into another rat's nest - insurance - a means of protecting the bank's interest in their car. Ever notice how irresponsibly people behave when using a car they don't own? Teenagers often demonstrate this by "burning rubber" their parents must replace. Well, the bankers noticed this tendency too - but to them, we're all irresponsible.

Since title (ownership) to American automobiles generally resides with a bank, and financial responsibility for damage or loss is carried by an insurance company, another link in our incidious "ball and chain" is necessary - registration. This is administered by a state department of motor vehicles, allowing the real owners and those with the real financial responsibility to keep track of their automobiles.

When a policeman stops an automobile on the highways, or investigates an auto accident, he relays the registration number and other pertinent data to N.C.I.C., a national computer system. Why? Well, the banks and insurance companies, whose autos are on file with the crime computer network, have a vested interest in our behaviour. Did the motorist move without making the last few payments? If so, the car is stolen. And in the case of an accident who, (or what insurance company) will pay the bill?

The debtor whose signature binds him to "contract law," waives his right to travel by automobile - because it belongs to someone else. The "right" is reduced to a mere "pri-

vilege" (Lat. *privius* + *lex* = private law) for which he must obtain permission. A "license" is required to use the bank's car and the insurance company's legal liability. However, very few motorists suspect a connection between state licensing (plus motor vehicle statutes) and the lobbying efforts of banks and insurance companies. Nor do our policemen appear to realize how they became "contract law" enforcement agents for them as well.

As the public continues seeking "terms" (installment credit) for their acquisitions, we can anticipate mandatory registration and eventual licensing of such diverse items as computers and bicycles - obtained on the "easy payment plan".

### ISRAELI DEALING DRUGS?

Will wonders ever cease?! On April 7, 1988 A.B.C. (U.S.) News revealed many facts regarding Israeli involvement in the "drugs-for-guns" trade, supposedly in support of the Nicaraguan "Contra" movement, and involvement we have long suspected. Long before Lt. Col. Oliver North became entangled in the Iran-Contra arms affair, the Israelis were dealing in drug production and smuggling. The Chaim Weizman institute in Tel Aviv is known as one of the largest drug factories in the world. The one-time trendy drug, "L.S.D.", some say, was created and developed at an Israeli factory.

In the case related by ABC, the Israelis purchased weapons and munitions from Communist-bloc nations such as Poland and Czechoslovakia, and shipped them from Yugoslavia (a country with western ways, but Communist rule) to Bolivia, and then to Panama and Costa Rica (landing at airstrips such as the one owned by John Hull, also involved in the "Heroin Pipeline" from Burma--see March 1988 America's Promise newsletter). The weapons were unloaded and supposedly supplied to Contra rebels (who are not allowed to fight a "guerilla" war against the Sandanistas). The Colombian cocaine and other drugs, including marijuana and heroin, were then loaded aboard old cargo planes (such as DC-6's and C-123's) and flown to isolated landing sites in Texas.

An anonymous informant, who used to fly these drug runs between 1983 and 1986, told ABC, "I guess you could say at that time I felt my employer was Israel; secondly, my employer was the United States of America... Bringing that stuff into the U.S....that was something else. I've never been so thoroughly disgusted with myself." Some pilots were hired for as much as \$360,000 (*per flight*) to run weapons and drugs.

One smuggler, George Morales, testified before the U.S. Senate Foreign Relations Committee that he gave "several million dollars" to the Contras from profits from cocaine





being smuggled into the U.S. Morales also claimed to have arranged at least six arms shipments to Nicaragua because Contra officials claiming to be Central Intelligence Agency (CIA) operatives promised to get drug charges against him dropped here.

Gary Betzner, another pilot who flew drug and guns flights, said the weapons usually included small arms, mines, C-4 (plastic) explosives, and M-16's, and that each return flight to the U.S. carried about 1,100 pounds of cocaine (Wholesale price of \$5 million, street value much higher. At the time, cocaine was selling for six times this price.) Betzner, who worked for Morales during this period, said he DID NOT KNOW WHO PAID FOR THE WEAPONS. In the Israelis' case, the original arms purchase was for \$20 million, which was re-imbursed to them out of "U.S. covert operations funds" (i.e. from the taxpayers). You are funding the war in Central America whether you like it or not.

Scripturally, it is exposing those who love money, the root of all evil (1 Tim. 6:10), those who are excluded from the Kingdom of God through *SORCERIES* (Rev. 22:15: "pharmakeia", - druggery).

It appears to us that we must put forth a new slogan for an unsung battle. Insist that our congressmen and other public servants **JUST SAY NO TO FOREIGN AID.** If ever there is reason to cut off aid to a country, it is the damning evidence against our alleged "allies," the Israelis.

#### 10

### WHAT ARE THE SPIRITUAL IMPLICATIONS OF THE INCOME TAX?

**Exodus 20:15** - "*Thou shalt not steal.*"

Only a Sovereign has the power to tax. Taxation is a tribute by a servant/slave to show submission to his sovereign master. God demands a tithe from all men, not just the saved or the redeemed because all men are His creation, His servants, His slaves, and He is the only universal Sovereign.

In fact, God is God of all men. He is Lord of all men. Some men are in rebellion and refuse to submit to His sovereignty kingship, but this does nothing to lessen God's position.

"*The earth is the Lord's and the fullness thereof.*" **Psalm 24:1.** The earth is not Satan's, nor does any part of it belong to him or to the government. God demands a tithe (a tax, if you please) because He is Sovereign. He is Lord. He is King. And He owns the earth and all that is in it. Men are mere stewards of that property of God. When a government attempts to force taxes on labor and property, government is proclaiming that it is sovereign, that it is god, and it owns the turf within its borders. In essence, the government that does this is stealing God's Sovereignty, God's property, and the lives of God's creation.

Our Founding Fathers, being very well versed in Biblical Law and principles, knew this. Therefore, they recognized God's sove-



reignty, accepted His church as a sovereign embassy with full immunity in this country. They also created a government where the citizens were sovereign under God but over government, and all taxes would be levied strictly by the consent of the people, not unlimited taxing power by the state and federal governments.

Today, our elected officials have become patsies for big financial institutions. Most of our elected officials are corrupt, many criminal, and the rest are ignorantly cooperating with the wicked. It is a rare thing indeed to find a man who stands up for the Constitution and the people. If he or she does, they are usually eliminated, targeted and destroyed so that they lose their effectiveness in their position. Here are a few well known who have become targets by the powerful interests that run our government: Larry McDonald, George Hansen, John F. Kennedy, Eugene McCarthy, Ronald Reagan (in his early days before he was shot).

In the days of feudal lords, the serfs rebelled against their lords over a 15 percent tax. Today, American citizens are paying 50 percent tax to their lords and seem to love it. The current government literally determines through its taxing and regulation policies who shall be allowed to succeed and have property and wealth. If you cooperate and promote government policy, you will be favored. If you will not cooperate you will be targeted, harassed and finally be effectively rendered helpless and poverty stricken.

The current government structure in America is a big Mafia-type operation, forcing more and more extortions of property from the American people who support more Socialist, Marxist and Communist countries around the world, plus finance the almost completed process of Marxising the American people through the public education system. (See chapter titled: Are You A Communist?). The Bible teaches private ownership and stewardship of property. Communism hates this concept. Communism knows the truth that God created: namely that dominion of the world is done through control of property. If you control property you have the power of dominion.

If the state controls property, the state has control of dominion. That's why a people without property or a church without property can do very little for the kingdom of God. There is an old saying that goes like this: Live by the Golden Rule- He who has the gold makes the rules. That's why the IRS and government agents are coming down on churches and individuals who are dissidents with property in America. They do not want dissidents to have property power.

Property power begets more property and more power for dominion. The marxist graduated income tax is the most powerful tool ever created by the government to limit the power of the people. ### WHAT ARE CHRISTIANS TO DO?

There are three extremes we must avoid: **first**, declaring a one-man war of killing and bombing; **second**, passively accepting the system; and **third**, martyrdom by: a) being a



pauper, b) fighting in a court constantly stacked against you, and c) going to jail when it is unnecessary. One thing the enemy knows, is that they can keep us busy in court, unproductive, and broke, then they win even if they lose. We must stay productive, we must conserve our assets and use them against the system.

The Bible says that, "...the children of this world are wiser than the children of light." The big boys have amassed billions of dollars in offshore banks, trusts, and investments. All of this is available to any American who seriously wants to apply Godly principles of frugality, legal tax avoidance, and aims for Godly dominion of his own life, his own family, his country and the world.

Families like the Rockefellers, Mellons, Hunts, and hundreds of others have paid very, very little income tax in the U.S.A. or any other country. If you are serious about these arrangements, simply read Secrets Of Offshore Tax Havens, available from America Today Books, Box 249, LOUISVILLE, NEBRASKA 68037.

A recent issue of U.S. News (1986) listed the 100 wealthiest families in America. Two things were significant about this listing: **First**, Rockefeller and the super rich were not listed because all their wealth is held in trusts and secret accounts instead of their names. **Secondly**, the number one investment of the rich is in *media*.

The anti-Christian forces long ago realized the absolute necessity of property. Those who wield power and influence control property. They also know the importance of controlling thought through their great investment in media including T.V., radio, records, book publishing and computers. The third step of their plan is to extract property from those they desire to control. If we as Christians ever hope to wield dominion in the name of Jesus, we must have a different attitude toward wealth, its procurement, protection and investment.

### The Jury

Many Christians try to avoid jury duty. This should not be. The jury is our most powerful tool against ungodly government. Many Christians do not know what to do on a jury, nor do they know the power of a jury. I suggest one book and one video tape for all Christians on the Jury. The book is An Essay on The Trial By Jury by Lesander Spooner. (Available from America Today Books, Box 249, Louisville, Nebraska 68037). The video tape is In The Jury Room, a professionally done one hour tape of an actual jury trial and its deliberations. (Available from PBS Video, P.O. Box 8092, Wahsington D.C., 20024.)

For the first time ever in the history of the courts, permission was granted to film an actual jury while in session behind closed doors. The film is excellent. After viewing the film, many people in my church lost all fear of

being called for jury duty.

The jury has the right to ask questions and decide the case on law and facts. The jury can nullify a bad law by voting *not guilty*. Suprisingly, most Christian jurors still vote *guilty* on a jury when trying a person for failure to file. We could destroy the system immediately if all Christians would:

- 1) Get out of debt,
- 2) Destroy all credit cards,
- 3) Refuse to use banks in the FDIC usury system,
- 4) Use their wealth to educate others and
- 5) Vote *not guilty* on all tax related cases which the government is using to jail non-filers and persons involved in the underground economy.

Let's do it.

The accumulation and proper use of wealth is a must for dominion work. Abraham, Isaac, Jacob, Esau and others were wealthy men. God blessed them because they used their wealth for dominion of the earth under God. If your goal is wealth for more material things and pleasures, then, of course, God is not interested in blessing that. Also, if your plan is to pile up wealth for children and grandchildren who are untrained in its use, that is bad.

But the greatest weakness in the Patriot circles is that they are broke and proud of it. There are thousands of causes seeking funds, and every patriot has his *silver bullet* to beat the system that writes its own rules as it goes. Of course, we must pray; we must put the wicked on notice. The American Coalition of Unregistered Churches has come up with an excellent plan, called the Court of Divine Justice.

They have used this Court in several places now, and its worked very effectively. They simply go in where the system is rotten to the core, where some Christian is being held in jail or his church is being shut down or taxed, and they hold Court on the steps of the courthouse, trying the judge, the sheriff, and all other criminals involved. After hearing the evidence, they find the verdict of guilty, pronounce the sentence, and turn them over to God's justice for judgement.

I might add that in some cases God has surely judged and certainly the fear of God has been put into a number of officials. They got this idea from my prayer on the steps of the jail-house as I got out of jail on January the 31, 1983. Many Christians, of course, have been appalled by the fact that I would pray such a prayer demanding God's judgement upon the wicked.

As I came out to the steps before the press, I prayed a prayer as follows: "*The Word of God is the Supreme Law of the universe. God says in His Word that if we'll ask anything in the Name of Jesus, that He will do it. Therefore, in the Name of Jesus and His shed blood, and upon the authority of God's Word, I ask God to stop the officials*



of the State of Nebraska from interfering with the work of God and their harassment of the Church of God by either saving the officials, removing the officials, or killing the officials."

Many people have been upset about that prayer, but Psalm 35 and various others show that we are to put the wicked on notice and bring them to accountability before God. Needless to say, it was after this prayer that things began to turn around in Nebraska, and eventually a great victory was won.

### Anti-Thought-Control-Dictionary

A Guide to Deceptive Words and Terms

Used to Neutralize Christians.

**HELL:** Mythological Meaning: Satan's literal kingdom somewhere "under the earth" where bad people go to live forever in endless fire and torment when they are dead. God sends all people, except a very few elect, to suffer there forever.

Intent: The threat of a "burning hell" is used to scare people into churches and under the subjection of priestcraft.

Biblical Meaning: Any grave or pit where dead bodies are buried. It can also refer to the state of death, as opposed to life. "Helling" something means "covering" or "hiding" it, as in "helling potatoes" (covering them in a cellar for the winter). Figuratively, "hell" simply refers to "death."

**INFLATION:** Controlled Meaning: Increasing the amount of currency in circulation, thus making the existing currency less valuable and causing higher prices.

Correct Definition: True inflation is caused by issuing more money than is needed to settle all debts and facilitate a sound economy. In reality, it almost never happens. Under America's Federal Reserve System, every dollar issued carries with it an equal debt to the Federal Reserve Bank. Thus, it is impossible to create more money than is needed to pay the debt since the debt is equal to the amount issued (loaned into existence). Adding usury on top of the original debt makes it impossible to ever have enough money in circulation to settle debts. Thus, we have debt inflation, not currency inflation.

Today, we are often told we are suffering from too much currency. The truth is we suffer from too little currency. That is as the bankers have designed it to keep the public dependent upon them for loans.

**DISCRIMINATION:** Controlled Definition:

Unfair preference of one race of people over another. White people (particularly Christians) favouring their own race.


