THOUGHTS FROM TIJUANA

DO CHURCHES CAUSE CANCER?

"My people are destroyed for a lack of knowledge..." (Hosea 4:6-NASV)"If you are at careful to observe all the words of this law which are written in this book, to fear this honored and awesome name, the Lord your God, then the Lord will bring extraordinary plagues on you and your descendants, even severe and lasting plagues, and iserable and chronic sicknesses. And He will bring back on you all the diseases of Egypt of which you were afraid, and they shall cling to you." (Deut. 28:58-60-NASV)

I couldn't help but think of the above verses on a recent return flight from Tijuana, Mexico. While we are made to worry about some so-called future plague of AIDS we seem oblivious to the present ravages of CANCER, a known disease of Egypt. The American Cancer Society now estimates ONE out of THREE Americans will suffer from this disease.

My seventy-two year old friend on the plane with me was part of that dreaded one-third. Although our trip to Mexico seemed to have been in vain, I was glad he chose it over adiation. As his pastor I had been with him when the doctor reported the brain tumor, that had just been surgically removed, was cancerous and sure to come back. Radiation was recommended but upon my questioning, the doctor answered honestly that it would make him sick, destroy good brain tissue, not cure anything and would, in fact, eventually activate the cancer to grow faster, but could perhaps prolong his life.

I've since thought of such treatment in light of the euthanasia practices of the old Sioux Indians or Eskimos. The Indians would leave their aged out on the plains to die and the Eskimos would abandon them to the freezing cold. Such practices seem barbaric until placed alongside the modern medical treatments of chemotherapy and radiation administered to the victim as long as he or his insurance company will pay for it. I was glad my friend was spared that. In comparison, the cruel plains or cold ice seem merciful.

My friend and his family eventually decided to try alternative cancer treatment, but the decision came too late. The physician in Mexico felt he was too far gone, too full of cancer. He wished he'd come sooner, preferably before surgery.


Of course, the AMA would say the physician was a quack out to make money off a suffering victim. Yet this "quack" didn't want to poison or radiate my friend as long as he and/or his insurance company could pay for it.

Alternative cancer treatment normally entails going to another country, because even though we have been told we live in a FREE country, our government and the AMA's monopoly have seen to it we are not free to receive the treatment of our choice.


The choice for my friend was Jimmy Keller's treatment at St. Jude International $\ensuremath{\mathsf{N}}$ Clinic in Tijuana, Mexico. Jimmy Keller's sory is a fascinating one. He came down with black melanoma cancer in 1968 and after being butchered surgically, he was given up to die. Instead of dying, he regained his health treatment administered through herbal Texas until the government stopped it. Mr. Keller dedicated his life to helping other cancer patients receive similar treatment and eventually became a target of the U.S. Government. As a result, Mr. Keller now lives as a fugitive in Mexico. I did not visit with him very long, but felt he was a loving and caring individual.

His Tijuana clinic was not much more han a few rooms in an old white building in need of repair. Upon arrival I pushed my friend's wheelchair down a dreary hall and entered a room whose walls were lined with occupied chairs. The people sitting in them

ranged from 20 to 70 in age, male and female. Most had i.v.'s in their arms with clear liquid dripping from bottles hanging above them.

During the four hours we were at the clinic, I talked with these people. At first I felt uncomfortable and even had to force mycelf to visit but soon it became easy. The atients were glad to talk. No one seemed to have a bad word to say about Jimmy Keller or the treatment. One patient pointed to a young man of about 20 sitting in the far corner with his eyes closed, listening to a stereo headset. "See that boy? When he came in here a week ago, he had a lump on the side of his neck the size of a small grapefruit." I looked closely and there now only appeared to be a small swelling under his ear. One older lady, who hadn't been there long, said she hadn't shown much improvement, but her girlfriend was completely cured of breast cancer.

I found it was easy to talk to these people about government. They were angry that they had been forced to leave their own country to get help. They had rightly concluded that somebody in America didn't want an effective and less costly cancer treatment to be available. I remembered, as a boy on a Nebraska ranch, listening to an old neighborly lady explain how the AMA didn't want a cure for cancer. "Too much money is being made

off of cancer," she said. I remember the other adults at the dining room table saying in disbelief, "They wouldn't do that!" They lady's husband was an old cowboy who had come down with rectal cancer years previous and had been cured by a method outlawed by the U.S. government.

Years later, as a Christian, I read in my Bible "The love of money is the root of all evil." Maybe someone would be evil enough to forbid effective help to cancer victims considering \$60,000,000,000/year is spent in America on cancer. Someone is making a lot of money from the disease.

THOUGHTS AND OBSERVATIONS I MADE WHILE AT THE CANCER CLINIC.

CHURCHES CAUSE CANCER

A diseased nation is the fault of the false, diseased, reprobate religion being pawned as Christianity. There has been some speculation concerning the cause of cancer as well as heart disease. The American Cancer Society says one out o f three Americans will get cancer and the American Heart Association says 65,980,000 Americans have one or more forms of heart or blood vessel disease. Amid all of this disease there seems to be one statistic that has been overlooked. America has ore so-called Christian churches today than ever before and she has more cancer (and other diseases) than ever before. Could it be the churches are causing cancer? The answer is YES! They cause cancer and other diseases by refusing to teach the Laws of God, by teaching against the Laws of God, by convincing the people the Law has been abolished because it was against them, and by substituting a doctrine of Grace for the doctrine of obedience to God's Laws. God has said, "...if you will give earnest heed to the voice of the Lord your God and do what is right in His sight, and give ear to His commandments, and keep all His statutes, I will put none of the diseases on you which I have put on the Egyptians; for I, the Lord, am your healer." (Ex. 15:26-NSAV).

REPENTANCE is turning back to and obeying God's Laws. Until the so-called Christian churches do that, we will be a sick and dying nation. The following quote from the book entitled **None of These Diseases** by Dr. S.I. McMillen, M.D., illustrates the point.

Leadership was taken by the church, as the physicians had nothing to offer. The church took as its guiding principle the concept of contagion as embodied in the Old Testament. ... This idea and its practical consequences are defined with great clarity in the book of Leviticus. ... Once the condition of leprosy had been established, the patient was to be segregated and excluded from the community.

Following the precepts laid down in



Leviticus the church undertook the task of combatting leprosy...it accomplished first great feat...in methodical eradication of disease.

The procedures came from Leviticus 13:46 "All the days wherein the plague shall be in him he shall be defiled; he is unclean: he shall dwell alone; without the camp shall his habitation be." Other historians credit the Bible for the dawning of a new era in the effective control of disease: "The laws against leprosy in Leviticus 13 may be regarded as the first model of a sanitary legislation."

As soon as the European nations saw that the application of Scriptural quaranine brought leprosy under control, they applied the same principle against the Black Death. The results were equally spectacular, and millions of lives were saved.

ALL IN THE CLINIC WERE WHITE PEOPLE

Not only does America's modern Judeo-Christian church help spread disease, they tack men such as myself, that observe and speak upon the racial significance of things. All in the clinic were white. Some may claim iey are the only ones that can afford it, yet in talking with them, I could see many were people of little means. I not only noticed they were white but noticed most had a deep faith as if it were in their genes. Their sickness had made them instinctively turn to their God and increase their faith in Him. They were and are children of their faithful Father Abraham. They are the true Israel people of Scripture. God has clearly proclaimed that these covenant people would be blessed if they followed His Law and cursed if they would not.

"Now it shall be, if you will diligently obey the Lord your God, being careful to do all His commandments which I command you oday, the Lord your God will set you high above all the nations of the earth. And all these blessings shall come upon you and overtake you, if you will obey the Lord your God...But it shall come about, if you will not obey the Lord your God, to observe to do all His commandments and His statutes which I charge you today, that all these curses shall come upon you and overtake you." (Deut. 28:1-2, 15-NASV). God has said these curses shall genetically follow the race of Israel. all come on you and

pursue you and overtake you until you are destroyed, because you would not obey the Lord your God by keeping His commandments and His statutes which He commanded you. And they shall become a sign and a wonder on you and your descendants forever."

(Deut 28:45-46, NASV).

IGNORANCE OF GOD'S LAW

Not only were these people ignorant of who they are but ignorant of God's Laws. To years you shall sow your field, and six illustrate this point, allow me to share with years you shall prune your vineyard and

patients. We'll call her Susan.

Susan is a baby boomer about 48 years old with cancer of the female organs. I could tell she was tough, independent and gutsy. She was not above an occasional cuss word when she spoke of the AMA and government, at least not until she learned I was a preacher. She didn't obey her medical doctor in the States who told her to have surgery immediately. Instead she called some friends and asked for prayer and headed to Mexico alone. She was a single parent with a six year old child at home (I don't know if she was divorced or

As I visited with her i pointed out that all in the clinic were white and explained the Bible story of Abraham, Isaac and Jacob and their descendants. She, in turn, asked what this ad to do with cancer. My response was, "We are breaking the Laws that God gave us as a people and thus are reaping the curses, one of which is cancer, a disease of Egypt." Her next "WHAT response, in all earnestness was, LAWS?"

BROKEN LAWS THAT AFFECT OUR NATION-AL HEALTH.

Time did not allow me to begin to list and explain the various laws. For one thing, I had to think about it myself and another I didn't want to make the novice mistake of telling too much or telling more than she could bear to hear. "I have many more things to say to you, but you cannot bear them now." (John 16:12,NASV). "A prudent man conceals knowledge, But the heart of fools proclaims folly." (Prov. 12:23, NASV).

SABBATH REST was one law I related. "Observe the sabbath day to keep it holy, as the Lord your God commanded you. Six days you shall labor and do all your work, but the seventh day is a sabbath of the Lord your God; in it you shall not do any work, you or your son or your daughter or your male servant or your female servant or your ox or your donkey or any of your cattle or your sojourner who stays with you, so that your male and female servant may rest as well as you." (Deut 5:12-14,NASV). When people fail to rest one day (after six of work), illness will result. She said "That's one thing I never get is rest" and explained what life was like as a saleswoman, a mother and single parent.

LAND SABBATH is another law that comes to mind. Not only is this working mother not getting a seventh day rest, the nation's farm land is not getting a seventh year rest. Man's body comes from the dust of the earth (Genesis 3:19) and his life is sustained and affected by what comes from the earth and how we treat it. God's Law said let it rest seven years. you a conversation I had with one of the gather its crop, but during the seventh year

the land shall have a sabbath rest, a sabbath to the Lord; you shall not sow your field nor prune your vineyard. Your harvest's aftergrowth you shall not reap, and your grapes of untrimmed vines you shall not gather; the land shall have a sabbatical year. And all of you shall have the sabbath products of the land for food; yourself, and your male and female slaves, and your hired man and your foreign resident, those who live as aliens with you. Even your cattle and the animals that are in your land shall have all its crops to eat." (Lev. 25:3-7, NASV).

The results of this act alone would have a profound effect upon national health. Such a land rest breaks the life cycle of many cropdestroying pests, eliminating the need for poisonous pesticides. Other insects are destroyed by a chemical action created by decaying grasses, legumes and fruits. There are many other benefits such as an inexpensive, nongovernmental elimination of surplus, a recharing of the water table, but most importantly, better quality, more nutrient-packed food in the six productive years. (I have a University griculture degree but was never taught this until the Identity truth brought me to a study of God's Law).

USURY, that is interest, is strictly forbidden by God's Law. "Take thou no usury of him, or increase: but fear thy God; that thy brother may live with thee. Thou shalt not give him thy money upon usury, nor lend him thy victuals for increase." (Lev. 25:36-37, KJV).

Because we have allowed an usury economic system and have become a debtor society with the entire nation in hock to bankers, rest is out of the question. The farmer would not meet the mortgage payment if he rested the farm every seventh year. Usury means pushing and raping the land for more production, thus we use of pesticides, herbicides and chemical fertilizers. (You learn to use these in the Agricultural College since many of the research grants given the schools come from the oil companies).

PHARMAKIA of Babylon would include the farm chemicals. "...because all the nations were deceived by your sorcery." (Rev.18:23, NASV). The Greek word for sorcery is "pharmakia" meaning poisoning, drugs, and medicine.

Today we are poisoning the land, drugging the water supply (fluoride & chlorine), chemically preserving the food, vaccinating the youth, and using growth hormones in the meat production. It's the "pharmakia" od Babylon and it's making us sick.

At this point I should mention my friend, whom I took to Mexico. He has been as fine a Christian man as one would ever have a chance to meet. He has obeyed God's Laws on rest, usury, and so forth, but because his nation has not, he is sick. Living in a nation that has gone to Babylon (Micah 4:10) can jeopardize the health of a Christian even when

he or she is obedient to the best of his or her ability. In such a scenario, the curses shower and filter down like rain falling on the unjust and sometimes the JUST.

UNCLEAN FOOD is probably another Law that Susan, like most Americans, was unaware of. Pork, shrimp, lobsters, oysters, and so forth, had no doubt been part of her diet. The unclean food may be tasty but it's also deadly and God said not to eat it (Lev 11).

Blood and fat is also forbidden, yet today many animals are not bled properly. For example, some slaughter plants electrocute fowl and thus get a very poor drain of blood. As for fat, we actually add it to hamburger and sausage.

REPRODUCTION of the species is a most fundamental Law of God (Genesis 1:28) but our race as been popping the pill while whoring around and mopping up with abortion. We have believed the lie of overpopulation and considered large families a curse rather than a blessing of God (Psalm 127:5, 128). One of the results has been women with cancer of the female organs. Susan's case is a good example. Fortyeight years old and only one (6-year-old) child, but you can bet she hadn't been celibate most of those years.

SEXUAL INTERCOURSE at the wrong time could also be another Law she'd never heard of. Leviticus 12 teaches the proper times for a man and woman to come together and, rest assured, health problems, hysterectomies, prostrate trouble, and so forth, are often tied to the violated laws.

The Bible addresses so many laws that affect health, including forgiveness, bitterness, worry, honouring father and mother, profanity, and such like, that we could not write them all here and I certainly could not have explained them to Susan during my brief visit to Tijuana. She was just one of a roomful of my people, my race, that is being destroyed for lack of knowledge.

Repentance is to once again obey God's Law. By this trip to Tijuana I am reminded my people must **repent or perish!**

Pastor Peters friend has since passed away. SCRIPTURES FOR AMERICA will miss his presence. But we have the hope of being reunited with him someday!

COMING FOOD SHORTAGE

This week I received the most startling letter I have ever received in my office. It written by a very credible attorney, a member of the bar in Alabama. It read,"Last night I talked with Gene Schroder from Campo plorado. Gene and his father were the founders of the American Agricultural Movement. Gene has a friend who works for the Univerty of Missouri. This friend is presently emloyed to study present and future weather patterns. In his study he has discovered that a unique combination of weather patterns and other factors has already produced the 1988 drought. The drought caused immeasurable damage to agriculture. Gene's friend says that he and all of his associates in the field are presently scared to death. They envision a calamity so profound as never to have been experienced by mankind. The drought, according to their study, will continue until after 1990. This means food and water shortages of a kind and nature as never before experienced.

The government of the United States knows this and certain people in the media now this, but for fear of panic they are not telling the people. There has been a major drought in the western and midwestern parts of the United States. Farm organizations have calculated that the harvest of grains is only one half of what it is in a normal year. America is not the only country which is in trouble, Soviet Russia had a very poor harvest this year also. This individual, the manager of the warehouse, is very knowledgeable of what is happening in the world and began questioning the government representatives as to what this space was to be used for. After much prodding he was reluctantly told, "We're renting this space because we anticipate the rationing of food as it was during the depression in 1929, 1930,1931."

U.S.-USSR MERGER MANIA

Who can deny that the American people and Congress have been subjected to an unprecedened campaign by the major American news media to portray Mr Gorbachev as a benign reformer whose only desire is openness and restructing in Soviet domestic affairs and normal relations with the United States?

How often have we heard about "glasnost" and "perestroika"? Why should we applaud a restructing which is intended to make commun-



ism work? Why should we rejoice in a restructuring which is inteded to build a better Gulag? Having heard the word "glasnost" so often on U.S. television and having read so much about it in the U.S. press, I asked my staff to look up the word in a Russian-English dictionary. The media tells us that the word means openness which leads us to believe that there is a relaxation of controls inside the Soviet Union and a new friendly attitude with the West!

The Library of Congress sent over to me a page from the Russian-English dictionary compiled by Professor A.I. Smirnitsky and published in Moscow. The entry under "glas" gives the meaning of "voice." The entry under "glasnost" gives a meaning of "publicity." Several specialists on the Soviet Union, who are native Russian speakers, have told us that the current meaning is a bit stronger than just "publicity." These specialists say that "glasnost" in current usage means "propaganda."

This is a far cry from what the media ould have us believe. But this distortion of the meaning of the meaning of words, warfare in the field of semantics, is typical of the edia diet that the American people are being red hour afer hour, day after day, page after page, broadcast after broadcast. This distortion of the meaning of words is typical of the ethical standards of American journalists working today. These journalists, intentional or not, are not reporting the facts about the news. They ae, rather, engaged in polemics and propaganda in a war on traditional American culture and values.

PSYCHOLOGICAL WARFARE

This campaign against the American people - against traditional culture and valuesis systematic psychological warfare. It is orchestrated by a vast array of interests comrising not only the eastern establishment but also the radical left. Among this group we find the Department of State, the Department of Commerce, the money center banks and multinational corporations, the media, the educational establishment, the entertainment industry, and the large tax-exempt foundations.

A careful examination of what is happening behind the scenes reveals that all of these interests are working in concert with the masters of the Kremlin in order to create what some refer to as a New World Order.

proceeds from an illusion of arms control. The INF (Intermediate Nuclear Forces) summit is supposed to mark the initiation of a new phase in Soviet-American relations. This phase is intended ultimately to produce a convergence in the two systems, Soviet and American.

THE 1929 FAST SHUFFLE

Problem; Growing Debt

The problem always waiting in a usury society is that:

Debt grows fater than equity.

More debt is issued each day. Today's S&L (Savings & Loans) bailout alone is supposed to put \$200 billion into circulation. Perhaps as much as \$50 billion will be fed into the nation's money system over the near term. Also, at this very minute, junk bonds (more debt) are being exchanged for stock (equity) causing further shortage of equity and a glut of debt. This debt/equity imbalance promotes an explosive situation. To deal with it the Federal Reserve banks can:

1) inflate by continuing to issue debt.

The risk is that the price of America's dream house could go to \$1,000,000 and General Motors could sell at \$5,000 a share. Or:

2) force prices down for a time. They can make the dollar scarce to depress both prices and debt through bankruptcy. Once this phase is over the money managers will allow prices to rise.

To make the dollar scarce they raise interest rates to discourage borrowing. At the same time they siphon existing dollars into banks by way of interest payments.

They are tricky. On occasion they may make you think that they are doing one thing while doing another. In 1929, they raised interest rates to stop the rising stock market. Then they lowered interest rates, BUT REFUSED TO MAKE LOANS. Many lost everything. The banks just refused to lend the money needed. This happened to tens of thousands across the nation. As the money growth shrunk, so did the value of stocks, houses, businesses, everthing else. It caused bankruptcy, foreclosures, and the bankers ended up owning everything – a thing the bankers insist is the last thing they want to happen.

How They Worked The Scam

The bankruptcy cycle can only be ended by ending usury, which was done to bring the West out of the Dark Ages. The usurers fight this tooth and nail. We still continue to "treat" their disease rather than to cure it with Arab-style non-usury banking. The day will come when everyone who loves to taste a slice of the usury pie carved from the side of an agonized kinsmen will be asked to acount for his actions. Until then:

International bankers use the system to go after 3rd world nations, forcing them to give up farms and businesses in exchange for



IOU's. At some point, America will be asked to do the same. Taxes on the national debt will become unbearable - as they are meant to. Then, the international bankers will offer to trade the national debt for our public lands, as was done to Rome. This, to lower public debt which will lower taxes.

Right now, the banking system has chosen to do one of the following:

- 1) Raise interest rates to break the stock market. After this they lower interest rates and boom the market.
- 2) Raise interest rates to break the stock market. Then, lower interest rates. As borrowers flock to the window to borrow money at the lower rates, refuse to lend them money as the bankers did in 1929, and act that caused massive foreclosures and sent the stock market hurtling down. Tricky, tricky.

Conclusion

Today's usury system constantly expands the debt. A growing debt causes wild fluctuations in prices. One must deal with the swings. There is no safe place to keep your money. To deal with the wild swings the choices are nied. One can buy:

EQUITY - real estate, gold stocks, coins, common stocks. These are good to keep up with rising prices. Or;

DEBT - bonds (government, municipal, corpoate); for falling prices. Or, if undecided, one can invest in:

CASH - folding money, CD's, T-bills, government money market funds as a reserve so that one can go either to cash or debt once a decision is made. Cash is always temporary, NEVER a permanent investment. Students of economic history know WHAT will happen, they just don't know WHEN. When undecided most invest in all three. They keep common stocks in reduced amounts, and load up on fixed 'come when interest rates are about to unange. After interest rates change and the M1 starts up they load up on common stocks. They also keep a larger cash reserve which can be moved either to fixed or common at the proper time. Usury society manipulations cause prices to swing wildly from one extreme to another. Low prices are temporary. High prices are temporary. But over the years the name of the BIG GAME is high prices. Debt ALWAYS stairsteps upward over the years. Those who invest in IOU's always lose in the long run. Be ready to switch from cash into common stocks and other equity on their signal. Usually, high interest rates, and the M1 begins to rise, stand ready to once more re-enter the stock market in a big way. The next inflation leg could make the value of stocks and real estate skyrocket. We could see the Dow at 10,000 sooner than anyone thinks.

In the meantime keep a balanced portfolio, your eyes open, and be ready to move. The monetary authorities have the power to make your sandwich cost 10ϕ or \$100. This

is the power of life and death. Respect it.

THE "HOLES" IN THE OZONE LAYER

The surface of this planet is covered by dry bits, called "land," and wet bits, called "water." Where these two bodies meet is termed a "beach," which may be sandy, rocky, cliff-face, or any one of many other types. Where these "beaches" occur, there is, to a greater or lesser extent, a certain amount of wave activity called "surf." Imagine you are strolling along a beach somewhere, minding your own business, and enjoying the view, when, out of nowhere, comes a demented, hysterical character who wants to enlist your help in freeing the beach of board-riders, because they are "wearing down the surf." He goes on to earnestly explain that the thin line of "surf" is the only thing "holding back" the ocean, and if the board-riders wear it out enough, the "layer of surf" will become so depleted that it can no longer "hold back" the ocean, and the ocean will flood over all the land and destroy mankind. What would be your reaction to such a person? You'd quite possibly conclude, quite correctly, that such a person should be confined to the local "funny farm" as quickly as possible, wouldn't you?

And yet, this is EXACTLY the kind of logic being used to support the "hole in the Ozone layer" scam. And erstwhile intelligent people are running around with varying versions of this Chicken Little story that the "sky is falling," without ever making even the slightest attempt to find out what is really happening, and why. As with the "greenhouse effect," it is only necessary to understand a few very simple scientific facts, to totally debunk this "scam." First of all, what exactly is the "ozone layer," or "ozone mantle" as it is now being called, which supposedly "protects" us from all that unwanted ultra-violet light? Well, quite simply and bluntly, there ISN'T one!! Just as the "surf" is not a magical barrier to the ocean flooding the lands, and is, in reality, simply an EFFECT of where land and water meet, so too is the so-called "ozone layer" merely an area where an EFFECT can be detected, not a CAUSE.

Let's start with a very basic chemistry lesson, which again can be confirmed with Junior High School text-books. First of all, existing on this planet Earth, and probably elsewhere, is an element called "oxygen." According to my dictionary, oxygen is an element, with the chemical symbol "O." Now, oxygen, for reasons I won't go into here, but which you can readily find out for yourself from aforementioned chemistry textbook, rarely, if ever, exists as the single atom "O." Such a single atom of oxygen, or most other "elements" is called an "ion," and it is very difficult for most substances to exist freely in their "ionic" state. What normally happens is that two



atoms of "O" combine, or "stick" together, and form the molecule "O²", or "oxygen" as you and I know it. This is the stuff you and I and all other living creatures breathe in and expel as "carbon dioxide," or CO² (one carbon atom, two oxygen atoms). In yet another of nature's (he should have said GOD'S!, HR) wonderful balancing acts, green plants "breathe" in the CO², extract the atom of carbon (C) as a building block in their cellular growth, and expel oxugen, or O². This is why it is so important that we stop destroying all the green stuff on the land by overclearing, and stop polluting up the oceans, and thereby killing all the little green plants known as "plankton."

"O2", or two oxygen atoms "stuck together" if you like, is the "normal" or most prevalent form of oxygen in the atmosphere. But it is by no means the only one. If one applies various forms of energy to the O² melecule, it will break down to its ionic state and reform into another configuration, one where THREE, it two, atoms of oxygen "stick together" to form a new molecule. This molecule is called "O³ⁿ, or "Ozone." Now, the "energy" required perform this little trick can come from a variety of sources. An electrical discharge through the air will do it. Unlike "oxygen" which is odourless, "ozone" has a distinct, pungent smell. Pick up your kid's electric train engine, or radio-controlled car, after it has been operating a while, and you will smell this odour. (Any brush motor will produce ozone at the brushes, electric drill, mixers, and so on. HR) The electrical discharge where the brushes rub on the commutator turns a certain amount of "oxygen" (O^2) into "ozone" (O^3) . Electrical storms, or at least the subsequent bolts of lightning, ionize a great deal of the surrounding air, and create a certain amount of "ozone."

By far and away the biggest "source" of energy for the conversion of "oxygen" into "ozone", however, comes from the sun, in the form of ultra-violet light. What happens is a cycle something like this; you and I breathe in oxygen (O2), and breathe out carbon dioxide (CO²). Plants, on the other hand, "breathe in" carbon dioxide and expel oxugen. This cycle is more or less endless. Oxygen (O2), however, is slightly lighter than the other elements which make up the "air" (nitrogen, carbondioxide, and so on), and so a certain proportion of the molecules of oxygen (O2) drift upwards to the outer fringes of that blanket of gases that surround the planet, which we call our atmosphere. From the other direction, light from the sun streams in. A certain amount of this light is absorbed or deflected by various elements, atoms, molecules, and particles of other matter. The bulk of this light from the sun, however, continues its downward journey towards the planet's surface, until it encounters the oxygen (O2) molecules rising up from the surface. At the point where the sunlight reaches a sufficient concentration of O2 molecules, a "reaction" takes place. A certain portion of the light from the sun, that portion known as the "ultra-violet" section, strikes the rising O² molecules, and departs it energy to the oxygen molecule it has struck. This has two effects. First, it greatly reduces the amount of ultra-violet light which would otherwise reach the Earth's surface, because the "ray" or unit, or "beam" of light loses energy and becomes light in the lower spectrums, the ones we call "colours." This is one of the causes of that spectacular light show called the "Southern," or "Northern" Lights. Second, it converts the "oxygen" molecules (O²), into "ozone" molecules (O³).

There is a portion of our atmosphere, from ten to fifty kilometres up, which is called the "ozonosphere." It does not, however, get this name because it contains some magical, mysterious "layer" of matter known as "ozone" which exists, and has existed, from the beginning of time to "protect" us from ultra-violet light, and which is now under "dire threat" from various man-made products. It is called this name because this is the region where the rising O2 molecules are struck by incoming ultra-violet light, and convert to O3 ozone molecules, and it therefore has a higher proportion of O^3 molecules to O^2 molecules. There will continue to be an "ozonosphere", or as it is incorrectly termed, an "ozone layer," for as long as the planet's surface continues to manufacture to rise, and for as long as the sun continues to emit light to encounter that rising oxygen. Just as there will always be "surf", for as long as there are places where "water" meets "land". The mis-named "ozone layer" will continue to simply be the end result of where to opposing forces and systems meet, until such time as one or the other of those forces or systems cease to exist. Just as there will always be "surf," for as long as there is "land" and "water," there will be an "ozonosphere" for as long as there is oxygen and sunlight. If either one of these packs up, we will have long since suffocated, or frozen to death, before we develop skin cancer. As I said, this stuff you can check out for yourself with the simplest of reference books. (Reader's Digest Great Encyclopedic Dictionary says: Ozone; Allotropic form of oxygen with three atoms to the molecule (O3), a pale-blue gas with a peculiarly pungent smell; formed by action of electric discharge or ultra-violet light; used for sterilizing water and purifying air. HR)

Okay. What about the so-called "holes" in the "ozone layer"? Well, as we have seen, there IS no such thing as a magical, mysterious "ozone layer," so there can't be any "holes" in it. There IS however, a region called the "ozonosphere" which normally has a higher incidence of "O³" than "O²" as described. Now, given the chemical/physical explanation of the ozonosphere, as opposed to the "hysterical" version currently being peddled by the



media, it becomes immensely easy to "predict" that there will be two "holes" in said ozonosphere at certain times of the year. As has been demonstrated, the so-called "ozone layer" requires, for its very existence, that oxygen (O²) molecules interact with ultraviolet (sun)light, in order to create "O³" molecules, which can then be measured and referred to as the magical "ozone mantle."

Now, there are two places on the face of the planet where, for a portion of the year, NO ultraviolet light strikes rising O² molecules and therefore, where there can be NO large formation of O³ molecules (ozone). I am referring of course, to the Northern (Arctic) Circle in the Northern Hemisphere winter, and to the Southern (Antarctic) Circle in the Southern Hemisphere winter. The Earth, thankfully, is not positioned exactly perpendicular to the rays of the sun. If it was, the sun would be overhead in the same place all the time, and the tropical regions would just get hotter and hotter, until they became uninhabitable deserts d the polar regions would just keep freezing.

ine bulk of the earth's surface would either be too hot, or too cold, to live in, with only a in region where the two extremes met, capable of supporting life as we know it. Fortunately, this is not the case; the Earth is, in fact, "tilted over" to one side with respect to the sun, and it is this tilt that gives us our "seasons". At the point known in the Northern Hemisphere as the "summer solstice" that is, when the sun is directly "overhead" at the Tropic of Cancer. This is the height of the Northern Hemisphere summer. At this time, NO sunlight is contacting with the atmosphere above the Antarctic Circle, and therefore there simply cannot be any conversion of "O2" into "O³ⁿ. Hence, there is a measurable "hole" in the amount of ozone in the ozonosphere at that time. As the sun's "overhead" position 'adually changes, and the sun "moves" back across the Equator, the amount of sunlight reaching the Antarctic Circle gradually increases, thus giving rise to an increase in the incidence of ultraviolet light striking atmosphere, thus causing the "hole" to "shrink."

As we reach the opposite condition, the "Summer Solstice" for the Southern Hemisphere. This occurs on December 22 each year, when he sun is directly "overhead" at the Tropic of Capricorn. Again, it is now the Arctic Circle which lies completely in the dark, and, surprise surprise, there is a measurable "hole" there in the amount of O³ in the ozonosphere. After the Southern Hemisphere Solstice, the sun begins its journey northwards again, and as we here in Australia slip into our Autumn, the "hole" at the Antarctic Circle starts to "grow" again, and the one at the Arctic Circle starts to "shrink." This is a natural cycle which has existed, and will continue to exist, for as long as the Earth is tilted, the atmosphere contains O² molecules, and ultraviolet light continues to come from the sun to convert them to O³ molecules. There are no laws that puny men can pass to stop the awesome forces and cycles of Nature, (and nature's GOD, HR), as King Canute learned when he attempted to "order" the tides to turn back. "Laws" to attempt to prevent the natural cycle of "holes" in the ozonosphere, fall into the same catagory, and should be treated with equal contempt.

So where did all this nonsense about "holes" in the ozone layer come from, anyway? Well, back in 1985 the British Climatological Team in Antarctica discovered the first "hole". There was a relatively short bout of hysteria, as always, whipped up by a compliant media because the whole thing was in "somebody's" interest; all front page hype and speculation about how half the world's population would be dead from skin cancer by the year 2000, and similar preposterous stuff. If you think back to late '85, early '86, you should be able to remember it all. You should also be able to remember that it had all just died away by late '86 early '87, and you heard nothing more about "holes" in the ozone layer until quite recently. But do you know why? Well, I'll tell you. It all died away because by that time the British scientists at the South Pole had been studying the phenomenon long enough to realize that it was not some hideous, dire threat to mankind's future, but part of a natural, endless, repetitive cycle. This was actually reported in the papers, but naturally enough, not in screaming page one headlines, but buried up on page fifty three or so, somewhere between the comics and the obituaries.

What was ALSO reported at the time was that the scientists, who now knew exactly what they were dealing with, were packing up in Antarctica, and moving camp to the Northern Polar regions to test their own predictions that there would be a similar "hole" there, at the opposite time of the year, thereby proving that the "holes" were not a new threat to the environment and to mankind, but part of a natural cycle. And that, of course, is exactly what they did, and that is exactly what they found of course, such a re-assurance would not suit those who wish us to live our lives in a constant state of near panic, and therefore ever more prepared to hand over control of our lives to some form of "Big Brother," to save us from these imaginary "threats."

And so, rather than the papers correctly reporting that the British team had discovered a second hole above the Arctic Circle, a hole they had already predicted and had gone there specifically to confirm, thereby proving their theory that such phenomena were part of a natural cycle, the papers instead screamed out from their front pages "SECOND HOLE IN OZONE LAYER DISCOVERED; DIRE DOUBLE THREAT TO MANKIND," and other similar hysterical drivel. And now, Maggie Thatcher, the head of government in Britain, the person who was ultimately responsible

for the team that discovered the first "hole," and the person with access to ALL this information, and the person who should be leading the way in debunking this scam, is the person inviting scientists and leaders from all over the world, to formulate "policies," and "agreements," and if necessary, "world laws" to be administered by the United Nations (read the book WHAT IS MYSTERY BABYLON? HR), to tackle this new "threat." And there are STILL people trying to convince me she's one of the "good guys." (I believe Mrs Thatcher is a member of the Bilderberg Group, HR).

Now, don't get me wrong; I'm not in of ANY strange laboratory-created substances polluting the air I have to breathe, and I wholeheartedly endorse the current campaign to rid the atmosphere of chloro-fluorocarbons (CFC's), the atoms being blamed for the so-called "holes" in the ozone layer. Picture in your mind how much CFC is involved, and will find its yay into the atmosphere to somehow (never actually explained) "destroy" ozone (O3). Now picture in your mind a Boeing 747 jet, with its four massive engines. Now imagine that jet hurtling through the sky at hundreds of miles an hour, scooping literally TONS of air into its jet engines, every minute or so. Now, what those engines are doing with that air, is extracting the available oxygen, tons and tons of the stuff, and using it to burn kerosene, thereby using up the oxygen and creating various carbonic gases. And where do these jets fly? Why, predominantly in the ozono-sphere. That's right; the "oxygen" these jets destroy by the ton every minute or so, is not the O² variety you and I breathe, its the O³ variety which SUPPOSEDLY exists as some kind of "protective mantle" and which we must now "save" at all costs, even the sacrifice of democracy and freedom. Every time a jet takes off and flies somewhere, it destroys more ozone than you could even imagine, let alone use, as CFC's, in a lifetime. We're not talking amounts that can even be conceived in

ASSAULT WEAPONS

The official Department of Defense definition of an assault weapon is one that will fire either in the fully automatic mode, or by turning a selector control, will fire in the semi-automatic mode, by which the weapon will discharge one bullet for each press of the trigger. Generally, a weapon, fired in the fully automatic mode is not very accurate. In comprehensive tests, it is the first bullet that leaves a fully automatic weapon that can be, with any assurance, considered accurate. On the other hand, the semi-automatic weapon can be aimed very quickly between trigger squeezes; therefore, it is by far the more deadly weapon. Consequently, when a guerrilla force, or a population in rebellion, is in the field without a large arsenal for the supply of ammunition, the semi-automatic is more effective by a factor of ten.

The Wrath of the Awakened SAXON

It was not part of their blood, It came to them very late With long arrears to make good, When the SAXONS began to hate.
