"WHAT MADE THE PILGRIMS SPECIAL?"

A VERY SMALL REMNANT

Four hundred years ago (1606) a small group of Englishmen were being persecuted for their separation from the corrupt Church of England. Some were executed, some were put in prison, others had their possessions confiscated; others were unfairly taxed — as a result the survivors were forced to flee to Holland in order to worship the God of Abraham, Isaac and Jacob.

Their church, located in Leyden, grew in size to between 400-600 people. Obviously, not many were financially and physically able to travel all the way across the ocean to a new land. And after the Pilgrims had to abandon their second ship—the Speedwell—many aborted their journey to England.

As a consequence, of the 102 passengers on the mayflower—only 41 were Separatists!: 16 men; 11 women; and 14 children. There were more non-separatists (called "strangers" by the Pilgrims) than separatists!

But while all of the Pilgrims survived the over two month ocean journey—almost half of them perished in the winter months after they landed. The Christian heritage of the United States was laid by less than 25 Christians!

THEY WERE STRONG BELIEVERS IN THE LOCAL CHURCH

While the Puritans, another dissenting sect, felt that the Church of England was corrupt and retained too many vestiges from its pre-Reformation connection with the Roman Catholic Church - they sought a middle ground between the church's Catholic traditions and the ideas of the Calvinistic reformers.

But the Pilgrims went further and denied the basic legitimacy of the Church of England. As Shiloh had lost their role as the sanctuary of God in the Old Testament, so had the Church of England in the 1600s.

As a result, the Pilgrim/Separatists believed that they were carrying the mantle of the New Covenant church. They strongly "believed that the ONLY biblically sanctioned organization between men and God was the congregation through which chosen or pre-destined individuals entered into covenants with their creator" (Jurt Kortenhof, *The History Channel Magazine*, "Saints & Sinners," p.30)

And as ancient Israel had journeyed to the Promised Land with a mixed-multitude—so did these Israelites of the 1600s journey to their promised land (of Joseph) with "strangers." They came to establish a local church. They came "to advance the Christian faith."

THEY PERSEVERED

While many of the "strangers" left Plymouth Plantation

within five years—some back to England; others southward to virginia, one (John Bilington) to execution for murder, NONE of the Pilgrims left. Through the great drought, illnesses, cold, starvation times, deaths, dangers, disappointments, aggravations—they did not give up.

Soon other Pilgrims arrived. many families were rejoined by other members who had not made the original Journey. And when the Church of England began to persecute the Puritans, the great migration of Puritans (over 20,000) in ten years solidified the Massachusetts colony.

THEY READ AND STUDIED THEIR BIBLES

The Pilgrims had the self-discipline to read and study their Bibles. Thus, they honored the Sabbath day. They worked hard and long for six days—but congregated at the "meeting house" for worship, singing, praising and preaching on Sundays.

They hated the Roman holidays of Christmas and Easter so much that they made those days mandatory work days (unless they fell on a Sunday). They also forbad any gatherings or feasts on these days.

They dressed modestly. They prayed constantly. They sought repentance and forgiveness amongst each other. They loved and cared for each other.

They abhorred evil. They would be aghast if they could see what America has now become with its drunkenness, aborticide, sexual promiscuity, rock 'n' roll music, fascination with witchcraft and wizards (Harry Potter), drugs, laziness, preoccupation with sports and the desecration of the Sabbath day.

THE IMPORTANCE OF PH BALANCE

THE WAR AGAINST OUR BODIES

Each of us is at war and we don't even know it! The private war we each wage is a daily assault on our body by bacteria, virus, fungus, yeasts, and moulds. We have entered what might be referred to as critical mass when it comes to this bacterial warfare onslaught being waged against us by stronger and stronger killer bugs and bad bacteria. Our immune systems are becoming weaker and over-taxed in this war. Even the medical profession's first line of defense (the antibiotic) is becoming less and less effective against resistant new strains being created daily as the bacteria mutate. Since Louis Pasteur discovered the germ theory of disease that states germs are the cause of disease, time has proven him correct. But note Dr. Pasteur's dying words: "The germ is nothing, the inner terrain is everything."

The inner terrain referred to in Dr Pasteur's statement is now being called our biological terrain and comprises our body's digestive tract, lymph system, blood, urinary tract, interstitial and interstitial fluids. Our bodies are alkaline by design and acid by function. maintaining proper alkalinity is essential for life, health, and vitality. Simply put - an imbalance of alkalinity creates a condition favourable to the growth of bacteria, yeast and other unwanted organisms. All leading biochemists and medical physiologists have recognized pH (or the acid-alkaline balance) as the most important aspect of a balanced and healthy body.

They have long known that the maintenance of an alkaline pH in our tissues and cells is critical to cellular health. In contrast, our digestive tract (except for our normally alkaline mouth) has varying degrees of acid by design, and our urinary tract should be slightly acidic for healthy function.

We live and die at the cellular level. All cells (billions of them) that make up the human body are slightly alkaline,

and must maintain alkalinity in order to function and remain healthy and alive. However their cellular activity creates acid and this acid is what gives the cell energy and function. As each alkaline cell performs its task of respiration, it secretes metabolic wastes, and these end products of cellular metabolism are acid in nature. Although these wastes are used for energy and function, they must not be allowed to build up.

One example of this is the often painful lactic acid which is created through exercise. The body will go to great lengths to neutralize and detoxify these acids before they act as poisons in and around the cell, ultimately changing the environment of the cell. Most people and clinical practitioners believe the immune system is the body's first line of defense, but in actuality it is not. It is very important, but more like a very sophisticated clean-up service. We must instead look at the importance of pH balance as the first and major line of defense against sickness and disease and for health and vitality.

WHAT IS KILLING US?

If we were to ask "What is killing us?", the answer might be "ACIDOSIS"! It has been demonstrated that an acidic, anaerobic (lacking oxygen) body environment encourages the breeding of fungus, mold, bacteria, and viruses. Let's look at an example. If we were to seal the door to our freezer and then unplug it, come back and open the door in two weeks, what would we find? Mold, bacteria, microscopic bugs. Things will be growing and multiplying. Where did they all come from? They did not sneak in - remember the door was sealed.

The answer is "they were always there." It is simply that the environment changed to

a more inviting and healthy one for the "critters" to live in. This can be likened to a shift in our biological terrain from a healthy oxygenated, alkaline environment to an unhealthy anaerobic acidic environment. You see what is healthy for us is unhealthy for the body attackers and what is healthy for them is what is unhealthy for our body.

A state of acidosis is simply the lack of oxygen and available calcium which the body uses to maintain its alkaline balance. Calcium makes up 1.6% of our body weight. It is literally the human glue that holds the body together. Calcium is so biochemically active that it has been likened to an octopus. A calcium ion can hold onto seven other molecules while it grabs onto one molecule of water. No other ion can do this. And it is the right size to easily get in and out of the human cell. As it does this, it takes a chain of nutrients into the cell and then leaves to get more nutrients.

THE BIGGEST PROBLEM

The biggest problem scientists have found is that over time the human body becomes depleted of calcium. A compound called mono-ortho-calcium phosphate is the chemical buffer for the blood. This buffer maintains the alkaline level (or the lack of acidity) in your blood. Without it you would die. If the acidity level of your blood changes even slightly you die immediately. But in order to supply enough calcium for buffering we must have enough calcium being absorbed from our diet or our body will simply rob the needed calcium from our bones and teeth. The more acidic we become, the harder it is for oxygen to be present, so our biological terrain also becomes more anaerobic. Without adequate oxygen, unfriendly bacteria, viruses, molds, and

fungus can live and prosper. Then our cells cannot carry on their life-giving functions in a very efficient manner because our biological chemical reactions need oxygen.

Life and death are in the biological terrain and the battle cry here is to reclaim your biological terrain. This is so important that some practitioners working with the inner biological terrain and its implications to the health of our bodies are beginning to say "There are no specific diseases, only specific disease conditions, and there is only one disease. And that one disease is acidosis."

The human body is very intelligent. As we become more and more acidic the body starts to set up defense mechanisms to keep the damaging acid from entering our vital organs. It is known that acid gets stored in fat cells. After all, if the acid does come into contact with an organ the acid has a chance to eat holes in the tissue. This may cause the cells to mutate. The oxygen level drops in this acidic environment and calcium begins to be depleted. So as a defense mechanism, your body may actually make fat to protect you from your overly-acidic self. Those fat cells and cellulite deposits may actually be packing up the acid and trying to keep it a safe distance from your organs. The fat may be saving your vital organs from damage. Many people have found that a return to a healthy inner biological terrain helps them to lose excess fat.

Osteoporosis is very confusing for many people. Most people think they can eliminate it by increasing their consumption of milk and dairy products. But in the countries where the consumption of dairy products is very low the instances of osteoporosis are very rare.

Osteoporosis is an acidosis problem. As the body becomes more acidic, to protect against the event of heart attack, stroke, illness, or even cancer, the body attempts to remain healthy. So, it steals calcium from the bones, teeth, and tissue. As bone mass becomes depleted, this is what we call osteoporosis. As we saturate the body with calcium this brings the alkaline pH up and drops the acid levels down.

One of the warning signs of an acidic biological terrain is calcium deposits. A little known fact is that there has never been a scientifically proven association between calcium deposits in the body and nutritional calcium. In fact quite the opposite is found in the results of testing calcium deposits of the body. Calcium deposits come not from dietary calcium but from structural calcium of our bones and teeth!

So if calcium deposits are forming, we know our inner biological terrain is too acidic. Our dietary intake of calcium is not keeping up with the calcium buffering needed and we are actively pulling calcium from our bones and teeth. It all works like a little train, from the bones to the fluids and cells, to the blood. As our biological terrain becomes acidic, our pH level drops. When this happens we start losing calcium out of the blood, the bones, and the tissues. This is a safety mechanism. Now tired and fatigued, allowing fungus, mold, parasites, bad bacteria, and viral infections to flourish and gain a hold throughout the body. It is interesting to note that you often won't have just some of these invaders. If you have Candida you will likely have bad bacteria, fungus, and parasites because they all flourish in the same terrain.

We must get in there and cleanse the body to get it under control. After it is under control, we have to support the body nutritionally to build new cells. We are in an era of malnutrition because the minerals aren't in the soil and they can't possibly get into our food chain. What we have is lots of food but very little nutrient value in it. I've heard experts

comment "if you don't want to take supplements, you haven't got a chance." The quality of the supplements you decide to take will make all the difference in the world because not all supplements are created equal.

Calcium is the one mineral that can really alkalize your body. It produces the calcium buffering compound Mono-ortho-calcium phosphate which raises your pH (makes your biological terrain more alkaline). There are many ways to keep your body's biological terrain at a healthy alkaline environment.

These include:

- Eating alkalizing foods including lots of green foods and super foods.

- Limiting our intake of phosphates which bind to calcium and prevent its absorption. Dietary phosphates are commonly found in all carbonated drinks, and in all animal protein.

- Adding dietary calcium in the form of supplementation is generally difficult because of our body's inability to absorb and assimilate most forms of commonly available calcium. The best calcium supplement, which is 95% absorbable by the human body is ionic coral calcium.

This all takes time. It is not easy to reverse acidity once we become too acidic. The extreme importance of cellular environment has been mostly overlooked in the past, but has recently been recognized.

Scientists who describe the environment of our cells measure three conditions of certain body fluids - in blood, saliva, and urine:

1. Antioxidant power
2. pH - Acid or Alkaline
3. Electric conductivity

The report that describes the overall environment of your cells based on those measurements, is called your Biological Terrain. The instrument used to test the body fluids if named the Biological Terrain Analyzer. Scientists have found that when the biological terrain is out of the narrow healthy range, the cells can not perform properly and a person is at a higher risk of contracting a wide spectrum of acute and chronic diseases as well as experiencing physical deterioration and more rapid ageing.

During this century, despite many technological advances in our society, we have seen many threatening declines. One of the most obvious and dangerous is the nature of food consumption. Food consumption in our most advanced countries has changed from nutritious raw foods to highly processed foods low in nutritional value. UNDERSTANDING pH LEVEL AND WHY MANY PEOPLE HAVE DISEASE, INCLUDING CANCER

According to the research of Dr. Enderlein, total healing of chronic illness only takes place when and if the blood is restored to a normal, slightly alkaline pH. In case you missed it, let me say it again.....

Total healing of chronic illness only takes place when and if the blood is restored to a normal, slightly alkaline pH.

pH: What does it mean?

pH is the abbreviation for potential hydrogen. The pH of any solution is the measure of its hydrogen-ion concen-

tration. The higher the pH reading, the more alkaline and oxygen-rich the fluid is. The lower the pH reading, the more acidic and oxygen-deprived the fluid is. The pH range is from 0 to 14, with 7.0 being neutral. Anything above 7.0 is alkaline, anything below 7.0 is considered acidic.

The pH scale is from 0 — 14

Human blood stays in a very narrow pH range right around 9.35 - 7.45. Below or above this range means symptoms and disease. If blood pH moves to much below 6.8 or above 7.8, cells stop functioning and the patient dies. **The ideal pH for blood is 7.4.**

A healthy blood pH without has acid + alkaline balance almost equal. Actually a healthy body is slightly alkaline measuring approximately 7.4. This ideal blood 7.4 pH measurement means it is just slightly more alkaline than acid.

An acidic pH can occur from an acid forming diet, emotional stress, toxic overload, and/or immune reactions or any process that deprives the cells of oxygen and other nutrients. The body will try to compensate for acidic pH by using alkaline minerals. If the diet does not contain enough minerals to compensate, a build-up of acids in the cells will occur.

There are two factors that are ALWAYS present with cancer no matter what else may be present. Those two factors are Acid pH and Lack of oxygen. Can we manipulate those two factors that always have to be present for cancer to develop and by doing so will that help reverse the cancer/ If so, we need to learn how to manipulate those two factors.

Cancer needs an acid and low oxygen environment to survive and flourish within. Terminal cancer patients are around 1000 times more acidic than normal healthy people. The vast majority of terminal cancer patients possess a very low body pH. Why?

In the absence of oxygen, glucose undergoes fermentation to lactic acid. This causes the pH of the cell to drop from between 7.3 to 7.2 down to 7 and later to 6.5 in more advanced stages of cancer and in metastases the pH drops to 6.0 and even 5.7 or lower. Our bodies simply can not fight disease if our body pH is not properly balanced.

The normal human cell has a lot of molecular oxygen and a slightly alkaline pH. The cancer cell has an acid pH and lack of oxygen. Cancer cells cannot survive in an oxygen-rich environment. At a pH slightly above 7.4 cancer cells become dormant and at pH 8.5 cancer cells will die while healthy cells will live. Again, the higher the pH reading, the more alkaline and oxygen-rich the fluid is. Cancer and all diseases hate oxygen/pH balance. The proper alkalinity pH of the blood (7.35—7.45) is critical for the overall health of the body. In other words . . . alkaline or die!

Remember the pH number is an exponent number of 10; therefore, a small difference in pH translates to a big difference in the number of oxygen or OH-ions. A difference of 1 in a pH value means ten times the difference in the number of OH-ions, a difference of 2 means one hundred times the difference in the number of OH-ions. In other words, blood with a pH value of 7.45 contains 64.9% more oxygen than blood with a pH value of 7.30.

The reason acidosis more common in our society is

One of the best things we can do to correct an overly acid body is to clean up the diet and life-style.

A Recipe for Granola Cereal

INGREDIENTS

- 9 Cups of organic raw oats

But throughout history, elimination of criminal behaviour or sins unto death have been a survival mechanism sanctioned by God for our society to live in peace. The Law is written in our hearts. We know what is right or wrong, and it’s written in our minds to understand when the law is in effect, or when it’s time to execute the law.

The conflict arises between two standards of law: man’s and God’s. When we don’t live under and obey God’s Law, we are under punishment for not doing so. We pay the price, as a society, being subject to the authority of man playing god.

As Christians, we know that we can only be servants to one form of government; i.e. the Kingdom of Heaven. Thy Will be done - Thy rule exists. The question I’ve asked, which few can give a straight answer to, is: Can we, or should we, take the Law (God’s) into our own hands? Can we say that we have jurisdiction to kill, when it’s a matter of self-defense? Some idiots actually say no, we don’t have that right. THE CROWN

Except for a few hard military types, I don’t know anyone that wants to go to war. Historically war is the most ruinous and uncivilized thing people can do. So why have there been so many wars? Why is the United States at war when so many citizens are absolutely opposed to the idea? There was no valid reason for our invasion of Iraq, though reasons were created and propagandized.

There is one explanation for today’s insanity, and only one—powerful interests have an agenda that includes wars and rumors of wars, and these power brokers have the means to keep populations emotionally and economically unstable so that common sense is uncommon. The people are presently in a confined state and beneath their noses ongoing violence has numbed the senses. Some elitists, and many “conspiracy nuts” are calling this “the new world order?”

The following is a simple and very generalized history of world events leading up to today’s apparently insane policies and war actions. You are invited to read into it what you wish.

The “modern” world of our so-called Western Civilization began at the end of the 17th century with the blossoming of the British Empire. The underpinnings of that empire actually began several hundred years earlier with the establishment of the *City of London*, which is now an 800-year old *corporation* that controls finance and philosophy for an entity called the *Crown*. This entity is the creator and controller of “central banks.”

The *Crown* has never been the King or Queen of England since the establishment of this corporate body. The Crown is the directorate of the corporation. An outline of this cabal is presented at tomvalentine.com.

Western colonization of the Americas, India and Africa is widely taught in school history courses, so it need not be repeated here. One key aspect of the colonial period is generally omitted or skimmed over from the more basic history courses. This is the fact that the all the crown colonies were established on a corporate model with financial ties to the City of London—not the nation of England or Britain. The Dutch used a similar corporate model with their colonies, but France, Spain and Portugal colonized in the name of their monarchs and the church.

The directorate of the *Crown*, whoever they were, had no loyalty to any nation—they were, and are, devoted entirely to their philosophy which seeks absolute power over an Earthly realm. For more than 250 years, the denizens of the Crown brought untold wealth back from the colonies to the British Isles—for themselves—note: the population of the United Kingdom (British, English, Scottish, Irish, Welsh peoples) received very little wealth even though they provided the tax base and cannon fodder.

The people were invaluable assets of the *Crown*, but they knew not what they served—and still don’t. No people are more hopelessly enslaved than those who false think they are free (Goethe) - [Australia today?!?!]

A unifying philosophy from Masonry allowed these banking and merchant princes to cobble together a world cabal of finance—severing themselves from all national loyalties long ago.

If, for example, one reads the history of the Rothschilds (see the **video CI-219** in black & white) one can readily see how the game of high finance works on a worldwide basis. Incidentally, the Rothschilds kept control within their family while dominating Europe. They were never part of the crown though they served the high cabal very well. The Rothschilds were allowed to amass immense wealth, without ever becoming insiders.

Another well-known family name that was set up by the *Crown* without being given a place among the directorate was Rockefeller. But this is incidental information, and we get ahead of the story. Suffice it to say that the *Crown* may carefully cultivate those whom they make rich and powerful so long as it serves to conceal their identity and promote the cabal’s goals.

If one wants to know the genuine motives for particular actions in history they are told to “follow the money.” But that is only half of it—one must also follow the philosophy—the religious beliefs of those in control.

For purposes of clarity, let the *Crown* always refer to a stealthy circle of power brokers who all believe in the Masonic philosophy—the brotherhood of man ruled by philosopher kings (or adepts) in league with Lucifer, the god of masonry. One need only wade through the cumbersome histories of Masonry and also read Albert Pike’s

MORALS AND DOGMA to see precisely that this anti-Christian power-philosophy encompasses virtually all the other religious notions ever conjured up by man.

Ordinary members of Masonic lodges, your relatives and mine, are to these adepts and their goals what the people of the United Kingdom and United States ate to the directors of the **Crown**—useful fools; masses of asses! A dissertation on Masonry and history will be forthcoming in another work, but my purpose here is to outline the imperialism that brought us this insanity of present day geopolitics.

There have been many key turning points of history, and historians love to dwell on the personalities of leading people when outlining what happened. The people are important, surely, but events would have reached our level of insanity even if different people were in the roles played by the likes of Napoleon, Bismarck, Marx, Lenin, Lincoln, Washington, Wilson, FDR, et al. Since human nature is unchanging, the key turning points of history are always technical in nature.

Thus, the key to modern history, virtually everyone must agree, was the “industrial revolution” and all the **technology of energy production** that so changed the structure of man’s life on earth—without changing him.

Therefore the key to our present geopolitical dilemmas lies in the most profitable and prolific basic sources of energy—oil and natural gas and nuclear power. When the emotional anti-war demonstrators shout that today’s savage war in the Middle East is all about “oil.” He or she tells the part of the truth without really uncovering the awful truth that is devouring us all.

On the other hand, when the informed sophisticate argues that the real reason for today’s mess in the Middle East is obviously Israel—this person, too, is touching part of the truth, yet is missing the boat.

Interestingly in the United States today very few pundits dare to suggest Israel is at the crux of the war issues though it is quite obvious. Israel is untouchable in the US and UK—why? The ultimate and bitter truth is that Israel is a Crown colony whose purpose is two-fold—to prepare the way for the adept’s philosophy of One World, One Bank, One False God, and to serve as the **Crown’s** wedge in the oil rich Middle East.

The third underlying reason for the **Crown’s** projected world war against Islam is simply “usury.” Islam abhors usury and Central Banks exist for it—this basic conflict is seldom mentioned by media pundits today.

Suffice it to say now that the **Crown’s** philosophy is anti-Christ, and it certainly shows up in the way Christianity is treated in the mainstream media. Incidentally, the major media are controlled by the Crown through interlocking directorates, thus the media always serves their purposes rather than the truth.

It is impossible for me to name individuals from within the directorate of the Crown with any certainty because they strive for anonymity, but their names are not important since we can easily analyze their deeds from the events of known history. It is by their fruits that we judge them.

Any conspiracy nut worth his salt will tell you that “they” financed Lenin and Trotsky and Hitler in our modern era. This, of course, refers to the “immaculate they” which is the all-encompassing pronoun used to describe some high cabal—such as our very real **Crown** from the City of London.

In another paper I summarize the philosophical side of

this massive conspiracy so that the events we use to illustrate it here make even more perfect sense. At this point we stay with economic manipulation, the companion of religious manipulation. Today’s confused geopolitical mess began in the 1880s and picked up steam after the turn of the 20th century.

The **Crown** had worn out the taxpaying base of the British Isles in maintaining the Empire, especially after costly wars in the “Raj” which is how they referred to India, and in South Africa at the turn of the century, so they simply adopted or usurped the masses of the United States by manipulating the US to take over the forefront of their imperialism.

World War One marked the transition from London to New York, so to speak. Incidentally, the actual home base for **Crown** operations isn’t really important in such a worldly scheme. Philosophically, Jerusalem is the most important location of these long-range planners. Let’s cover this particular road to One World Empire, step by step.

Britannia ruled the waves for more than 200 years, and established the Crown as the premier world power (and lending institution). Then it became apparent to the **Crown** very early in the oil-patch game that “black gold” was going to rule the world’s economy—they correctly deduced that nothing else would be as dominant in the mechanical world as fuel for the machines. Energy had become the most important facet of international economy. Up until oil became king, control of the oceans was the key. While the rest of the world thought in terms of coal-fired steam engines that dominated the first half of the 19th century, the **Crown** with its tremendous

resources and control over academic and technical institutions knew that petroleum oozing out of the ground would very soon dominate the endeavours of mankind. Until nuclear energy came along, oil was the cheapest, most abundant source of energy with a favourable energy-in/energy-out ratio.

Oh, so quietly, the **Crown** went to work behind the scenes to carefully manipulate control over the world’s use of oil. It did not matter which personalities were discovering and drilling for oil; nor did it matter which individuals or companies would come along to distribute and market the oil—the Crown would be the power behind the financing. This neat trick of sitting behind the scenes and merely supplying the life-blood of credit for every new development had become second nature to these mercantilists from the dawn of shipping, trade and insurance.

The early merchant kings had honed their skills going back to the days of trade routes across Asia, so they easily controlled steamships and railroads at the dawning of the industrial revolution. Besides, the **Crown** also had a long-time controlling hand in all the stock exchanges worldwide. They automatically controlled anything and everything that could be called “capital intensive” because they ruled the capital.

For example, John D. Rockefeller had to get a lot of financing to establish his early “capital intensive” Standard Oil monopoly; The Nobel family of Sweden developed the world’s first major oil field at Baku in Azerbaijan on the Caspian Sea but the Crown soon took over control.

Just as petroleum blossomed into black gold with the advent of Henry Ford’s auto manufacturing assembly line after 1903, the **Crown** realized the British Empire was on the wane. Competition from Germany was serious, Russia

had always been seen as a threat, and the United States had survived the civil war (War Between the States!), which the *Crown* had helped to instigate. The Ottoman Empire was also on the wane, while it appeared that huge amounts of oil lie buried beneath Muslim dominated Middle Eastern sands.

(One little aside here: history remarks on how Henry Ford saw the danger of financial cabal and battled against the *Crown* his entire life. In bitterness, Ford blamed the “Jews” which illustrates how clever the *Crown* really is at establishing false flags and scapegoats. Yes, there have always been Jews on the Directorate, and masonry is very much a Talmudic philosophy, but those ordinary folk who call themselves ethnic Jews are also unwitting cannon fodder. The phenomenon of “anti-Semitism” or hating a Jew simply because he is a Jew serves the *Crown’s* manipulations well. For example, note how the “holocaust” was used to forge modern Israel!

You can only imagine how difficult it is to manipulate an entire world population of stubborn and irrepressible human beings to bring about total dominance of all trade, all war, all commerce, and all money. It wasn’t easy, but they have done it—their New World Order (not ours) is virtually here, and one of these days expect the announcement.

In the early decade of the 1900s, if the *Crown* were to maintain its worldwide power in the face of seething nationalistic populations, all with strong desires of their own, it had to act boldly.

So, at the turn of the century, not only did they cleverly enlist the United States in aggressive steps towards Imperialism by fostering the Spanish-American war, they also took South Africa away from the Boers, and arranged for the Japanese to have a very strong modern navy in order to keep Russia out of the Pacific. After all, the *Crown* had long prevented Russia from getting a seaport in any warm waters to the south and west, and there was no need to acquiesce to the Pacific. The Japanese naval defeat of the Russians in 1902 did the trick neatly, and the *Crown* directors smiled silently as the Russian bear remained landlocked.

There is nothing in the above recitation of history that is not well known—except, perhaps, the central role of the *Crown*. Historians insist upon calling it the “British” Empire, but the people of Britain had absolutely nothing to do with it. The “Commonwealth” is an interesting term for nations who are tied directly to the *Crown*. All the millions of subjects (not citizens) in the Commonwealth have no say, nor anything to do with the Empire, except to play the same pretend politics we play in the US today and provide able bodies for the military and some tax dollars.

World War One was one of the *Crown’s* finest hours, so to speak. Think about some of these facts:

1. Nobody can explain how the war came about, especially at that particular time in Europe. The famous assassination of Archduke Ferdinand was truly insignificant, but thanks to many “treaties” serving silent manipulations of the *Crown* a number of nations declared war against Germany while Germany declared none.

2. The fighting in Europe was utterly insane, to the point of the French army going on strike as millions of men died for no reason in trench warfare. The US population wanted nothing to do with Europe’s war, but dirty trick politics manipulated Americans into the fray. The sinking of the Lusitania comes to mind. American forces engaged in

actual fighting for only a few months.

3. The trench warfare ended in stalemate with no clear winner, but at the Treaty of Versailles, the *Crown* used American President Woodrow Wilson and manipulated the terms as if Britain had won—thereby setting the stage for Adolf Hitler and WWII.

4. Egypt, and the vital waterway called Suez, was essentially a *Crown* colony at the outset of WWI, and when the shooting stopped in the Middle East, Britain and France were directed to parcel out the entire region by the *Crown*. Two of the parcels became nations of keen interest to us today—Iraq and Israel.

5. Lord Balfour instigated the establishment of modern Israel with a mere “declaration.” This gave a green light to the “Zionist” movement that had grown more prominent after 1897 when Theodore Herzl wrote *The Jewish State*. Who directed Lord Balfour? Despite all the terrorism and posturing that made it appear the British were dragging their feet in helping Israel get established, it turns out that Israel is a de facto *Crown* colony to this day—attached at the hip with the *Crown’s* main mercenary, the United States. That was the best trick of all.

6. Iraq was cobbled together from various tribal groups in Mesopotamia after the British occupied Baghdad in 1917. In 1921, after considerable strife, the *Crown* manipulated the selection of an Arab Hashemite (Faisal) as Iraq’s first “elected” ruler. Then the *Crown* was ostensibly kicked out of Mesopotamia when the Baath Party came to power much later. The socialist Baathists were formed in 1947 ostensibly attempting to decide religious archeology directions as well as what should be done in the wake of the fall of the Ottoman Turks.

The hidden hand of the *Crown* tried to pull all the strings of this fiasco, but many Arab leaders had become aware of the high cabal behind the political powers of the west. The Muslim leaders saw Israel as a colony establishing a foothold in the Levant. The *Crown* knew that Islam would vow to resist Israel for more than religious reasons alone. This historic “tension” could be used to great advantage by the manipulative *Crown*.

Establishing control of the blossoming world of oil export was only half of the goal of the *Crown* in these machinations following both WWI and WWII. These two world wars were actually all one manipulated global-changing activity. To fully understand where we are going, we need to delve into a little modern history of Institutional Churchianity because it is the combination of Jewish Zionist and Churchist Zionist belief systems that provided the political base for America’s unfettered support of modern Israel.

I distinguish Churchists and Christians for obvious reasons—no Christian thinks modern Israel has any scriptural connection whatsoever. In a nutshell, Christ, on the cross and resurrected, fulfilled the Old Testament and accredited the New. The Roman destruction of the Temple in Jerusalem, where God had chosen to relate to humans in the old order, marked the dawning of the Kingdom promised by Christ—a spiritual kingdom sustained entirely by individual belief, conviction and obedience [Valentine has no understanding of Anglo-Saxon-Israel, and the EXCLUSIVENESS of the same as God’s Chosen People, CIM]

worked into the mix early on. This led to some very unchristian behaviour resulting in wars between churches over centuries of time back when man lived without electricity and technological wonders. Regardless, Christians believed Jesus Christ completed His Father's work. The Jews have always vehemently denied it, generating an implacable wall.

Along came the millennial revolution. This was a revolution that changed Christianity as thoroughly as the industrial revolution had changed man's ways of life—ironically, the two unrelated revolutions grew together in the 1800s. Secular history taught in schools deliberately ignores the millennial revolution for what it really is, but one need only read an excellent book: *Death of the Church Victorious*, by Ovid Need Jr. to get the entire well-documented story.

The so-called Brethren movement actually caught on more in the United States than it did in its native UK. The US fervor for evangelism was made to order for the *Crown*, and they took full advantage of it. An itinerant American lawyer names Cyrus Scofield obtained backing for the Scofield Teaching Bible from some very interesting sources. In the US it was Arno C. Gaebelin, a Zionist who published a periodical *Our Hope*, in 1894. Gaebelin, a “converted” Jew proclaimed the imminent but non-scriptural “Second Coming” of Christ and alerted gentiles to the remarkable Zionist awakening among the Jews of Europe.

Curiously, the Scofield Teaching Bible was first published by Oxford in England thanks to a financial angel named Untermyer (with known connections to the *Crown*). Oxford is hardly a religious publisher, so it was out of character for this highly connected institution to publish a “Bible.”

Though few among believers know what the words mean, Millennialism and dispensationalism are very popular today, but they are Anti-Christ while pretending to be Christian. These non-scriptural doctrines actually make the advent of Jesus Christ of non-effect, and virtually “Judaize” Christianity—and hardly any churchist today sees this.

So, as Christianity came into the radio, and eventually the television age, the predominant point of view was and is anti-Christ Scofieldism, carefully cultivated by powerful forces behind the scenes. BLESSED IS THE NATION WHOSE GOD IS THE LORD

The title of this message is taken from Psalm 33, verse 12 which reads in total: “*Blessed is the nation whose God is the Lord; and the people whom He hath chosen for His own inheritance.*” Over the years I have found this Psalm to be of great comfort and information, [teach your children to sing the Psalms! CIM] and I would recommend that you read all twenty-two verses. You will note that not only is the nation blessed, but also the people whom our Heavenly Father has chosen for His own inheritance. Just who are these people that have been chosen to be God's inheritance? We know that our God is a discriminating Deity, so the contentions of most churches within the framework of Christianity must therefore be in error. It is not ALL peoples and ALL nations which fit the criteria of the Scriptures.

In Numbers 6:27, we see our heavenly Father instructing Moses, “*And they shall put my name upon the children of Israel; and I will bless them.*” It doesn't say that Moses



was to put His Name on all of the peoples of the world, and that God would bless all of the peoples of the world. His Name, and the blessings were to be given to the CHILDREN OF ISRAEL, and to them only! The efforts of “churchianity” to both give and apply these Divine blessings, assigned to Israel, to all peoples is a direct affront to our God. It is based upon materialistic traditions which have been adopted and inculcated into a skewed and biased version of so-called Christianity by the Roman Church and the Protestant denominations over the past many centuries. It is a form of Christianity based upon man’s interpretation rather than that brought by our Saviour Jesus Christ.

As Paul stated in Acts 13:17, “The God of this people of Israel chose our fathers and exalted the people when they dwelt as strangers in the land of Egypt...” In addition, we refer to the words of our Saviour Jesus Christ as found in John 15:16, “Ye have not chosen me, but I have chosen you...” Despite what the church may claim, that the blessings and promises given to Israel have been transferred to the church, there is nothing in Holy Writ to substantiate such a false claim. Paul in Acts 5:31 states, “Him hath God exalted with his right hand to be a Prince and a Saviour, for to give repentance to Israel, and forgiveness of sins.”

Further, we find in Jeremiah 31:1, the words of our God, “At the same time, saith the Lord, will I be the God of all the families of Israel, and they shall be my people.” Throughout the entire Bible, there is reference after reference with regard to our God, the Almighty of Scripture, being the God of Israel, and the people of Israel being his chosen and selected. This does not refer to the non-Israelite Jews, the Moslems, the Orientals,, the darker races, the Eskimos, etc! It is a very restrictive and specific people - the Israelites.

Most theologians are aware of the so-called “lost ten

In James 1:1, we read, “James, a servant of God and of the Lord Jesus Christ, to the twelve tribes which are scattered abroad, greeting.” Likewise, in 1 Peter 1:1, we read, “Peter, an apostle of Jesus Christ, to the strangers [geyr] scattered throughout Pontus, Galatia, Cappadocia, Asia, and Bithynia.” The Jewish historian Flavius Josephus, wrote in **The Antiquities of the Jews**, [#535 @ \$28.00] chapter 5, Section 2, “Wherefore there are but two tribes in Asia and Europe subject to the Romans, while the ten tribes are beyond Euphrates till now, and are an immense multitude and not to be estimated by numbers.” Obviously James,

Peter, and Josephus, contemporaries of the times, were aware of the location of the Israelites and their streaming through Asia Minor and into Europe. And, where did we originally come from? From Europe! [see **Heirs Of The Promise - CI-001** @ \$15]

The original settlers to this nation came seeking **religious freedom**. The risks, challenges, and dangers that they faced were accepted so that they could have the freedom to worship the God of Israel. How far have we fallen and deteriorated from that point. We now accept and tolerate and even worship all manner of false gods. Our Father, the God of Israel, however is a jealous God and we wonder how much more blasphemy He will accept before retribution takes place.

Our civil leaders and our clergy are either ignorant to who we are, or disregard this truth to profit from their materialistic desires. MORE DECEPTION FROM THE WAR CRIMINAL

Bush's State of the Union address did not describe the deplorable State of the Union. The speech's importance consists of Bush's plea to Congress to please let him fool them one more time in order that he can attack Iran and start a bigger war that Congress will have to support in order to support Israel(i). That is all the president had to say.

The "surge" of US troops for Iraq is another deception. The surge's purpose has nothing to do with achieving victory in Iraq. Its purpose is to counter the pressure from the American public, Congress, and the US military to withdraw US troops from Iraq. Once a withdrawal begins, the neoconservative misadventure in the Middle East is at an end before its goals can be achieved. Delaying the withdrawal by proposing an escalation and provoking a debate gives Bush and Israel(i) time to orchestrate an attack on Iran.

No one in Congress or print and TV media is prepared to call Bush on this transparent deception. Instead, critics focus on the fact that the surge cannot succeed. For example, in the Democratic response to Bush's address, Senator

Jim Webb, who served as Secretary of the Navy under President Reagan, stressed the recklessness and cost of Bush's invasion of Iraq: "The President took us into this war recklessly. He disregarded warnings from the national security adviser during the first Gulf War, the chief of staff of the army, two former commanding generals of the Central Command, whose jurisdiction includes Iraq, the director of operations on the Joint Chiefs of Staff, and many, many others with great integrity and long experience in national security affairs. We are now, as a nation, held hostage to the predictable and predicted disarray that has followed."

Consequently, while Congress wastes time with non-binding resolutions against the surge in Iraq, Bush proceeds to implement plans to start war with Iran.

I have said that the only hope of stopping Bush from initiating war with Iran is for the leadership of both parties in both houses of Congress to make unequivocally clear that Bush will be impeached if he attacks Iran without the approval of Congress. Even this might not be enough. The Bush Regime is capable of orchestrating an incident, such as an attack on a US aircraft carrier, that can be blamed on Iran and, in that way, sweep Congress along on a patriotic outburst against "Iranian aggression against US forces."

Many of the people who have come to oppose Bush's war in Iraq mistakenly believe that Bush is a good person who is trying to protect America, but that he is going about it in the wrong way and is too inflexible to learn from his mistakes. They have no clue as to the evil agenda that guides the Bush Regime.

The Bush Regime is the first neoconservative regime in US history. Bush hides the neoconservative agenda behind "the war on terror," which essentially is a hoax. The

main purpose of the neoconservatives' "war on terror" is to eliminate any effective Muslim opposition to Israel(i)'s theft of Palestine and the Golan Heights. To silence Muslim opposition to Israel(i)'s theft of Arab lands, the US must eliminate or intimidate Middle Eastern governments that are not under US control - Iran, Syria, and Hezbollah which governs southern Lebanon. The US invasions of Afghanistan and Iraq have failed to establish US control, but they have left both countries in a destructive civil war. Israel(i)'s invasion of Lebanon appears to have renewed civil war in that country.

Bush is not going to be forthright about the neoconservative agenda, because he knows it is one that Congress and the American people must be manipulated and maneuvered into accepting. However, neoconservatives themselves are very forthright about their war plans. Let's listen to their most recent pronouncements.

On January 23, former Republican Speaker of the House, Newt Gingrich, a leading neoconservative, told a conference in Herzliya, Israel(i), that the United States and Israel(i) were in danger of nuclear attack from Iran. The crazed Gingrich, who is considering a run for the US presidency in 2008, said: "*Our enemies are fully as determined as Nazi Germany, and more determined than the Soviets. Our enemies will kill us the first chance they get. There is no rational ability to deny that fact.*"

Gingrich says: "*We don't have the right language, goals, structure, or operating speed, to defeat our enemies. My hope is that being this candid and direct, I could open a dialogue that will force people to come to grips with how serious this is, how real it is, how much we are threatened.*"

Who are "our enemies"? Why, Iran, of course. Iran is

such a dangerous determined enemy that “the threat of a nuclear Holocaust” hovers over the US and Israel(i). “Israel(i) is in the greatest danger it has been in since 1967.” The US could “lose two or three cities to nuclear weapons, or more than a million people to biological weapons. Freedom as we know it will disappear.”

Another American presidential hopeful, Mitt Romney, told the Israeli audience that Islamic jihadism was “the nightmare of this century.” Israel, Romney declared, “is facing a jihadist threat that runs through Tehran, to Damascus, to Gaza.” Hezbollah, he declared, is not fighting for a Palestinian state but for the destruction of Israel(i).

Also at the Israeli conference was US Undersecretary of State Nicholas Burns, who added fuel to the fire by alleging without any evidence that “Iran is seeking a nuclear weapon, there’s no doubt about it. There’s no debate among experts. It’s seeking a nuclear weapon at its plant at Nantz.”

A truthful statement, which no one any longer expects from any member of the International Atomic Energy Agency have investigated Iran’s nuclear program and have found no evidence of a weapons program. A number of experts, such as Gordon Prather, have fiercely disputed the propagandistic claims of an Iranian nuclear weapons program.

What concerns experts is that once Iran has succeeded with a nuclear energy program, it could go on, in the absence of inspection to develop nuclear weapons in about 10 years.

However, as a signatory nation to the non-proliferation treaty, Iran would undergo the inspections, as it was doing prior to the recent provocations orchestrated by the Bush Regime. In contrast, Israel has not signed the non-proliferation treaty and has a large number of nuclear weapons, the existence of which Israel has denied for years. Burns told the Israeli conference that “The US will no allow Iran to go nuclear.”

This is an extraordinary statement, because every signatory country to the non-proliferation treaty has the right to develop nuclear energy. Some people speculate that an oil-producing country doesn’t need nuclear power. However, oil is Iran’s only significant export. The less Iran uses its own oil, the greater its exports. Burns told the Israelis that “We are committed to our alliance with Israel. We are committed to be Israel’s strongest security partner. I can’t remember a time when the relationship between our two countries was stronger than it is today.”

Chief US neoconservative Richard Perle told the Israeli conference that President Bush would give the greenlight if US military involvement was needed for a successful strike on Iran. According to the Israeli press, “Prele hypothesized a nightmare scenario, saying: “in possession of nuclear weapons or even in possession of nuclear material, Ira is perfectly capable of using its terrorist networks to enable others to inflict grievous damage.”

Former Israeli defense minister Shaul Mofaz, who met privately with Burns prior to their joint appearance at the Herzliya conference, said that 2007 would decide the future of the Middle East. Mofaz declared, “The year of 2007 is a year of decisiveness. Iran of 2007 has all the components to threaten us existentially, and the whole of the region.”

Any expert or knowledgeable person who examines these statements sees nothing but unsupported assertions, paranoid speculations, fear mongering and blatant lies. It is on this basis and this basis alone that the Bush Regime will

initiate war with Iran. Iran is being set up by the identical propaganda machine that set up Iraq with fearful imagery of mushroom clouds over American cities and nonexistent “weapons of mass destruction.”

After years of blaming al-Qaeda for the Iraqi insurgency the Bush regime propagandists have suddenly switched gears and now are blaming Iran for the failure of the US occupation in Iraq and for the deaths of US troops. The Bush Regime recently arrested Iranian diplomats in northern Iraq and made changes so preposterous that the changes were even rejected by Bush’s Kurdish and Iraqi allies. Powerful US naval attack fleets have been stationed off Iran’s coast and attack aircraft have been moved to Turkey and other locations on Iran’s borders. Meanwhile, Iran has done nothing.

Iran has refrained from arming and encouraging its Iraqi Shiite allies to join the insurgency against US troops. Iran could deliver the weapons that can knock out US tanks and helicopter gunships, thus eliminating the US military advantage from the conflict.

Neoconservative and Israeli propagandists have spread the lie that the Iranian president Mahmoud Ahmadinejad has declared Iran’s intention to “wipe Israel off the map.” This lie is today regularly repeated even by such formerly careful newspapers as the New York Times and London Times.

A number of experts have examined the speech by the Iranian president. What Ahmadinejad actually said was a direct quote from the deceased Ayatollah Khomeini “The Imam said this regime occupying Jerusalem must vanish from the age of time.” The experts explain that in

the context of the text of the speech, what is being said is that peace in the Middle East requires regime change in Israel. In place of a Zionist regime hell bent on stealing more land from Muslims, Zionism will pass away and Israel will cease its aggressive policies and live at peace with its neighbors.

A great number of Western experts agree that the problem in the Middle East is neither Islamic Jihad nor Israel per se, but Zionism which keeps Israel on a land expansionist course at the expense of Arab peoples. The failure of US policy in the middle East is the failure to deter Israel from this Zionist policy. A Large number of Israelis are opposed to this policy and recognize that Zionism is the cause of Israelis conflict with Arabs.

The real problem that Americans face is that the Zionist influence on US policy is so powerful that instead of dealing with the real cause of strife in the Middle East, the US is about the join Zionism in attempting to eliminate all Muslim opposition to Zionist expansion. THE STRANGER IN YOUR HOME

"If you came home and found a strange man teaching your kids to punch each other, or trying to sell them all kinds of products, you'd kick him right out of the house," said Dr. Jerome Singer of Yale University. *"But here you are; you come in and the television is on; and you don't think twice about it."* A wise observation. Do you control the television in your home? Or does it control you?

Almost every U.S. household has at least one (if you can believe it, households with a TV outnumber households with indoor toilets), and it's typically on seven hours a day.

The average American adult spends over 1,700 hours a year gazing at it (compared to only 110 hours spent reading books). According to Dale and Karen Mason, authors of **How to Get the Best Out of TV**, millions of Americans are so addicted to TV that they meet the criteria for "substance abuse" in the official psychiatric manual.

Statistically, a young person turning 18 will have whiled away more hours with this "stranger" than doing anything else except sleeping. Six of 10 children watch it without supervision; 4 of 10 keep one of these influential aliens in their bedroom. It is a fair question—in fact, we would be criminally negligent if we failed to ask it: *What is all this TV doing to us?*

Firstly, the hours devoted to television can never be reclaimed for something productive—working, exercising, studying, reading, communicating with actual people. And, it's not the most refreshing diversion: After an hour or two of television, people tend to be cranky, irritable and tired. Research shows that people "don't respect themselves for watching television, don't enjoy it much, and by and large wish they would quit" (ibid). Does that describe you?

Children who watch a lot of TV show a reduced capacity for creative imagination, concentration and delayed gratification. Thanks to the images on the tube changing on average every four seconds, their attention spans shrivel and their reading becomes lazy; they exhibit deficiencies characteristic of learning-disabled children. Similar patterns emerge in adults.

And all that doesn't even take into account the *content* of the shows on TV. As Jim Henson said, "Television is teaching—whether you want it or not." But *what* is it teaching us? What is it teaching our children? We can't afford not to think seriously about these questions.

None of us can watch without picking up ideas, values and patterns of behaviour from the small screen. It shapes our sense of what's normal, what's funny, what's beautiful, what's cool—what's right, what's wrong.

Even children's programming (is exactly that - it "programs" your children) is loaded with depressing and wrong messages (not to mention the fact that 10½ minutes of every hour are devoted to advertisements for things they don't need or that could be bad for them). But then again, only 14 percent of the network's schedules are devoted to kid's shows—so young people often end up watching adult programs that can feature violence, drunkenness, sexual promiscuity and other evils. In effect, our children are "eavesdropping" on the adult world, picking up lies and faulty behaviour as they go.

Take one example: TV's horribly distorted and decidedly unhealthy picture of sexuality. In addition to its prevalence—with over 65,000 references to sexual behaviour on American television each year—broadcast sex is unrealis-

tic: It happens five times more often between unmarried couples than between married; the second-most commonly depicted sexual experience is with prostitutes; homosexuality is pervasive; and consequences of sex such as pregnancy, disease, and disrupted relationships are almost never shown. In short, immorality is made to look normal, with few or no kickbacks.

Another of this stranger's primary messages is *materialism*. Among heavy TV users, the feeling is strong that certain material goods are necessities, whereas light TV users usually consider the same goods luxuries. Thus, television can breed into us a dissatisfaction with what we have—no matter how lavish. Is it any wonder we're so saddled with personal debt?

Other common messages on television, pinpointed by media researcher Dr. Robert Kubey, include: For everything there is a quick fix; young is better; open and unfilled time is not desirable—in fact it cannot be tolerated; violence is acceptable; and religion is unacceptable. Michael and Diane Medved's book *Saving Childhood* shows how TV additionally "bombards [us] with messages encouraging impatience, self-pity, insecurity and pessimism." Then there is the persistent foul language and gross humour, the course communication and shameless disrespect, the shallowness and lies mandated by political correctness. Add to these the ways that television trains us to root for the bad guy, to smile at lawbreaking—to cuddle comfortably with compromise as a way of life.

What would we do if we caught a schoolteacher trying to feed these concepts to our children [some teachers in schools now are, with impunity]? *I know—it's terrible isn't it?* many silently respond. *I can't believe they show that stuff.* Yet so many of us keep watching, convinced we can "handle" it while it gradually, incessantly, inescapably sculpts and shapes the way we think, the way our children think, how we behave.

That's not to say there are no positives to television. There are educational programs. It can be relaxing—even bonding—if used judiciously, with genuine moderation.

But the danger is that we grow comfortable with televised sin, after a lifetime of programming. This is an area of family life we cannot be careless about. Don't let this stranger into your home unchecked. Keep a close eye on him; limit his influence; don't let your kids spend time with him [it] alone; scrutinize how he affects you and your family. And, if you need to, kick him out!

The Almighty foretold the plagues He would bring on the Egyptians, then did it. After that, He told the Israelites to march to the promised land. He used fulfilled prophecy to dem-



onstrate the complete reliability of His Word. In Isaiah 48:3-5, our Heavenly Father said, "I have declared the former things from the beginning and they went forth from My mouth, and I showed them: I did them suddenly, and they came to pass. Because I knew that thou art obstinate, and thy neck is an iron sinew, and thy brow brass; I have even from the beginning declared it to thee: before it came to pass, I showed it thee."

In the New Testament 2 Pet. 1:19 reminds us, "We have also a more sure word of prophecy; whereunto ye do well that ye take heed, as unto a light that shineth in a dark place, until the day dawn, and the day star arises in your hearts." In 1 Cor. 13:22 Paul tells us, "Therefore, (speaking in) tongues are for a sign, not to them that believe, but to them that believe not; but for prophesying serveth not for them that believe not, but for them which believe." Christ Jesus said in John 13:19, "Now I tell you before it come, that when it is come to pass, ye may believe that I am He."

The whole 11th chapter of Hebrew is filled with examples of those whose faith was triumphant. Enoch by his faith, was translated not seeing death. Noah by believing and acting upon his faith, he and his family were saved from death in the flood. Abraham, because of his faith, received a son when both he and his wife were very old. Moses, by his faith, was able to lead his people safely through the plagues of Egypt. He also led them through the waters of the Red Sea and forty years in the desert. Joshua, who believed the Lord God marched around Jericho seven days, then blew the ram's horn trumpet and the walls fell.

However, note this, faith always blows the ram's horn before the walls fall. Noah built the ark years before there was any flood in sight. It is like a checker game. god makes His move when He offers you His blessings of salvation, healing, deliverance from dangers, etc..... Then it is your move. Believe in Him to fulfill His promises. Don't say, "**God I don't think I can trust you, I'll have to wait and see.**" Believe Him, the it will again be His move, and He will make it. Our Saviour said, "According to your faith be it unto you."

Faith is for these days, not for the sweet by and by. Present material salvation and redemption, as well as spiritual, was given to those who believed. Noah and his family escaped drowning. Enoch escaped death altogether. Moses led his people dry shod, through the Red Sea. Then Moses was given food and drink for all the multitude in a barren desert and he was given great military victories. Joshua was promised military victories over "seven nations mightier than thou." He believed and he got the victories. Think of the many who were healed of all manner of diseases.

Today, we are in peril of death from nuclear attacks, germ warfare, etc - Why don't we, as a nation, rely upon God's promises of deliverance? In Isaiah 54:15-17 our heavenly Father said, "Behold, they shall surely gather together, but not by Me; whosoever shall gather together against thee shall fall for thy sake ... No weapon that is formed against thee shall prosper; and every tongue that shall rise against thee in judgment thou shalt condemn. This is the heritage of the servants of the Most High, and their righteousness is of Me, saith the Lord."

Psalms 91:15-16 promises, "Thou shalt not be afraid for the terror by night; nor for the arrow that flieth by day; nor for the pestilence that walketh in darkness; nor for the destruction that wasteth at noonday. A thousand shall fall at thy side, and ten thousand at thy right hand; but it shall not come nigh thee. Only with thine eyes shalt thou behold and see the reward of the wicked. because thou hast made the Lord God, which is my refuge, even the Most High, thy habitation, there shall no evil befall thee, neither shall any plague come nigh thy dwelling." Then God says, "Because he hath set his love upon Me, therefore will I deliver him: I will set him on high, because he hath known My name. He shall call upon Me, and I will answer him: I shall be with him in trouble; I will deliver him, and honor him. With long life will I satisfy him, and show him My salvation." What can all of the rogue nations, with any number of bombs and weapons, do against the power of our God?

Should we fear the epidemics which we are told are threatening us? Why don't all the churches offer their people God's healing? [note by Chuck kuhler: Because they lack the faith and belief in God's Word!] We have had many, many times demonstrated the power of God to heal. Yes, and His willingness to

heal, as he has promised.

Our heavenly Father's promises are still ours for the asking, if we have faith. They are real, don't limit them by spiritualizing them away. The Lord took upon himself the material body of a man, and walked this material earth in the form of Jesus Christ. He made to material man, His promises of help when needed. Help as great as our need. Jesus said in John 16:23-24, "Verily, verily I say unto you, whatsoever ye shall ask the Father in My name He will give it to you. Hitherto ye have asked nothing in My Name: ask and ye shall receive, that your joy may be full."

In 1 John 5:4-15 we are told, "For whatsoever is born of God overcometh the world: and this is the victory that overcometh the world, even our faith. And this is the confidence that we have in Him, that, if we ask anything according to His will, He heareth us: and if we know that he heareth us, whatsoever we ask, we know that we have the petitions that we desired of him."

Why should we then fear the terrible international convulsions of the last days, now just ahead of us? We are told in advance of these things just so we would not fear them. We know that these things are the fulfillment of Divine prophecies, and the signs of the dawn to follow. In these times, to compromise with evil is literally suicide. When we abandon rights and justice, we lose God's protection and yet our enemies still hate us as much as ever. This is the time for boldness for the right, not cowardly surrender. Certainly the war of all organized evil, against the remnant of good, will come and very soon.

Don't pray that these things will not happen, that is not praying according to His will, for the Lord prophesied this. Pray they shall not happen to you. Pray for health, security and victory. As Luke 1:70-75 tells us: "As He spoke by the mouth of His holy prophets, which have been since the world began: that we should be saved from our enemies, and from the hand of all that hate us: to perform the mercy promised to our fathers, and to remember His holy covenant: the oath which He swore to our father Abraham, that He would grant unto us, that we being delivered out of the hand of our enemies, might serve Him without fear, in holiness and righteousness before Him, all the days of our lives."
