"IDENTIFYING ISRAEL. PT 10"

The Genealogical Record

Hosea 4:6, "*My people are destroyed for lack of knowledge...*"

So many people (including myself in the past) have wondered why the Bible includes genealogical records. The question seems to automatically pop into most peoples' minds, "Why are these here? It doesn't matter who you are." And we skip over these records as insignificant to the Biblical revelation. But, there they are! They confront the Bible reader in both the Old Testament and the New Testament. There must be a good reason. It may be that this is what Hosea is talking about in the verse above: knowledge about the Law of our God and knowledge about who we are!

This is the point of knowing something about the genealogical record of the Bible. The response most preachers give regarding genealogy is, "God cares about everybody and knows us by name." That may sound sweet and caring, but that's not a serious response from a theological point of view. Any serious Bible student knows that every scripture must fit together in harmony with the Bible as a whole, and hopefully with the established doctrines of their particular church.

Throughout this series I have showed who Israel is. The Jews claim to be of Israel, yet have admitted they are of a different origin. It can also be proven by genealogical record that they are not even closely related to Israel's descendants. They are even hundreds of years apart in history. In the second part of this series (#290, June 2010) I gave an explanation of the many meanings of the word "Jew" depending on its racial, religious, or geographic applications. The word "Jews" first appears in the book of 2 Kings (16:6).

If the Bible is the book of the Chosen People (and it is), then surely this chosen race would be mentioned in its pages. Since "Jews" are not mentioned in the previous books of the Bible, then there were no Jews in Genesis and the story of Abraham; there were no Jews in Exodus who were delivered out of Egypt; Moses was not a Jew; and the Jews never received the Law! Yet, by way of deception, today's churches think that anything in the Old Testament is Jewish, and they call both Abraham and Jesus a "Jew"!

The word "Jew" was coined by the Babylonians around 588 BC, after the southern tribes of Judah (the remnant in Jerusalem) went into the seventy years Babylonian captivity. The Biblical account of this is found in 2 Kings 24-25.

The Babylonian term "Jew" has been commonly used in most Bible translations but a proper English translation would be either "Judahite" (racial) or "Judean," (geographic) depending, respectively, on whether one was descended from the Israelite tribe of Judah; or if one was simply a person who lived in the country of Judea.

But, by the time Jesus Christ appeared, Judea was filled with a mixed multitude of Judeans. Jesus appeared at a very significant time in history. Some Judeans were true descendants of the tribe of Judah (and probably a remnant of a few other tribes), yet others were not. These others, nevertheless, were still called Judeans because they lived in Judea; just in the same way a person might be called a Texan even though such a person may not have been native born of that country. (Dutch, German, English, Australian, American, are all examples of geographic names without racial affiliation).

Just because a person is living in that country of Judea does not mean that the person is a racial descendant of the tribe of Judah or the "House of Judah" (the divided kingdom term). Judah had become more and more mixed with Edomite (Esau) blood in its racial mix, and by the time Jesus appeared, was thoroughly entrenched in the political and religious power structure of the country. Jesus was the Light invading a very dark time in history.

JUDAH

Today, the whole world would have us believe that the Jews living in the state of Israel(i) are the descendants of Judah. This is the biggest lie of history. The true Judahites through Pharez and Zerah were largely taken to Assyria and dispersed with Israel. Those who remained were pushed out, or bred out by the invading Edomites from Jerusalem; and only a small portion remained in the northern parts called Galilee, where Jesus and His disciples ministered (mainly consisting of Benjaminites, returned under Ezra and Nehemiah after the seventy-year captivity in Babylon).

As mentioned before, some of the descendants of Zerah populated parts of Europe centuries before (1550 BC) the time of Jesus. Tea Tephi, daughter of Zedekiah, the last king of Judah, a descendant of Pharez, was taken to Ireland to carry on the line of the kings. For more on this I have provided the following quote from "*The Genealogy of Yahshua the Messiah*" by Clifton A. Emahiser.

YAHWEH PRESERVED DAVID'S THRONE

Though the Throne of David was nonexistent for nearly 600 years in Palestine, during the inter-testament period, it was alive and well in Ireland, and Yahweh was true to His covenant of salt with David. The curse of Jeconiah was not on Zedekiah and his descendants, though Nebuchadnezzar killed all his sons who were eligible for the throne. But in Israel, the daughters can inherit the throne if there remains no living male heir (Numbers 27:6-11). Jeremiah took the two daughters of Zedekiah to a new land. Isaiah 37:31 prophesied that: "*And the remnant that is escaped, of the house of Judah, shall again take root downward, and bear fruit upward.*" Purposely written in the riddle form of a parable so that few would understand it, the Throne of David was relocated in Ireland, (Ezekiel 17:22-24):

Thus saith Yahweh, I will also take of the highest branch of the high cedar (royal family) and will set it: I will crop off from the top of his young twigs a tender one (a daughter), and I will plant it upon a high mountain (the isles) and eminent: in the mountain (the isles) of the height of Israel will I plant it: and it shall bring forth boughs (family branches), and bear fruit, and be a goodly cedar (strong family tree): and under it shall dwell all fowl of every wing; in the shadow of the branches thereof they shall dwell. And all the trees of the field shall know that I the Almighty have brought down the high tree (Pharez royal line), have exalted the low tree (Zerah royal line), have dried up the green tree (Pharez royal line), and have made the dry tree (Zerah royal line) to flourish: I Yahweh have spoken and have done it."

No sooner had Jeremiah arrived in Ireland with Tea Tephi (Zedekiah's daughter of the Pharez royal family) than he arranged for her marriage to Eochaidh, the Heremonn, a prince of the Tuatha de Danaans on his mother's side and a direct descendant of Fenesia Farsa, and thus of the line of Zerah, the twin brother of Pharez of the royal house of Judah, thus uniting the House of Pharez and the House of Zerah.

DAVID TO RULE ALL OF ISRAEL, NOT JUST JUDAH

Had Jesus taken the Crown at His First Advent, He would have been King of only Judah. Had He taken the Crown over all of Israel, He would have had to make a journey to Britain to dethrone whoever was king there at that time for there could not be two kings holding the position at the same time. If He had become King, at that time, He would have to have dethroned Herod. Had He taken Herod's place, He would have found Himself a vassal under Roman rule, and Jesus is never going to be subservi-

ent to any earthly king! When asked by Pilate if He were King, He answered (John 18:36): *My kingdom is not of this (2889, present world order), if my kingdom were of this (present world order), then would my servants fight.* We know this fighting did not happen at His first Advent, and hasn't happened since. We know Jesus didn't receive the scepter from the "Jewish" nation (RSV), and forty years after He was gone, they were still under Rome. If the first coming of Jesus was His Shiloh coming, then He failed miserably; for the people did not gather unto Him as prophesied in Genesis 49:10. It would have been impossible for the Israelites to gather to Him for they were scattered all over Europe from the Black Sea to the British Isles. God declared "Judah is My Lawgiver."

According to accepted evidence, Judah as Lawgiver departed from the nation of Judea five hundred eighty eight years before the One acceptable to eventually become Shiloh in the future came, thus leaving an unbridled chasm of time like a gaping void which cannot be easily plastered over. All who claim that Jesus has already come as Shiloh are compelled to resort to inexcusable distortions of Scripture to fill this gaping breach of five hundred eighty eight years from the overthrow of Zedekiah until the time of Our Redeemer.

It is recorded in 1 Kings 8:25: "*There shall not fail thee a man in My (God's) sight to sit on the throne of Israel.*"

Psalm 89:35-37 says: *Once for all I have sworn by my holiness; I will not lie unto David. His line shall endure for ever, his throne as long as the sun before me. Like the moon it shall be established for ever; it shall stand firm while the skies endure (RSV).*

Jeremiah 33:17-18: *For thus saith the Lord; David shall never want a man to sit upon the throne of the house of Israel; Neither shall the priest the Levites want a man before me to offer burnt offerings and to do sacrifice continually (KJV).*

ESAU

Another example of miscegenation is seen in the case of Esau (also known as Edom or Mt. Seir). Esau's genealogy is found in Genesis 36. From "*Easton's Bible Commentary*":

See Genesis 24:3, 27:46, 28:1, "...*Thou shalt not take a wife of the daughters of Canaan.*" At the age of forty years, to the great grief of his parents, he married (Genesis 26:34-35) two Canaanitish maidens, Judith, the daughter of Beerli, and Bashemath, the daughter of Elon. When Jacob went to find a wife in Padan-aram, Esau tried to conciliate his parents (Genesis 28:8-9) by marrying his cousin Mahalath, the daughter of Ishmael. This led him to cast his lot with the Ishmaelite tribes...

Here we see the example of Esau who married into one of the races that the Lord said was forbidden to marry. The descendants of Esau were not of Israelite blood and therefore not a part of the covenant which the Lord made with Abraham and his descendants. The Edomites later became a part of the multi-cultural mix of Judea. When Jerusalem was conquered by the Babylonians they sent all the Judeans into exile (586 BC). After the downfall of Judah, Edom rejoiced (see Psalm 137:7). This created a vacuum that drew in citizens from around their empire. It would have been likely that there had also been some mixing with the descendants of Shelah during the previous centuries. In time these newcomers became known as Jews. Later, they started telling everyone they were the Chosen.



Edomites settled in southern Judah as far north as Hebron. Nabateans occupied Old Edom beginning in the third century BC, continuing their civilization well into the first century AD. During the period from about 400-100 BC, Judas Maccabeus subdued the Edomites and John Hyrcannus forced them to be circumcised and then made them a part of the Judean people. They officially converted to Judaism in 129 BC. Most of the Pharisees, the High Priest, and the Herodian dynasty were of Edomite descent. All of modern day Jewry are also descended from Edom.

Today's Christian churches say that marrying outside of one's race is alright; that the prohibition was because of other religions, not race, but many passages in the Bible do not mention false religions in connection with marriage. It is true there are scriptures that mention false gods but that is because false gods usually accompany races outside of the covenant. The command in Exodus 20:14, "Thou shalt not commit adultery," is primarily in reference to the mixing of seed (See Deuteronomy 22:9), not only cheating on your spouse. We need to have a sense of loyalty to our race, our forefathers and our heritage. If miscegenation is not a problem, as the modern church believes, then why in two places is it mentioned that Rebecca and Isaac were greatly disturbed over it? Were they just prejudiced? Were they racist? (Canaan was from Ham, who was from Noah - therefore basically the same roots. Canaanites, as Moabites and Ammonites, were forbidden lineages because they were born from incest. There must have been something about their appearance that could identify them as such. CIM)

"And Esau was forty years old when he took to wife Judith the daughter of Beeri the Hittite, and Bashemath the daughter of Elon the Hittite: Which were a grief of mind unto Isaac and to Rebekah." Genesis 26:34-35.

"And Rebekah said to Isaac, I am weary of my life because of the daughters of Heth: If Jacob take a wife of the daughters of Heth, such as these which are of the daughters of the land, what good shall my life do me?" Genesis 27:46.

In this passage there is no mention concerning the religion of these girls. So why didn't Rebekah and Isaac just say something like modern Christians do, "Oh, they're in love; and as long as they are the same faith, that's all that matters." Isaac's father, Abraham, was also racially observant:

"And Abraham said unto his eldest servant of his house, that ruled over all that he had, Put, I pray thee, thy hand under my thigh: And I will make thee swear by the Lord, the God of heaven, and the God of the earth, that thou shalt not take a wife unto my son of the daughters of the Canaanites, among whom I dwell: But thou shalt go to my country, and to my kindred, and take a wife unto my son Isaac." Genesis 24:2-4.

Were all the family of the faith just racial bigots, or were they following what the Lord God had commanded? Once again there is no mention here of the religion of these daughters, only, "go unto my country, and to my kindred, and take a wife..." And, why did he promise this with his hand on Abraham's thigh? Why wasn't it on his chest or some place else?

Most seem to forget that throughout history certain races followed particular religions: the Orientals followed

Buddha, the Arabs followed Mohammed, the Caucasians followed Jesus Christ; etc. Why have the Caucasians followed Jesus the Christ? Because they are Israelites; they are the Sheep; they are the descendants of Abraham, Isaac and Jacob and are included in the covenant promises of the Lord.

INHERITING THE LAND

Here is the Biblical account on how we can take, and keep, our country.

"When the LORD thy God shall bring thee into the land whither thou goest to possess it, and hath cast out many nations before thee, the Hittites, and the Girgashites, and the Amorites, and the Canaanites, and the Perizzites, and the Hivites, and the Jebusites, seven nations greater and mightier than thou; and when the LORD thy God shall deliver them before thee; thou shalt smite them, and utterly destroy them; thou shalt make no covenant (no 'land right's treaties', no recognition as 'original owners' etc) with them, nor shew mercy unto them (as the churches are doing by holding collections to 'feed Africa's children' or import them as adoptions!) Neither shalt thou make marriages with them; thy daughter thou shalt not give unto his son, nor his daughter shalt thou take unto thy son (what part of THOU SHALT NOT, don't you understand?). For they will

turn away thy son from following me, that they may serve other gods: so will the anger of the LORD be kindled against you, and destroy thee suddenly. (Are you still walking in God's Law as you were taught and grew up with, or has your spouse caused you to become slack, and backslide?) But thus shall ye deal with them; ye shall destroy their altars (sacred sites, carvings, images), and break down their images, and cut down their graven images and burn them with fire. For thou art an holy (separated) people unto the LORD thy God: the LORD thy God hath chosen thee to be a special people unto Himself, above all people that

are upon the face of the earth." Deuteronomy 7:1-6. (that last line is what the media interprets as "White Supremacism," - they know what it says better than the people it pertains to, as most of them deny any 'supremacism').

Is this not clearly a racist statement in the minds of most people? These seven other families or races were to be killed, shown no mercy, not covenanted with, or married into. Their religious symbols were not to be tolerated. Why? Because genetic Israel was holy to the LORD and He chose them as special and above all other people upon the Earth. This is an exclusive relationship; all others are left out. (see "The Exclusiveness Of Israel", by Eliel, #714 @ \$23.95)

It is no different today than it was in the past. This is zero tolerance for a multi-racial, multi-cultural society. God had warned His people Israel that one of the results of race-mixing would be that their offspring would worship other gods, and so it was in Judea and Jerusalem. If we violate this Law (and we have), it says that God will become our enemy and destroy us. This is why this nation continues to decline under the wrath of God. Until this Law is instituted in our governments and God's Law becomes the Law of the land, we will continue to destroy ourselves.

After the small portion of Judahites returned to Judah and Jerusalem and the foundation of the temple was laid, something was brought to Ezra's attention:

“Now when these things were done, the princes came to me, saying, The people of Israel, and the priests and the Levites, have not separated themselves from the people of the lands, doing according to their abominations, even of the Canaanites, the Hittites, the Perizzites, the Jebusites, the Ammonites, the Moabites, the Egyptians, and the Amorites. For they have taken of their daughters for themselves, and for their sons: so that the holy seed have mingled themselves with the people of those lands: yea, the hand of the princess and rulers hath been chief in this trespass.” Ezra 9:1-2. What was Ezra’s response?

“And when I heard this thing, I rent my garment and my robe, and plucked off the hair of my head and of my beard, and sat down confounded.” Ezra 9:3.

This was Ezra’s act of humiliation. He was greatly disturbed over this trespass of God’s Law and so he went to prayer (see Ezra 9:6-15). Most Christians today are not disturbed; at least not enough to take action. They just say, “There’s nothing wrong with marrying another race; whatever they want to do; we’re all the same inside.”

Later we see a course of action suggested to Ezra:

“And Shecaniah the son of Jehiel, one of the sons of Elam, answered and said unto Ezra, We have trespassed against our God, and have married foreign women of the peoples of the land: yet now there is hope for Israel concerning this thing. Now therefore let us make a covenant with our God to put away all the wives, and such as are born of them, according to the counsel of my lord, and of those that tremble at the commandment of our God; and let it be done according to the law.” Ezra 10:2-3.

This is true repentance. It is action that is needed not complacency or a confession only. Does not Proverbs 28:13 say:

“He that covereth his transgressions shall not prosper; But whoso confesseth and forsaketh them shall obtain mercy.”

God will not bless us or our land without repentance. Repentance is turning around: confessing the trespass of God’s Law, forsaking the sin, and following the Law. Without this there can be no salvation, either individually or nationally. After gathering Israel in Jerusalem, Ezra gave the instructions:

“Now therefore make confession unto the Lord God of your fathers, and do his pleasure: and separate yourselves from the people of the land, and from the strange wives.” (10:11) What, divorce [put away] your wives (some Christian may ask)? I thought God was against divorce? The response from the people in verse 12,

“Then all the assembly answered and said with a loud voice, as thou hast said concerning us, so must we do.”

The rest of the book gives details on who put away their wives and children. Ezra also tells us what happened to those returning who could not prove their genealogy (see Ezra 2:59 & 62). This is further proof that the issue was not just over religion; it was over race. Nehemiah 9:2 comments:

“And the seed of Israel separated themselves from all strangers and stood and confessed their sins, and the iniquities of their fathers.”

Again, it does not say that they separated themselves from false religions, but from the racial strangers (‘mamz-

ers’). Many people in churches today are taught that divorce is wrong. Indeed it is a serious matter. but what we have here in the books of Ezra and Nehemiah is not divorce; it is “putting away” or separating. Miscegenation is NOT marriage in God’s eyes; therefore no written divorce is needed. A marriage with a thousand marriage licenses from the state does not justify a mixed racial union. It is fornication (illicit) and adultery (mixed seed) and must be repented of. This sin of miscegenation will destroy any nation; and has throughout history.

How did the people of Judah and Levi then living in Judea, lose control of their government and religion? They very foolishly forgot or ignored one of the most important laws of the LORD God, a law stated in Deuteronomy 23:2 which reads, “A mongrel shall not enter into the congregation of the Lord.” Yes, I know the KJV says “a bastard” but in the original scripture the Hebrew word was ‘mamzer’ which means a mongrel, a person born of racially different parents. Such a child would be false, not genuine,

and therefore illegitimate, but would not necessarily be born out of wedlock. A mongrel or so-called ‘bastard’ could only be produced by the mixing of races, and marriage had nothing to do with it.

When the Temple was rebuilt about 515 BC, a government under God was then re-established in the city of Jerusalem. This government, called a theocracy, was then once more administered by the Levites as God had commanded, and the sons of Aaron again served as the priests in the Temple worship. But soon thereafter, the pagan aliens from Babylon began their intrigue of subversion and conquest of the government and religious worship. These Babylonian pagans

were related to the Canaanites, Amelekites, Hittites and other people that God had told the Israelites to avoid; who were also living at that time in the land of Judea and particularly in the city of Jerusalem. Think of the sad words from Hosea 4:5,

“My people are destroyed for lack of knowledge: because thou hast rejected knowledge, I will also reject thee, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children.”

Most of the returning people of Judah and Levi settled in Judea, but the people of Benjamin established their homes considerably to the north in the province of Galilee. This was a significant fact, because the people of Jerusalem and Judea were integrated with these other races and in time became almost totally mongrelized with them, while the people of Galilee were segregated and so were saved from the ravages of race-mixing. God had warned His people Israel that one of the results of race-mixing would be that their offspring would worship other gods (and follow other law-systems) and so it was in Judea.

CONCLUSION

After reading the scriptures as relating to marriage and genealogy, some will feel this cannot be true for it would make God a racist, at least in some sense of that term. Some will refuse to accept this position saying, “That just isn’t fair.” But God will decide what is fair; He is the potter and you are the clay. He is the One who created genetics and He makes the rules governing it. Will you side with Him or will you side with the world? Today we are mixing the

aces and forgetting about God's Law regarding it. As Hosea has said, we too will be "...destroyed for lack of knowledge"; the knowledge of who we are and how we relate to God's Law.

And, are all these examples and genealogies in the Bible for nothing? Like most pastors say, "There's nothing in the Bible about race". What? The Bible is full of race! And some day, if the Bible is banned by the government as a "racist book," will you agree with it? The government can understand plain English, why can't the churches understand plain English? Today's preachers will quote just one verse to support the view that race doesn't matter, usually Galatians 3:28, "*There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female: for ye are all one in (an anointed people belonging to*) Jesus.*"

* This is how Arnold Kennedy said it should have been translated. There being a substantial difference in the Greek between 'Christ Jesus' and 'Jesus the Christ'!

But this verse is not speaking about race or genetics; it is speaking of nationality, economic status, and sex. Race and heritage does matter. Does the modern church person think that Ezra was just a mean old man who liked to break up families for fun? Do they think that the accounts of Esau and Judah are just insignificant historical notes? Do they take the Bible seriously when it says: "*For whatsoever things were written aforetime were written for our learning...*"? Romans 15:4.

PICTURES OF MISCEGENATION

"*Thou shalt not sow thy vineyard with two kinds of seed, lest the whole fruit be forfeited, the seed which thou hast sown, and the increase of the vineyard.*" Deuteronomy 22:9.

"*And whereas thou sawest iron mixed with miry clay, they shall mingle themselves with the seed of men: but they shall not cleave one to another; even as iron is not mixed with clay.*" Daniel 2:43.

"*Give not that which is holy unto the dogs, neither cast ye your pearls before swine, lest they trample them under their feet, and turn again and rend you.*" Matthew 7:6.

"*So the servants of the householder came and said unto him, Sir, didst not thou sow good seed in thy field? from whence then hath it tares?"* Matthew 13:27.

"*The field is the world; the good seed are the children of the kingdom; but the tares are the children of the wicked.*" Matthew 13:38.

"*And the dragon was wrath with the woman, and went to make war with the remnant of her seed, which keep the commandments of God, and have the testimony of Jesus Christ.*" Revelation 12:17. [Notice that this war is not with a religion, but with a Seed!]

THE SKY IS FALLING

I have just returned from one of the most important Climate Change conferences ever held. Sponsored by the Heartland Institute, more than seven hundred scientists from all over the world came together to testify that man-made Global Warming does not exist. DOES 'ACTION' GET RESULTS?

Over the years, we have asked readers (of "*Salt Shakers*") to take action on a wide variety of issues. Most of the time, these issues are related to upholding the Biblical standard on issues in our states and nation. It might be opposing the localization of prostitution, complaining about advertisements or television programs or supporting the definition of marriage as being "the union of a man and a woman to the exclusion of all others, voluntarily entered into for life." i.e. "to cleave, and be one flesh."

You might well ask the question, "Does 'action' get results?" Or perhaps, "Does *my* letter really matter?"

Often we are tempted to think that our/my letter won't make any difference - so it won't matter if I don't write - BUT, of course, if everyone thought that, then no letters would get written. The fact is that when a lot of individuals ALL act, it adds up to a large number of people.

We can get disillusioned when we lose campaigns. For instance, when Victoria passed the *Abortion Law Reform Act*, the people who had

written letters or marched on the street may be tempted to think that their effort was a waste of time.

However, the problem is not that those efforts were wasted. The real problem was that not enough people took such action. Not enough people marched on the streets. Not enough people spoke to their MPs.

A politician once told us that, when he looked out from Parliament House and could see ten thousand people marching down the street to oppose abortion then maybe he could do more in the parliament to stop abortion. It is the same with EVERY issue.

If the people aren't protesting, then the politicians think we don't care. Unfortunately, they will nearly always listen to the loudest voices (the squeaky wheel gets the grease). Another factor is that not enough Christians actually stand for political service.

The reality is that politicians and governments weigh up competing voices, both outside and inside the parliament. When groups such as Emily's List or the homosexual lobby exert the power, the politicians listen. That makes it harder to get politicians to really assess the merits of the arguments, since they have already made up their mind on the issue. The reality is that when politicians are considering an issue they look at how many letters they have



received on that issue and how many constituents have visited them to discuss it. If Christians don't write and visit their MP, to let them know their views, all they are going to hear are the arguments from the OTHER side.

Activism Gets Results

During the past month we have seen two instances of activism that have resulted in immediate action. The respective responses from the federal government and a private company were very swift and decisive - but in both cases they really didn't seem to have worked through all the issues.

The first issue relates to the live export trade of cattle to Indonesia. The federal government made a knee-jerk reaction to suspend the trade immediately, in response to a concerted campaign and the 'outrage' of the public following the screening of horrific images of animals being mistreated in a few Indonesian abattoirs on a *Four Corners* program.

It turns out that the animal welfare group *Animals Australia* had shown the Indonesian abattoir to *Four Corners* - as part of *Animals Australia's* stated campaign to ban the live export trade. *Animals Australia* and *RSPCA* set up a website, called "Ban Live Export" at <http://www.banlive-export.com/>

They worked with two Independent Senators, Andrew Wilkie and Nick Xenophon, who put a bill into Parliament to end all live animal exports. They also organized a 'National Week of Action' - using email, phone and mail - to get people to contact MPs to persuade them to support the Bill.

Get Up!, a left-wing activist organization, joined in, urging their "members" to sign their petition (they say that more than two hundred forty thousand people did!) and to join the *Animals Australia* campaign. Within a few days of the TV program the government acted!

The decision was made with no regard to the effect it would have on a wide range of people - Australian cattle producers, manufacturers of stock feed, the 'good' Indonesian abattoirs or the poor people in Indonesia who rely on fresh meat because they often have little refrigeration.

The decision left farmers across the north of Australia in dire financial trouble after many years of drought. Their animals, which were being readied for the Indonesian market had nowhere to go.

The second incident, this time in Queensland, involved the placement of ads that featured a homosexual 'couple' and a condom along with the message 'Rip 'n Roll,' on bus shelters to encourage condom use. Complaints were made by concerned parents and Christians about placing condom ads on bus shelters which are frequented by children and young people. The company, *Adshel*, responded to the complaints by removing the ads.

Naturally, it didn't take long for homosexual groups to

'complain,' including online complaints on Facebook and a small, but noisy, protest outside *Adshel's* office. *Adshel* responded almost immediately by reinstating the ads - saying the complaints were only from an 'organized campaign by *ACL*,' organized by *ACL Queensland Director*, Wendy Francis, *Adshel* then gave the organization (*QAHC*) an 'extra two weeks' of ad space.

In fact, Wendy, on her own initiative, had been running a year-long campaign against all sexualized outdoor advertising. Wendy was concerned about the sexualisation of children viewing the ads and would have been just as concerned if it featured a heterosexual couple and a condom.

Adshel have not explained why the family/Christian complaints were any less worthy because they were part of a 'campaign'. Why should it matter if a campaign was organized? People only write if they are personally concerned about an issue.

It seems that *Adshel* weighed up the two competing groups... a few polite letters from concerned parents versus the noisy homosexual lobby protesting on the street outside their office. The homosexuals won!

If more Christians had been concerned, and been prepared to do something, the result might have been different.

Action on Both Sides

The current debate over a carbon tax has become more lively in recent months as groups who oppose a carbon tax have started to hold rallies and initiate action.

This has gone some way to balancing the government's promotion of the tax, but in response, a group of actors got together to present a public face to support the new tax - to "Say Yes" to a 'carbon tax'.

Cate Blanchett was the star who headlined the campaign, but it suffered a credibility gap when it was pointed out that the coal-fired power station in the ad was actually the UK's Battersea Power Station, which was closed twenty eight years ago!

The 'Say Yes' campaign was organized by a Coalition of groups: environment organizations such as *Greenpeace* and the Australian Conserva-

tion Foundation climate groups such as the Climate Institute, and the unions (so long as they get 'compensation'!).

So what lessons can we learn?

There are many people taking action - but increasingly those taking action have a left-wing and often, anti-Christian perspective.

Just have a look at *Get Up's* current list of campaigns, which they encourage all their members to take action on! "Climate Action Now"; "Support Victorian Human Rights" - campaigning for an extension to Victoria's Charter of Rights; "Ban Live Export" and "Marriage Equality" - support for homosexual marriage.

Only a small proportion of the population receive our publications; in fact only a small proportion of Christians receive it or even do something about it. We need to spread the word, encouraging others to take action as well as taking action ourselves.

In Tasmania, the homosexual lobby recently set up a special website to urge their people to lobby MPs to support the Surrogacy Bill - they stated that this was to counter the large numbers of letters the MPs were getting from Christians who were opposing the Surrogacy Bill! But we suspect the MPs are really hearing more from the homosexuals!

A poll on The Age website, run in relation to the issue of teaching Religious Education in schools, gained an amazing eight thousand votes, with eighty percent in support of Religious Education. We sent the poll out on our E-News - we also kept getting a variety of emails urging us to vote in the poll - that sort of grassroots action is what is needed on every issue.

The Issue of Our Time

The threat to marriage is the most vital issue we currently face. There are two factors currently influencing this battle - the Greens and pressure within the ALP itself.

Currently the Gillard government isn't succumbing to pressure from Bob Brown and the Greens - but the Greens will have control of the Senate from July 1, 2011.

The issue of same-sex 'marriage' is now firmly on the agenda for discussion at the ALP Conference in December.

In a startling example of 'activism', in June *GetUp!* and *Australian Marriage Equality* successfully bid for a 'Dinner with the PM' - paying \$31.50 for three same-sex couples to have dinner with Julia in an effort to persuade her to change her mind! Oh, and they also won dinner with the Independents...

WE MUST take action too!

Health Problems with RU486

The abortion pill, RU486, had been available in Australia since 2006, when the federal government passed a law transferring the control over the importation of RU486 from the federal Health Minister to the Therapeutic Goods Administration (TGA).

Abortionists and doctors who wish to use RU486 for 'medical abortions' have to apply to the TGA for approval. Since 2006, the TGA has given one hundred and two doctors and abortionists permission to hand out RU486 to pregnant women who want an abortion and has handed out eleven thousand one hundred seventy three prescriptions.

When the issue was debated in 2006, it was said that RU486 would only be used for early stage pregnancies - however, it is also being used for much later abortions. In addition, RU486 was promoted as an 'easy option' that was safe and trouble-free. The woman is given the RU486 pill (*mifepristone*), and later given a second drug, *misoprostol*, and usually sent home to deliver the dead baby 'in the privacy of their home'. It is not surprising that there are medical complications for the woman using RU486. Of course, there are also additional emotional consequences for the women who have to undergo such a devastating experience on their own at home.

Many states do not record the number and type of abortions, or monitor the adverse consequences resulting from those abortions. South Australia, however, is one state that monitors abortion statistics. A recent study of the statistics, published in *Australian Family Physician*, gives an insight into the use of RU486 in South Australia. The results of the study was reported in the *The Australian* in May.

The study compared surgical abortions and 'medical abortions' which use the RU486 abortion pill. The researchers, Adelaide-based doctors Ea Mulligan and Hayley Messenger, found that complications from the abortion pill are higher than for surgical abortions. Of the nearly seven thousand abortions done in South Australia in 2009-2010, just over three percent of women who used RU486 in the first trimester of pregnancy ended up going to a hospital emergency department, compared with a little over two percent who had undergone surgery. Of those, nearly six percent of those who had used RU486 were admitted to hospital, compared to half a percent of those who had surgical abortions.

The risk of 'serious complication' was also higher for RU486 abortions. Two of the five thousand eight hundred twenty three surgical patients suffered severe hemorrhage, involving the loss of more than a litre of blood. This equated to a rate of one in three thousand. Four of the nine hundred forty seven women who had medical abortions using RU486 had the same problem, lifting the ratio one in two hundred.

The article in *The Australian* said, "Dr Mulligan pointed out that the number of complications was so small it could be regarded as statistically insignificant."

However, the study found that complications from second-trimester medical abortions happened in up to thirty three percent of the cases reviewed. *The Australian* reported that Dr Mulligan "conceded that Australian doctors were still on a "learning curve" about RU486 and its use.

Life Network Australia responded, "The idea of a "learning curve" is alarming when the lives of women, babies and families are so negatively affected by this drug, which some have likened to 'backyard' abortions."

Life Network Australia is calling for a review of the use of RU486 and encouraging everyone to write to their federal MP and Senators, asking them to ban the use of RU486. They suggest people should remind them of the

warning given by Dr Renate Klein back in 2006. Dr. Klein, a feminist academic who supports legal abortion, warned that the use of *prostaglandin*, the second drug given after RU486 to expel the dead baby has serious health consequences for women. She said, "Since the 1970's *prostaglandins* have been rejected by the women's health movement as far too dangerous to use as abortifacients as they cause such severe and painful contractions in some women that the uterus may be irreversibly damaged. They can also lead to uncontrollable blood loss."

As Christians, we believe that any abortion goes against the Biblical commandment of not murdering another person. The RU486 abortion pill adds even more ethical problems and health risks, and so its use in abortions should be totally rejected.

ACTION: Contact your federal MP and twelve state Senators - ask them to ban the use of RU486 in abortions. Mention the additional health risk and emotional trauma experienced by women who use this drug for abortions.

Q: What does the Bible say about tattoos and piercings?

First, the words tattoo and piercings do not appear in the King James Version. What we have to look at is what does God have to say about our bodies? Are we free to do whatever we want to our bodies? Obviously, since God is the Creator of our bodies, He has ultimate say over what we can and cannot do. Let's look first in Romans 12:1-2.

"I beseech you therefore, brethren, by the mercies of God, that ye present your bodies a living sacrifice, holy, acceptable unto God, which is your reasonable service. And be not conformed to this world: but be ye transformed by the renewing of your mind that ye may prove what is that good, and acceptable, and perfect, will of God."

So we are told that our reasonable service is to present our bodies a living sacrifice, holy (separate) acceptable unto God. However, if we look at the sacrifices under the Old Covenant we see that all of the various sacrifices were to the unblemished. We are also told in Leviticus 19:28, "You shall not make any cuts in your body for the dead nor make any tattoo marks on yourselves: I am the Lord." New American Standard. When we look at the context of this we see that all of this relates to Israel not embracing the ways of the heathen. If we look at the origin of tattoos, we find this:

"The term "tattoo" or from Samoa, "Tatau" is first referred to by Joseph Banks, the naturalist aboard Cook's ship the "Endeavour" in 1769 where he mentions it in his journal. To paraphrase, he states, "I shall now mention the way they mark themselves indelibly, each of them is so marked by their humor or disposition". Tattooing has been practiced for centuries worldwide. The Aimu, the indigenous people of Japan, traditionally wore facial tattoos. Today one can find Berbers of Tamazgha (North

Africa), Maori of New Zealand, Arabic people in East-Turkey and Atalay of Taiwan with facial tattoos. Tattooing was widespread among Polynesian peoples and among certain tribal groups in the Taiwan, Philippines, Borneo, Menawai Islands, Africa, North America, South America, Mesoamerica, Europe, Japan, Cambodia, New Zealand and Micronesia." <http://en.wikipedia.org/wiki/Tattoo>

Obviously then, tattooing and most piercings are "the way of the heathen" and is conforming to our current world and should not be practiced by Christians who are making their bodies a living sacrifice.

It is important to note that ear piercing is in the Bible and this was a sign that a person was a lifelong slave (servant) to another Israelite of their own free will and volition. "Then his master shall bring him unto the judges; he shall also bring him to the door, or unto the door post; and his master shall bore his ear through with an awl; and he shall serve him for ever." Exodus 21:6

It is important to note that there are other references given in the Bible regarding earrings. The very first reference is in Genesis 35:1-4. "And God said to Jacob, Rise up go to Bethel live there, And make an altar to God there, who appeared to you when you fled before your brother Esau. And Jacob said to his house, and to all those with him. Put away the strange gods which are in your midst and purify yourselves and change your clothing. And let us rise up and go up to Bethel. And I will make an altar there

to God, who answered me in the day of my distress. And He was with me in the way in which I went. And they gave all the strange gods into their hand to Jacob, and the earrings which were in their ears and Jacob hid them under the oak that was near Shechem." Green's Literal Translation.

Notice the strange gods and earrings are both pagan in this account. The other references to earrings show that Israelites did wear them as they gave them as offerings in Exodus 32:2-3, 35:22; Numbers 31:50; and Judges 8:24-26. In Isaiah 3:20 the earrings and adornments are taken away as punishment. In Ezekiel 16:12 God tells Hosea that Israel adorned herself and

went after other lovers and forgot God.

From these accounts, we see that the earrings and adornments can be used for good or for evil. So the distinguishing factor is why are you wearing what you are wearing? Are you doing it to honour God or are you doing it to entice others to do evil? Is what you are wearing modest and up-lifting or worldly?

In conclusion, we can see that tattoos and cuttings (body piercings that embrace heathen ways and actual cutting of the body) are totally forbidden by God's Law. However earrings are not prohibited, but we must look at why they are worn. Also, the only time we know for certain that the ear was pierced was for a permanent earring that was used to mark a person as a slave (servant). So, just as we consider what clothes we wear, we must consider everything about our outward appearance and strive to always be a good Christian witness for Him. Remember your lifestyle may be the only Bible some people ever read.

Only God is the Supply of Living Waters but only the individual can keep open the sluice gates and the flumes of his soul.

It is no mere figure of speech to declare that God desires to indwell His people and does exactly that in all

who are open to Him. Paul was speaking both by guidance and by experience when he declared, "...ye are the temple of the Living God". (II Corinthians 6:16).

The Apostle found it necessary to warn those whom he declared to be the *temple of the Living God* to break all personal associations with unbelievers. He *admonished them to separate themselves from the world, i.e., this present evil society*. He declared it to be an unclean way and warned that God's own people should not even touch it. (II Corinthians 6:14-17).

HABITS OF THOUGHT AND ACTION which are related to our modern society can so fill the soul with the sludge and muck of the world that the Living Water of God's Spirit is blocked and turned aside.

LIFE IS NO FOOLISH GAME which can be played by the rules of the flesh. I'm not writing this because it is popular to do so. This truth is just as unpopular today as when it nailed our Lord Jesus to the cross! I'm writing of this because our Heavenly Father wants us to know *the facts of Life, of the Life of His Spirit indwelling us*.

Though the tank is filled with gas and every mechanical part in perfect order, no car will move until the key is turned in the ignition. *How seemingly insignificant the spark of electricity, yet how dead the finest automobile is without it. Without ignition, it remains just so much metal, rubber, plastic and paint.* But, with the turn of the key, the current of its life, stored in the battery, sparks the motor and off the car goes to fulfill its reason for existing.

In many different ways, Jesus taught His disciples that, until they turned the key which connected their physical selves with the Life of His own Spirit, they remained before God as dead and useless persons. On one occasion when a disciple requested, "Lord, allow me first to go and bury my father," *Jesus answered, "Follow Me; and let the dead bury their dead."* (Matthew 8:21-22).

We must not think, as some have ventured to suggest, that our Lord teaches any lack of concern for the passing of our loved ones. Rather He used this exceptionally strong figure of speech to show us that *any person or situation which hinders us from following Him blocks the flow of The Spirit of His Life in us. Without His Life in us, we are dead to God; just as dead, spiritually, as those who have ceased to breathe are dead in the physical sense!*

Lest some think these truths are not to be literally applied in our day-to-day walk, please consider a further illustration. Everywhere one turns, those who profess to follow Christ are desecrating their Sabbath. The commandment of the Lord is clear and there can be little excuse for misunderstanding on the part of those who profess to love the Lord Jesus and to obey His Word. "Remember the Sabbath (rest) day to keep it holy. Six days (not five, not four but six) shalt thou labor, and do all thy work; But the seventh day (the day following six days of work) is the Sabbath of the Lord thy God..." (Exodus 20:8-11). Further direction is found in Isaiah 58:13-14. God's people are to make the Sabbath a holy day, not a pleasure day; it is to be one day in which all their thoughts and actions are for the sole purpose of honouring God.

It is not within the scope of this short article to discuss the manifold benefits which result from obedience in this

matter of the Sabbath. It is to remind God's own that in this matter, as in many others, which can be readily ascertained by all who love Jesus, multitudes are allowing the present evil society to so engulf their thoughts and strength that there remains no open channels for the flow of the Living Water of His Spirit. Though they appear busy, important and very much alive to the world, they are fast becoming dead in the sight of God.

Come, drink, believe (live by); these are all verbs. They indicate action with Jesus. Those who act with Him are blessed with Him.

THOSE WHO MUST TRAVEL steep mountain trails, where a slip of the horse's hoof could send horse and rider crashing down the mountain side or over the edge of a precipice, choose their mounts with care. True climbers are horses whose rear feet trace *exactly* where the forefeet are planted. When they place their front feet upon a safe ridge, their rear feet will follow safely, too.

This was the explanation given to Glenn Clark when he was advised, upon one occasion, to take a round-about but safer trail up to the plateau where he and several others were to meet.

"I see," replied Clark. "Your horses have feet like the deer and the antelope."

"Exactly," replied his companion, "and a horse has to be as sure-footed as a mountain goat to take this trail to the high places.

This casual exchange between the two men led to one of the greatest experiences of Glenn Clark's unusually successful life. At that time, he had been searching for the key which would unlock the secret of a particular passage of Scripture. The passage appears three times in the Bible. For a number of reasons, which would take too much space for this short article, he had been seeking to understand and apply the words of David - "He maketh my feet like hind's feet and setteth me upon my high places."

Now the advice which his friend had given fitted perfectly! Suddenly, as he himself writes, "*The mystery of the hind's feet was solved... the deeper I got into the mystery the more marvelous it became... great thoughts came to me.*"

Quickly it all became clear. No animal has such perfect correlation of its front and rear feet as does the HIND or female deer. While leading its young into hidden fastnesses, the hind is the most perfect example of physical correlation that God has ever made.

Glenn Clark's own words concerning this great secret from the Word of God are the clearest and most precise I have ever read. Here they are: "*As the feet of the hind are to the mountains, so is the mind of man to the heights of life; and as the rear feet of the hind are to the front feet, so is the subconscious mind of man to the conscious mind.*"

If you are familiar with the life and writings of Glenn Clark, then you know that not only did he find the secret of HIND'S FEET that day but he went on to apply the spiritual principle involved and his own hind's feet did indeed carry him to high places in his service to God and man.

NO MATTER HOW GREAT THE KEY, success comes only through faithful and vigorous application. To know is not enough. It is essential to apply. The question

then is what shall we do that our own feet may become like HIND'S FEET - that our conscious and subconscious minds may track perfectly and so carry us upward to the mountain tops of spiritual and material achievement?

What happens must happen inside, deep inside us first. The Lord Jesus pointed the way when He declared, "*I and My Father are one*" (John 10:30), and then prayed that His followers might also become one with Him and His Father. (John 17:21). How did Jesus achieve and maintain this perfect unity with the Father? How did His conscious mind trace so perfectly with His subconscious? That such was the case, there is no doubt. For all His works prove it. He was the One Great and Perfect example of this truth. He expressed it this way: "*For verily I SAY unto you, that whosoever shall say unto this mountain, Be thou removed, and be thou cast into the sea; and shall not doubt in his HEART, but shall BELIEVE that those things which he SAITH shall come to pass; he shall have whatsoever he saith.*" (Mark 11:23).

All students of Jesus' life know about His secret BUT FEW KNOW IT IN THEIR OWN EXPERIENCE. Why? Because few, very few, spend time with Him and the Father in SECRET prayer. Few enter in at the straight gate, few tread the narrow way. Few go up into the mountains of prayer regularly as Jesus did. Few there are who EXPERIENCE THE WONDER OF GOD'S VOICE in their own hearts - few take the time to allow God to fill their hearts (subconscious minds). This is why so few of Jesus' followers learn to track and

attain their high places. But no one can say that God has not shown the way. He has - in Jesus the Christ of Nazareth.

If you would have HIND'S FEET, FOLLOW THE ADVICE OF the Psalmist: BE STILL AND KNOW THAT I AM GOD - become ONE with Him - let Jesus teach your conscience and subconscious minds to track perfectly. This is our challenge for today!

THE DAY OF THE LORD AND THE CERTAINTY OF JUSTICE

Obadiah was likely the first prophet to use the term "...the day of the Lord" (Obadiah 1:15). It has an intended foreboding sound to it because it speaks of an ultimate accountability before a God to whom justice is attributed as part of His being. The expression is used in Scripture to refer to a day in which judgment is both pronounced and executed. The reference is to men and nations appearing before God's court.

Obadiah's specific message was calling the nation of Edom (Idumea) to their sentencing before God for their mistreatment of Judah. In that context, the prophet also refers several times to Judah's trial as "the day." Judah itself had been called before God's court. In Judah's day of judgment, the Edomites (descendants of Esau) took advantage of the Hebrews, a related people. Judah had its day of judgment, as had Israel, and the Edomites now were assured theirs was coming, but one with no mercy and future restoration.

After Obadiah wrote, other prophets used the term. The day of the Lord came at different times for Israel, Judah,



and Edom, as it does for every person, nation, and institution, yet there is also a final day of the Lord referred to in Scripture; hence it is called the *Last Judgment*. Because the prophets were specifically speaking to nations facing violent foreign invasions and captivity, the Old Testament references are quite harsh. The nature of the day is one of destruction and land laid desolate. Their descriptions speak of humbling, goods and lands spoiled or stolen, heathen swords, and repeated references to darkness. Such imagery is also in the New Testament, where the earth (system) and its works are burned up in that final day of the Lord.

THE NECESSITY OF JUDGMENT

There can be no justice without judgment on both injustice and the unjust. Judgment on sin is the consequence of violating God's moral order. In human courts we say people are "brought to justice," they are held accountable for their crimes. We do not say justice is suddenly imposed on them. Obadiah tells the Edomites their judgment is directly related to their sin: "[A]s thou hast done, it shall be done unto thee: thy reward shall return upon thine own head" (Obadiah 1:15b).

When Hosea prophesies about the coming defeat and enslavement of the nation of Israel, their judgment is also referenced as a direct consequence of sin, "For they have sown the wind, and they shall reap the whirlwind." (Hosea 8:7a). Their judgment was a necessary and direct result of their sin. Judgment is not a subjective decision by God but a necessary part of His righteousness. Judgment is God saying, "You made your bed, now lie in it."

Likewise, the curses of God are described to us as following and inevitably overtaking disobedient man (Deuteronomy 28:2, 15). Like the laws of physics God built into His universe that we recognize with scientific certitude, the moral law of God is an unavoidable part of reality that man ignores at his own peril.

In *The Biblical Philosophy of History*, my father notes something profound when discussing that history is linear, not cyclical. Not only does history move forward, he says, but in a very real sense it moves backward from future to present, because the future promise of God and His predestined plan make that future certain. The present moves toward that eternal purpose. Nothing can exist or operate except in the eternal certainty of God's future. This is why postmillennialism does not stem from man's optimism but from a faith in the person and Word of God and the exalted place of His Messiah. One of the persistent problems of the contemporary church is that it gives 'Satan' a position of preeminence by assuming he controls the world and its future.

WHO CONTROLS THE FUTURE?

The writer of Psalm 46 assumes God controls the future when he writes, "Be still, and know that I am God: I will be exalted among the heathen, I will be exalted in the earth" (Psalm 46:10). That writer speaks of "natural" disasters, plus foreign threats and the devastation of war, yet still can exalt God as his "refuge and strength."

Our faith in God may be a faith in His rule over all things, not just our salvation. A world whose attention is focused on one of the most devastating natural disasters in modern history should remember the faith the psalmist professes:

"Therefore will not we fear, though the earth be removed, and though the mountains be carried into the

midst of the sea; Though the waters thereof roar and be troubled, though the mountains shake with the swelling thereof." (Psalm 46:2-3).

There is no hint of a 'satan's' control over anything in Psalm 46. As Christians we need to examine our faith. Do we believe God or 'satan' controls life, history, and the future? How you answer that question controls much of your life and thought.

NO SAFETY IN SIN

There is evil in this world; there is no doubt that is the context of all Scripture. We are ourselves sinners (1 John 3:4), and we live in a fallen world. Sin has its consequences, so the life of sinners in a fallen world has problems. Sin produces both temporal consequences and moral judgment, yet righteousness also produces temporal consequences and blessing. Sin and righteousness, both being moral in nature, have moral rewards before the court of a just God; but God is not just as we choose to define justice, or we make God into a puppet of our humanism. We understand the nature and definition of justice as we understand God's revelation of Himself and His Law-word.

The salvation of God represents more than our eternal reward; it must be seen as our status as new creatures in (Jesus) Christ in this fallen world of time and history. Our purpose as the redeemed of God is our recall to the exercise of dominion in terms of our faith that God is who Scripture says He is, and that Jesus (the) Christ is now Lord and Savior. The end certainty on which we fix our eyes is the historical certainty of Revelation

11:15, "The kingdoms of this world are become the kingdom of our Lord and of His (anointed people) Christ; and He (our Lord) shall reign for ever and ever." This is not a short-term goal for which we strategise but a faith in which we operate in sometimes very frustrating labors.

There is no safety in a sinful world, and no easy way for sinners, even those redeemed by grace. Life in a sinful world has been problematic since the fall. This does not mean sin or 'satan' controls either this world or the course of history.

THE SLAVE MENTALITY

Egypt was used by God and the prophets as a symbol of oppression and slavery. Even as a place of slavery, Egypt was, however, also a place of security; the Hebrews were not responsible for anything but their work details. This was one reason the Hebrews resisted Moses. Slaves could not think like free men; they did not have the courage to exercise the responsibilities liberty demanded. One result was only remembering the food Egypt provided and their complaining to Moses about the fine mess he had gotten them into. That generation had such a slave mentality that God forbade them to go into the land and they died in the wilderness.

We, too, derive many benefits from the humanistic, statist culture in which we live. We cannot be quick to assume the standard of living in the wilderness was better than that of Egypt. God did not give them instant prosperity, nor did the "promised land" offer a land of ease, but a land of opportunity under God's Law. Should God's judgment fall in our lifetime, we too, may find ourselves in a wilderness for a time, stripped of the comforts and conveniences of our Egypt. The question for us will then be, "Do we move on to the building of a better nation under better laws, or do we cry out for the lost pleasures of the past?"

Too often materialism has been denounced in either Marxist or dualistic terms (i.e., as either unjust or unspiritual). The real problem with materialism is that men tend to esteem its comforts more than God. Israel was wholly and Judah partially given over to Baalism, the worship of "lords" or "powers." [the 'powers that be'] These various Baals had the common denominator of being aspects of fertility cults, where God is treated like a Baal whose appeasement assures that His worshippers are given the good life.

When the Hebrews were called out of Egyptian slavery, their apostasy took the form of a mental return to the love of prosperity. Even Jehovah became no more than a minor Baal in their pantheon of lords. They became slaves to prosperity. Today we also become slaves to prosperity. We most often do this by means of the slavery of debt and fiat money. Rather than acknowledge that everything we have was given by God, and showing that by tithing; greed and selfishness has caused people to steal from God (Malachi 3:10), because otherwise (they think) they can't make ends meet. The consequences of this sin are coming home; we have sown the wind, and we are soon to reap the whirlwind.

DARKNESS... AND LIGHT

During World War I, when man's humanistic optimism was shattered, Edward Grey, a British statesman, remarked privately, "The lamps are going out all over Europe. We shall not see them lit again in our time." The expression is the most famous quote of that era and is still used to refer to a pessimistic outlook on current events.

In contrast to such a negative perspective, consider Zechariah 14:7, which says of the day of the Lord, "[A]t evening time it shall be light." This is not referring to a time of day, but to the approach of a time of darkness, a time when pessimism seems appropriate, when the lights seem to be going out. It means when the darkness of events falls, God can give light, a new day, a new hope. God can do more than regenerate men's hearts; He can change the course of history.

There is a myth that postmillennialism is a belief in man's ushering in of the Kingdom of God by his proactive efforts. Rather, postmillennialism is about a faith that God will confound man's sin in His direction of the course of human history so that men, nations, events, and institutions will fulfill His purpose and glorify Jesus Christ. It's about the action of God in history, not of men.

"REJOICING... IN THE DAY OF THE LORD"

The judgment of the day of the Lord is a frightening thing, even to the redeemed, because we know, even though we are spared damnation, we have failed our God in many ways. Nevertheless, Paul speaks of rejoicing in the day of the Lord (II Corinthians 1:14). We cannot follow the prosperity cults of our time and believe in only those aspects of God that appeal to us. We must accept God as He defines Himself. In accepting that God is righteous, just, and powerful, we must then accept His righteousness, His justice, and the exercise of His power, and we must rejoice therein. The justice of God is certain; we either welcome it and rejoice in it, or we resist it, which puts us in peril at its coming!

NEW DEVELOPMENTS IN CLIMATE-CHANGE BATTLES ILLUSTRATE THE DIFFERENCE BETWEEN SCIENCE AND "POST-NORMAL SCIENCE"

As one who, though very widely read in environmental and especially climate science, earned his academic degrees in religion and philosophy, economic ethics, and the history of political thought, I am tremendously grateful to the many scientists who, through their books and articles and in many instances their direct personal communications, have helped me understand the workings of science - and its corruption.

A little over a year ago I wrote an article titled "*Wanted for Premeditated Murder: How Post-Normal Science Stabbed Real Science in the Back on the Way to the Illusion of 'Scientific Consensus' on Global Warming.*"¹ The article explains the difference between real science and "post-normal science" and refers to another article in the subject by

British scientist Kevin McGrane. Understanding that difference is, I believe, one of the most important things for Christians - indeed for everybody - to grasp in today's world, for a great deal of dangerous nonsense now masquerades as science and undeservedly gets the respect real science has earned, and the consequences for mankind are deadly.

Now another scientist friend, John Swayze, a research chemist, having read about the hyper-politicized, misanthropic views of the editors, has written two paragraphs that state that difference between science and "post-normal science" about as clearly, simply, and concisely as anything I've seen:

Traditionally, science worked something like this: "I was curious, asked a question, and had an idea. So I tested that idea through experiment and observation, obtaining some results. Those results caused me to ask more questions, posit

more ideas (including some which contradicted one another), and test them all through further experiment and observation. After examining all the data, I have reached this conclusion which I am sharing with you. Feel free to examine my data and conclusions, have alternate ideas, test yours and mine, and reach your own conclusions, even if they contradict mine. Eventually, a range of ideas and conclusions may coalesce into a coherent whole, which we will regard as true until a countervailing argument is found to be more compelling. I acknowledge that this process may take generations, also knowing that an upstart with new ideas may upset the applecart at any time. That is a good thing."

Unfortunately, the system has been transformed in many ways to be this: "I had an idea. I liked it a lot because it could transform politics and economics, in ways I would like, if people believed it. So, I set out to find only those data which supported it. When I found data which didn't support my idea, I sought other sources which would allow me to reach the conclusion I wanted. By combining some sources of data and information, and ignoring others, I was able to support the conclusion I had already reached. By joining forces with like-minded others and obtaining public support from news media and politicians, I was able to claim 'overwhelming scientific

consensus,' drowning out voices raised in disagreement. As I had become a prophet uttering profound oracular claims, it was both reasonable and necessary to stifle dissenting views. The truth is what I say it is. Anyone who disagrees is, therefore, a liar and a scoundrel. It is reasonable to use both the courts and the court of public opinion to silence heretics.'

Such clear expression put me, once again, in debt to a scientist friend. I couldn't help recognizing its applicability to another development in the warfare between science and "post-normal science;" the filing of lawsuits against Canadian global warming skeptic Dr. Timothy Ball.⁴ I take no position on the legal merits of the case or the veracity of Ball's accusations against global warming alarmists Dr. Andrew Weaver and Dr. Michael Mann, or theirs against him. *Canada Free Press*, which published many of Ball's articles, has removed most from its site and published a retraction of some claims Ball made about Weaver in one of his articles. (Curiously, I can no longer find the apology at *Canada Free Press's* website, and links to it in past articles fail.⁵ But the text of the retraction can be read elsewhere.⁶)

Aside from admitting "one small mistake" (saying Weaver was bowing out of the Inter-governmental Panel on Climate Change), Ball said, "I stand by the story."⁷ (Weaver earlier sued *Canada National Post*; that suit is still pending.) Whatever the merits of the lawsuits, in an interview about the lawsuits, Ball rehearsed what appears to be a plain example of "post-normal science" in action in the climate debate:

People find it hard to believe that the entire world could be so easily misled by so few people. They, particularly Maurice Strong, established control of all government weather agencies by co-opting the World Meteorological Organization. This gave them control of data collection and archives within each nation [and] then its global dissemination. Each national weather agency controlled politicians and funding of research.

They directed funding to one side of the science debate, thus allowing later the circular arguments that claims that most scientists and most publications prove the science. The national agencies also determined who served on the IPCC, thus providing complete control. The group of scientists who controlled the entire process became so small that Professor Wegman was able to name names in his report to the US Congress. As he demonstrated, they controlled the peer-review process, thus allowing them to further control the publication process.⁸

The rise of "post-normal science," with its politicization of science and corruption of scientific process, is part of a larger philosophical corruption sweeping the West in the last fifty years: postmodernism and its literary sidekick, deconstructionism - according to which language conveys not truth but only power. In both the humanities and the sciences, the Western world is in full flight from its Biblical worldview foundations, jettisoning the rationality necessary for scientific endeavor.

That flight is nowhere more clear than in the environmental movement, where Western postmodernism and Eastern mysticism combine into a deadly poison. "Truth is being hijacked by radical environmentalism to smuggle in a whole worldview... It is a religious philosophy which is no longer really secular but has become pagan," says Dr. Vishal Mangalwadi, Indian Christian philosopher and theologian, in his lecture "*Logos vs. Mysticism: Environmentalism's Flight from Reason*," in the recently published *Resisting the Green Dragon* video series.⁹

Fundamental to human nature is the *imago Dei*, the

image of God, and fundamental to that is *logos*, the capacity to reason: "*In the beginning was the Logos*," wrote the Apostle John, "*and the Logos was with God, and the Logos was God: That Logos*", he added, "*is the true light, which enlightens everyone.*" (John 1:1,9).

The flight from, indeed the warfare against, reason in "post-normal science" is in fact the outworking of the rejection of God and His representative on Earth, Mankind, which is His image (Genesis 1:26). It is no wonder, then, that in environmentalism, it goes hand-in-hand with the kind of misanthropy that could lead two editors of the journal *Water, Air, and Soil Pollution* to write, "Currently, one could argue that the most significant form of global pollution is human population growth."¹⁰ Thus they vehemently demand population control to prevent catastrophic, man-made global warming. This is why the environmental movement also poses a challenge to the sanctity of human life, as Dr. Charmaine Yeast argues in her lecture in *Resisting the Green Dragon*.

The need is great to understand and resist these challenges to reason and the Christian faith. * * *

TRUSTING GOD AS FREEDOM FADES

By the end of April 1945, Hitler had lost WWII. Months earlier, communist Alger Hiss had served as President Roosevelt's adviser at the Yalta Conference, where Roosevelt, Churchill and Stalin consigned most of Eastern Europe to Stalin's deadly realm.

As UN Secretary General, Hiss convened the First UN Conference in San Francisco in June, 1945. The UN Charter, co-authored by Hiss, was signed by representatives from fifty nations on June 26. The new global era had begun.

Julian Huxley, the first Director-General of UNESCO, despised Christianity. In his book *UNESCO: Its Purpose and its Philosophy*, this powerful Fabian socialist wrote:

"The task before UNESCO... is to help the **emergence of a single world culture**... This is opportune, since this is the first time in history that the scaffolding and the mechanisms for **world unification** have become available... And it is necessary, for at the moment, **two opposing philosophies of life** confront each other from the West and from the East.

"You may categorize the two philosophies as... individualism verses collectivism... or as capitalism verses communism, or as Christianity verses Marxism. Can these opposites be reconciled, this antithesis be resolved in a higher synthesis? I believe... it must happen... If we are to achieve progress, we must learn to uncrystallize our dogmas." (UNESCO: Its Purpose and its Philosophy, p.64)

Through the rest of the 19th century, most Americans remained loyal to our God and nation. But behind the scenes, the transformation continued. To prepare people to recognize and resist communism back in 1963, the House of Representatives included a long list of Communist Goals in the Appendix of the Congressional Record. Here are just a few. Notice how they match the current changes. Most fit the Islamic agenda as well:

- Get control of the schools. Use them as transmission belts for socialism and propaganda.
- Use student riots to foment public protests...
- Discredit the family as an institution... Encourage promiscuity... and easy divorce.
- Emphasize the need to raise children away from the negative influence of parents...
- Infiltrate the press...
- Break down the cultural standards of morality by promoting pornography and obscenity...
- Infiltrate the churches and replace revealed religion with "social" religion... Discredit the Bible...
- Eliminate prayer or any phase of religious [referring to Christianity] expression in the schools...
- Discredit the Constitution by calling it inadequate, old-fashioned, and out of step with modern needs...
- Support any socialist movement to give centralized control over... education, social agencies... mental health clinics, etc. (Communist Goals, Congressional Record (House of Representatives), Appendix, pp. A34-A35)

Remember, this is *spiritual warfare!* Look around, and you will see countless signs that our treasured heritage of faith and freedom is being replaced by these repressive options: **Global Socialism, Communism, Communitarianism** (a blend of communism and capitalism) and/or Islam. "Watching the markets... two interlocking phrases immediately come to mind: *Ordo ab Chaos*, and *Crisis Equals Opportunity*. *Ordo ab Chaos* is a Latin phrase and the motto of the Thirty-Third Degree of Freemasonry. It means, '**Order out of Chaos**.'" (Carl Teichrib, "The Joseph Principle and Crisis Economics," Quoting Albert G. Mackey, *An Encyclopaedia of Freemasonry*, Volume 2, (Masonic History Company, 1917, p.537)

Whether the chaos ahead will be real or conjured, they may well be used to push the masses toward global tyranny. The planned solidarity will be cleansed of divisive truths from the Bible. Those who refuse to comply will face painful consequences.

Might the spread of Islam be used for similar purposes? A few more wars and revolutions - unencumbered by Christian moral restraints - would help our globalist leaders solve the so-called population crisis.
